PQ Question: To ask the Minister for Health the number of persons on CAMHS waiting lists by community healthcare network and length of wait at the end of quarter 2 of each year from 2023 to 2025, in tabular form. -David Cullinan

Dear Deputy Cullinane,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

Child and Adolescent Mental Health Services (CAMHS) provide specialist mental health services to those aged up to 18 years, who have reached the threshold for a diagnosis of moderate to severe mental disorder.

The table below provides the available information on the number of children and young people waiting to be seen by CAMHS as at end of **Quarter 2 for 2023, 2024 and 2025**. Please be advised that this data is preliminary and subject to change and amendment pending ongoing review and validation. Age range is not captured.
