Re PQ 41060 25: To ask the Minister for Health to provide the total number of grant payments issued by the Department in each of the past five years, along with the total value of those grant payments for each year, in tabular form; and to confirm whether these figures include all schemes and discretionary grant programmes administered directly by the Department or through its agencies.

Please see **Table 1** in **Appendix 1** to this letter which shows the total Revenue & Capital Grants paid by the HSE for the years 2020 to 2024.

Each year the HSE Annual Report and Financial Statements (AFS) Appendix 1, details HSE Revenue and Capital grants to Section 38 & Section 39 agencies, charities and other grant funded organisations. All agencies in receipt of grants greater than €100k are listed by name. This information is available from the HSE website at the following link

The legal basis under which the HSE provides grant funding to agencies is set out in the Health Act 2004. Annually the HSE funds circa 1,820 agencies, ranging from the large voluntary hospitals in receipt of over €600 million to small community-based agencies in receipt of €500. Additional payments, not shown in AFS Appendix 1, may have been made to some agencies related to services provided.

In addition Note 8 to the HSE Annual Financial Statements provides a breakdown of HSE payments for Primary Care and Medical Card Schemes. Please see **Table 2** in **Appendix 1** to this letter for the totals for the years 2020 to 2024.
