The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

PQ 41703/25:

To ask the Minister for Health the number of community nursing home beds specifically available to persons with Alzheimer's disease, per county, per year between the years 2020 to 2025, in tabular form; and if she will make a statement on the matter.

Please see table below which provides details requested re the number of beds which are specifically identified for people who have a dementia like condition based in Community Nursing Units. The time as requested is from year end 2020 to June 2025, based on the National CNU Bed Register

These beds are categorised under both long and short stay beds.

It is important to note that publicly managed and Section 38 CNU residential care services do support residents who may have a diagnosed cognitive impairment inclusive of dementia like conditions such as Alzheimer's disease.
