Re PQ 42662 25: *To ask the Minister for Health whether the HSE has plans to facilitate the payment of accident and emergency department charges in cash at local post offices; and if she will make a statement on the matter.*

Dear Deputy Aird,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. Your PQ above has been referred to me for response.

The HSE can accept payments for statutory charges via contactless payment or by cash at acute hospitals for Emergency Departments(ED) or Local Injury Unit(LIU) presentations.

If a statutory charge is not paid locally at presentation to ED or LIU, HSE Finance Shared Services will issue an invoice to the service user and offer a range of payment options to service users to facilitate the payment of these charges as follows:

Service Users may pay:

- Online at hse.ie/payabill or by scanning the QR code shown below
- Over the phone by card– Freephone HSE 1800 852 445
- By post – send a cheque, bank draft or postal order to: HSE Finance Shared Services, IDA Business Park, Purcellsinch, Dublin Road Kilkenny, R95 XYW2. A cheque or bank draft must be made payable to Health Service Executive. Please write the HSE customer account number and invoice number on the back.
