Dear Deputy Cullinane,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

The details of the capital funding allocated to the Level 4 Hospitals between 2011 and 2024 is captured in the table contained in Appendix 1 enclosed with this letter. Also included is a table listing energy works funding allocated to Level 4 Hospitals between 2019 and 2024 on Appendix 2.

Please note that the funding includes allocations relating to several programmes such as: Major Capital; Minor Capital; Equipment Replacement; Design and Dignity; Remedial Fire Works; Energy; Antimicrobial Resistance (Infection Control) and Medical Gas Upgrade Works. The funding excludes any funding relate to any programme where funding could not be specified as being attributed to Model 4 hospitals and any covid 19 emergency works.
