Dear Deputy Clarke,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Questions, which were submitted to this Department for response.

PQ 31655/25

To ask the Minister for Health the standards those employed in nursing homes have to have in terms of qualifications before being employed; the ongoing training that is provided; and if she will make a statement on the matter.

In HSE Community Nursing Units (CNUs) staff including nursing staff are registered with the relevant professional regulatory body, where applicable, in compliance with legislation. The HSE sets out clear eligibility, qualifications and experience for the employment of Healthcare Assistant Staff. Please see the following link to the HIQA National Standards for Residential Care Settings for Older People (2016). Within this document Theme 7, Standards 7.1 – 7.4 refer to Workforce Standards.

In HSE CNUs all mandatory training is tracked and recorded across units. There is a mandatory suite of training provided to staff which provides employees with the skills and knowledge to care for Older People. Each unit also provides additional training to staff dependent on specific resident requirements. The HSE do offer training opportunities for Nursing Home staff though their IT educational platform HSE Land, i.e. Infection Prevention and Control and also through the IPC Link Practitioner Programme. The Irish Hospice Foundation /HSE and All Ireland Institute of Hospice and Palliative Care collaborative approach in training Nursing Home Care staff in supporting care and compassion at end of life in residential care (CARU).

Nursing Homes are registered as Designated Centre's under the Health Act(s). The Centre's themselves are therefore required to work in accordance with the National Standards of Care (as determined by Regulation) and this obligation rests with the Provider (owner) and the Person in Charge (PIC) under the Regulations.
