Dear Deputy McAuliffe,

Thank you for your Parliamentary Questions referenced above, which have been forwarded to me for direct reply. You have also clarified that you are interested in data for both the Childrens Disability Network Teams and Primary Care data.

The HSE is committed to delivering efficient high-quality services to all eligible service users. In 2024, there were over 1.3 million patients seen by HSE Primary Care Therapy services. Each Health Region is focused on improving access to care in order to reduce waiting times for patients in the context of resources available.



Children requiring interventions including health and therapy services would access services through Primary Care Teams in the Regional Healthcare Areas as well as through Children's Disability Services.

Primary Care Access and Integration has compiled and provided us with the latest available waiting list data, on services for which they collate data, for the end of May 2024 for those aged 0 to 17 years and 11 months.

Please find the attached appendices, which contains, in tabular form, details of the Primary Care Children's Occupational Therapy and Speech and Language Therapy waiting list for each Regional Health Area, as of April 2025 which is the latest data available at this time.

# Children Disability Network Teams (CDNT).

In line with the Progressing Disability Services model, all 93 CDNTs, aligned to 96 Community Healthcare Networks (CHNs) across the country, are in place and are providing services and supports for children aged from birth to 18 years of age.

Each CDNT covers a specific geographical area and holds a waiting list for children with complex needs residing in that area.

The model of service for all CDNTs is family-centred and based on the needs of the child. This includes universal, targeted and specialised supports and interventions, as appropriate to the individual child and family. It is based on the objectives of empowering and supporting parents and others who are with the child on a daily basis to facilitate the child's developmental needs.

The CDNTs are currently providing services and supports for 44,000 children and strategies and supports for urgent cases on the waitlist where staffing resources allow.

### Waiting List for the Childrens Disability Services

Historically the number of children waitlisted for children's disability services provided by section 38 and section 39 providers has not been available nationally. The establishment of CDNTs in 2021 has facilitated the collection of this data. A National Information Management System for all 93 CDNTs is being rolled out and when implemented, will provide current data on waiting lists and other details for all CDNTs.

Pending full roll-out to all 93 CDNTs, manual data collection is currently in place nationally as an interim measure.

The table on the next page is the validated data for the end of May 2025 activity reports. This shows the number of children that are waiting for an initial contact with a CDNT in the 6 Regional Healthcare Areas (RHAs).
