PQ 32426/25 additional query: I note in relation to BowelScreen you have answered "All samples were processed domestically by private services." Could the reply be revised to clarify for CervicalCheck samples processed by Quest Diagnostics, the amount processed domestically or internationally?

Dear Deputy,

I refer to the above Parliamentary Question that follows on from the below response issued to you.

As referenced below, a woman's sample goes to 1 of 2 quality-assured lab providers we work with. Our lab providers are:

- Quest Diagnostics Inc. in the US
- the National Cervical Screening Laboratory in Dublin
- The numbers of samples going to each laboratory are detailed in the table below.

We use a lab provider in the US because there are not enough quality-assured labs available in Ireland to meet our needs. We hold regular meetings with the laboratories to ensure they are operating to the required standard.

- 1. Which of the three cancer screening programmes this query relates to: It relates to all four screening programmes
- 2. Clarification in relation to what samples are within in the scope of the question: Any biological samples taken or used for the purpose of screening
- 3. The timeframe this query relates to: Full year 2024 and year to date 2025

## Dear Deputy,

I refer to the above Parliamentary Question. I note that your query relates to all four screening programmes. Biological samples are not taken for the purposes of screening for our BreastCheck or Diabetic RetinaScreen programmes, therefore the information provided relates to CervicalCheck and BowelScreen only.

## CervicalCheck

CervicalCheck offers free primary HPV cervical screening every three years to women and people with a cervix aged 25 to 29; and every five years to those aged 30 to 65 years. The programme is up to date with invites for cervical screening. Once eligible, it is up to each person to make an appointment with a registered sample taker. Women can check if they are eligible for their free screening test <a href="here">here</a>. The number of people eligible for cervical screening in Ireland is 1.3 million.

The table below shows the number of cervical screening samples processed by our two <u>quality</u> <u>assured labs</u> for 2024 and quarter one of 2025. These samples were taken at either primary care or in colposcopy.

## **BowelScreen**

BowelScreen offers free bowel screening to people aged 59 to 69 every two years. The primary objective of BowelScreen is to reduce people's risk of developing bowel cancer, by detecting and removing pre-cancerous adenomas in the lining of the bowel. If bowel cancer is found early through screening, it's easier to treat and there's a better chance of recovery. Once the person gives their consent to participate, they are sent a faecal immunochemical test (or 'FIT kit') which is a test done at home and returned by post.

The total number of bowel screening samples for 2024 and quarter one of 2025 is shown in the table below. All samples were processed domestically by private services.
