Dear Deputy Sheehan,

The Health Service Executive has been requested to reply directly to you in regard to your parliamentary question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

In order to respond to the queries raised in your Parliamentary Question, it was forwarded to Milford Care Centre, who receive Section 38 funding from the HSE to provide specialist palliative care services on behalf of the HSE Mid West. Milford Care Centre have provided the following information in response to your representation:

Milford Care Centre is located in Limerick and is the sole provider of specialist palliative care services for the Mid-West region, covering Limerick, Clare, and North Tipperary. Milford Care Centre delivers a broad range of services, including in-patient hospice care, specialist community palliative care, day care, outpatient and bereavement support services.

Specialist palliative care service is a medical model and Milford Care Centre is staffed by a dedicated multidisciplinary team comprising specialist palliative care consultants, nurses, social workers, physiotherapists, occupational therapists, pastoral care, and support staff all working collaboratively to ensure high-quality, person-centred care.
