Dear Deputy Dolan,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question which you submitted to the Minister for Health for response.

While we can provide information in relation to HSE Procurement, we would not be in a position to comment regarding other agencies under the Ministers remit.

HSE Procurement facilitates training to procurement staff to improve processes, encourage further study and upskill staff to support service delivery across the health sector. Training currently provided to staff includes the Apprenticeship Programme Supply Chain Management at diploma, degree and masters level (NFQ Level 7 to Level 9). Additionally, HSE Procurement Training supports procurement staff in organising tailored procurement training.
