I refer to your recent correspondence referenced above and outline below the percentage of posts filled in Children’s Disability Network Teams in County Laois as follows:

I have included all staff in Network 11 as this areas covers North Laois/ East Offaly, however, it is not possible to provide a breakdown of staff that are allocated specifically to Laois in this network.

I can confirm that the HSE continues to strive to fill vacant positions, however it is not possible to provide a timeframe for when they will be filled in a permanent capacity as this is dependent on a number of factors including actual panels for a profession being in place, individuals on a panel being interested in taking up a post etc.
