Dear Deputy Gould,

The Health Service Executive (HSE) National Ambulance Service (NAS) has been requested to reply directly to you in the context of the above Parliamentary Questions above, which you submitted to the Minister for Health for response.

# PQ25/10540

Funding for new service development posts in 2025 is part year funding, i.e. €8m, and is expected to take effect from July 2025. Full year effect expected to occur in 2026 (€16m).

Several proposed new service developments remain dependent on progress on several pay related matters, which are currently the subject of a WRC Conciliation process. These matters include the future grading and deployment of current Advanced Paramedics.

A significant number of posts will require appointees to enter either a BS. (Hon) in Paramedic Studies or an MSc. in Specialist Paramedic Practice (Community) programme. It is expected that any new appointees will commence employment and/or training before the end of 2025.

Due to the ongoing WRC related process, there are no plans or educational capacity available in 2025 to commence an MSc in Specialist Paramedic Practice (Advanced).

However, subject to the resolution of the current industrial dispute before the WRC, and the expansion of tertiary educational capacity in 2025, a recruitment campaign is planned to commence in 2025 to select suitable candidates to commence an MSc in Specialist Paramedic Practice (Advanced) in 2026, leading to appointment as Specialist Paramedics on successful completion.
