**Dear Deputy Murphy** 

I refer to your parliamentary questions below which have been forwarded to me for attention. Firstly, please accept my apologies for the delay in issuing a response.

PQ 10655 25 - To ask the Minister for Health if she has read the consultant report relating to operations at Cappagh and Temple Street hospitals (details supplied); and if she will make a statement on the matter.

PQ 10656 25 - To ask the Minister for Health if she is aware of the allegation that monetary gain may be a factor in the number of operations; and if there are plans in place to widen the scope of the review into operations at Cappagh and Temple Street hospitals (details supplied).

PQ 10657 25 - To ask the Minister for Health if, in relation to the report on the consultant report relating to operations at Cappagh and Temple Street hospitals, she is aware of whistleblower concerns that this has been going on much longer than the two-year timeframe of the current review; and whether there are plans in place to look at earlier periods (details supplied).

# Children's Health Ireland (CHI) Response:

Children's Health Ireland (CHI) and the National Orthopaedic Hospital Cappagh (NOHC) confirmed in July 2024 that it would undertake a joint clinical audit to look at a random and anonymised sample of DDH surgeries performed during the 2021-2023 period, after a concern was reported that the threshold criteria being used for surgical intervention in relation to DDH may have been different across CHI sites and NOHC. The audit is being conducted by a UK Paediatric Orthopaedic Consultant with specialist expertise in this area.

The audit is not yet complete, and so we cannot provide any details of its findings, and we cannot comment on any media reports in relation to the audit, as to do so would undermine the integrity of the audit process.

### **About DDH:**

Developmental dysplasia of the hip (DDH) is a condition where the "ball and socket" joint of the hip does not properly form in babies and young children. Babies diagnosed with DDH early in life are usually treated with a fabric splint called a Pavlik harness. Surgery may be needed to correct the issue.
