**PQ Question: To ask the Minister for Health the number of people admitted to acute medical hospitals for treatment for eating disorders in the years 2022 to 2025, in tabular form; and if she will make a statement on the matter. -Marie Sherlock**

Dear Minister Sherlock,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

Most people can and do recover from eating disorders if they receive effective, evidence-based treatment from eating disorder (ED)-trained staff. While a small number of people benefit from more intensive treatment through day programmes or inpatient care, the most effective treatment setting is in the community. The HSE's core focus is on developing regional community-based specialist ED services provided by skilled multidisciplinary teams.

The number of **referrals** (adult and children) to Irish psychiatric units and hospitals (including CAMHS units) with a primary admission diagnosis of eating disorders 2022-2023. We do not have data 2024 or 2025 yet.
