"To ask the Minister for Health the number of vacant occupational therapy posts in Donegal; the length of time these posts have been vacant; the number of posts expected to become vacant within the next year."

Dear Deputy Doherty

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

I have examined the matter, and the following details below outline the figures for the number of vacant Occupational Therapy (OT) posts, length of time these posts have been vacant, and the number of posts expected to become vacant within the next year in Co. Donegal.

The Primary Care and Social Care Occupational Therapy Service provides community-based assessment and intervention to the people of Donegal. The following data pertains to this service as a whole, as the service strives to work in an integrated manner across the care divisions of Primary Care & Social Care (Disability Services and Older Persons Services).
