## Re; PQ ref 11842/25 in relation to HSE submissions on wind farm planning applications since 2021

Dear Deputy O'Donoghue,

I refer to the Parliamentary question referred above to the National Environmental Health Service on 10<sup>th</sup> March 2025.

## Question

To ask the Minister for Health to provide a list of all HSE submissions on wind farm planning applications since 2021, in tabular form, including planning authority case file number, EHO reference number, wind farm name, planning authority, application type e.g., local authority, strategic infrastructure development, appeal, substitute consent, amendments, etc; and if she will make a statement on the matter.

## Response

The HSE has made 29 submissions on wind farm planning applications since 2021 and are outlined in the table below.

Whilst there is a legal requirement for Planning Authorities to consult with the HSE with regard to certain developments, the HSE has no legal duty to respond to any consultation requests made under Planning and Development Legislation and has no role in the decision making around a specific project. Where the HSE consider it appropriate to make a submission in the planning and development process, the role of the HSE is to inform the Planning Authorities around areas of Public and Environmental Health that may assist them in making their decisions.
