" To ask the Minister for Health the number of full-time occupational therapists and physiotherapists currently working at a centre (details supplied); and if she will make a statement on the matter."

Details supplied: Mayfield Health Centre.

Dear Deputy Kenny,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

Primary Care Services are organised on a geographical basis across Ireland with 96 Community Healthcare Networks (CHNs) nationwide. There are 14 CHNs operational across Cork and Kerry. CHN 8, known as North Cork City Central, has a population of 35,729 and comprises of five areas: (i) Blackpool/The Glen; (ii) Carrignavar; (iii) Mayfield; (iv) Montenotte/Tivoli; and (v) St. Patrick's. CHN 8 covers areas to the north side of Cork city.

The following table outlines the budgeted v's the actual whole time equivalent (WTE) in situ in the network:

At present in Community Healthcare Network 8, North Cork City Central, there is 1 WTE occupational therapist employed, and 1 WTE occupational therapist commencing in April 2025 who provide services to the paediatric population. There are 3 WTE occupational therapists working with the adult population.

Efforts are continuing to increase staffing resources where vacancies arise and in this regard, the Senior Leadership Team, as part of the post prioritisation process, are reviewing all vacant posts with a particular focus on services which have long waiting times.

Posts approved for filling will be progressed by way of National HSE panels for Senior and Staff Grade OTs. Where posts were not filled via the National Recruitment Service, local temporary recruitment is underway.
