Dear Deputy Carthy,

The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary questions, which were submitted to this department for response.

**PQ: 9763/25**

*To ask the Minister for Children; Equality; Disability; Integration and Youth the status of the proposal submitted in September 2023 by an organisation (details supplied) which would allow it to alleviate public waiting lists for children's disability services; if a service legal agreement will be put in place for such an arrangement; and if she will make a statement on the matter.*

**PQ: 9765/25**

*To ask the Minister for Children; Equality; Disability; Integration and Youth the funding that has been allocated to an organisation (details supplied) for both capital and current purposes for each of its centres at Kildare, Monaghan, Mayo and west Cork, in the years 2020-2024 inclusive, and allocated for 2025, in tabular form; if there are proposes to allocate further funding to these centres; and if she will make a statement on the matter.*

Details supplied: Sensational Kids

**HSE Response**

Sensational Kids is a not-for-profit organisation delivering interventions to children over the last 10 years. It operates as a child development centre, providing subsidised therapy services for children and professional development training workshops for those working with children with special needs.

Sensational Kids employs approximately 30 staff, including a clinical team across child development centres in Kildare, Mayo, Monaghan and West Cork, providing supports such as occupational therapy, speech & language therapy and play therapy.



In 2023, the Assistant National Director Disability Services met with the CEO of Sensational Kids and discussed what would be involved if Sensational Kids were to become a Section 39 agency.

In September 2023, the HSE confirmed to Sensational Kids at a meeting with the Minister, of its commitment to working with Sensational Kids in supporting children with disabilities to access supports.

Following receipt of an updated proposal from Sensational Kids in September 2023, staff from HSE Disability services and from HSE Estates met with Sensational Kids in October 2023 concerning their proposal regarding a waitlist initiative for intervention and their building proposal for a National Child Development Centre.

HSE Estates provided Sensational kids with the *Capital Projects Manual & Approvals Protocol HBS Estates* with a focus on Section 3 requirements and advised the organisation of the requirement for public tendering on a publicly funded capital project.

The HSE confirmed that a clear funding plan setting out the HSE capital requirement was required in order that the HSE could consider the building proposal for discussion and inclusion on the 2024 Capital Plan proposals. As the clarification was not available at that time, it was not possible to include same in the 2024 Capital Plan.

The Service Improvement Lead, National Children's Disability Services set up another meeting in March 2024 which included personnel from Sensational Kids, HSE National Estates and the Head of Disability Services CHO 7.

The critical requirements for Sensational Kids to complete for a Capital Submission to the HSE were reviewed again.

HSE National Estates raised concerns with Sensational Kids regarding their proposal and recirculated the Capital Manual to Sensational Kids. It was clarified again with Sensational Kids, the steps and documentation that are required for completion of a capital submission.

The concerns are as follows;

-Phase 1: Build - National Estates raised significant concern with Sensational Kids regarding the risk of their plan to sign a contract for €9.6m + €1.9m fees with only €3.6m in hand so far.

-Phase 2: €5m fit out cost is now being sought by Sensational Kids, €4m over the initial €1m due to rising costs since original submission.

To progress matters, following that meeting, it was agreed that the CEO of Sensational Kids would liaise with the Head of Disability Services in CHO 7 with a view towards progressing a Service Arrangement and providing assistance and support for developing a capital submission.

There has been significant engagement with Sensational Kids and HSE disability staff in order to agree the service required by the HSE in line with the CDNT model and the ability of the organisation to provide service with their existing staffing complement.

### **Current position**

With regard to the National Child Development Centre, a meeting was held with Sensational Kids and with Capital and Estates from Dublin Midlands on the 5<sup>th</sup> February 2025. This was to discuss the Capital application process. At this meeting, Sensational Kids were again advised in detail about the capital application process and templates were shared with the organization. The HSE is currently awaiting the submission of a completed application from the organization in order to consider further.

A meeting is planned with Sensational Kids in due course to discuss their local service provision for the Kildare area.

### **Funding**

The organisation has received small grants under the National Lottery Grant Scheme amounting to €4,577 in 2016 and €3,000 in December 2022.



In 2024, Sensational Kids received €241,000 in funding under S39 of the Health Act 2004 via a Service Arrangement with CHO 7 /DSKWW
