## Roadmap for Service Improvement 2023 – 2026, Disability Services for Children and Young People

The HSE's Roadmap for Service Improvement 2023 – 2026, Disability Services for Children and Young People is a targeted Service Improvement Programme to achieve a quality, accessible, equitable and timely service for all children with complex needs as a result of a disability and their families.

The Roadmap includes a robust suite of 60 actions including:

## Action 2.17. Commission and complete an independent review of the CDNT service model in 12 months.

The HSE has commissioned the National Disability Authority (NDA), an independent statutory body providing evidence-informed advice and research to Government on disability policy and practice, to complete the 3-part review as follows:

- 1. Review of CDNT service model in operation
- 2. Determine optimal staffing for CDNTs
- 3. Review of the National Therapy Service in 16 Special Schools Pilot.

The Project Outline has been agreed between the HSE, National Disability Authority, DCEDIY and Minister of State.

The Review commenced in February and will be completed by end of 2025.

Part 1 includes:

- A review of current literature regarding health and social care supports for children with disabilities.

- Consideration of the competencies and skill mix required to inform CDNT composition, in order to optimally support children with complex disabilities and their families.

- Review of the operation of CDNTs in line with the 12 principles of PDS

- Review of current allocation of staff resources to child population per team within a CHO/RHA to be

- An evaluation of the experience of children and families in accessing and waitlisted for CDNT services.



- An evaluation of the experience of service providers and staff providing children's disability services including CDNTs, Primary Care, CAMHS and the Disability Act Office
