Dear Deputy Sherlock,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

To assist in responding to the question raised, the attached data has been provided by the HSE Business Information Unit.

The HSE Business Information Unit (BIU) is a central repository for activity information for Acute and Non Acute Services. The BIU collects, collates and validates extensive amounts of data which is used in performance monitoring and measurement to support the HSE in operational and strategic decisions.

The percentage of Bed Occupancy represents the number of occupied beds used in each hospital represented as a percentage of all available beds during the time period.

The information requested has been provided in the attached Excel file supplied by the Acute BIU, please see the explanatory information on the Excel file and outlined below.

Galway University Hospital are currently undergoing a validation exercise locally of their data in this regard, as a result the full validated data for this site is not yet available.
