PQ 23527/25 – To ask the Minister for Health to confirm if a number of required positions have been filled in Temple Street's spina bifida multidisciplinary team service; and the number that remain vacant, in tabular form (details supplied).

Details Supplied: According to CHI's temple street's own published report* and HSE documents, it has been stated that the Spina Bifida MDT should consist of the following positions: Neurosurgeon, Consultant Urologist, Consultant Orthopaedic Surgeon (lower limbs), Consultant Orthopaedic Surgeon (spinal), Spina Bifida Nurse Specialist, Paediatrician with interest in Neurodisability, Physiotherapist, Occupational Therapist, Medical Social Worker, Dietitian, Speech and Language Therapist, Psychologist, Orthotist, Play Therapist, Neuro-ophthalmologist, Advanced Nurse Practitioner.
