Dear Deputy Sherlock,

I refer to your parliamentary questions, which have been passed to the HSE for response.

Following the 2019 GP Agreement between the Department of Health, HSE and the Irish Medical Organisation, funding was provided to support and maintain GP Services for Communities with a high degree of Social Deprivation. This grant is a financial support for GP practices in socially deprived urban areas with a population of 1,500 or more and may be used for costs incurred in engaging additional medical personnel, additional nursing hours, additional key worker hours, additional counselling hours or additional practice administration hours.

The grant allocation process commenced in 2020, with the first tranche of qualifying GP practices receiving financial supports in Q1 2021. This grant process has continued each year since.

It is envisaged that the current Grant application and mapping process will transition to a data driven model in 2025. This process is currently underway and full details in this regard will be available once finalised.
