"To ask the Minister for Health if she will report on the current staffing levels within CAMHS teams in West Cork and the wider Cork area; and the number of children who have been referred to CAMHS West Cork but who have never been seen; and if she will make a statement on the matter"

Dear Deputy Clarke,

The Health Service Executive have been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted for the Minister for Health for a response. I have examined the matter and the following outlines the position.

Child and Adolescent Mental Health Services (CAMHS) provide mental health services to service users up to the age of 18 years, who have moderate to severe mental disorders that require the input of a multi-disciplinary team.

As of 30/04/2025 there are 91 children on the waiting list who have been referred to CAMHS West Cork.

The service acknowledges the difficulties faced by families waiting for access to CAMHS, we are working on a number of initiatives to improve access to the service across the region, with emphasis placed on ensuring vacant posts are filled as soon as possible.
