Purpose of the TOP Data Governance Group

I trust this clarifies the matter.

Effective monitoring and evaluation of the TOP service is essential for measuring the quality of services, observing trends and as a basis to inform and improve service delivery and quality. NWIHP, in collaboration with the National Perinatal Epidemiological Centre (NPEC), is therefore rolling out a REDCap national data capture solution for hospital based TOP services. This electronic solution will be the mechanism for TOP data collection and analysis and, going forward, will become the source of data for national reporting on TOP services in secondary care.

The TOP Data Governance Group provides oversight and guidance for data use, data quality, data protection across the system and will review and consider TOP data policies, procedures and principles. In addition, the Group supports NWIHP in implementing these policies, procedures and principles, and informing the design of national service audits and reporting. All data will is managed in accordance with all relevant legislation regarding data protection. As with other NPEC audits, no identifying data points is collected.
