"To ask the Minister for Health the number of sites that the MedLis (Medical Laboratory Information System) is to be deployed to; the timeline for deployment in each site; and if she will make a statement on the matter."

Dear Deputy Rice,

Following the success of MedLIS at Beaumont Hospital, it is planned to deploy MedLIS in all HSE funded diagnostic laboratories by 2030. The Order Communication and GP eOrdering elements will be deployed throughout the community and other acute hospital. Deployment of the system will be governed through the Regional Health Areas and will be deployed in multiple sites through a series of waves as outlined below.
