The Health Service Executive has been requested to reply directly to you in the context of the above representation, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The HSE undertakes regular engagement with all voluntary hospitals to review performance in line with available funding and delivery of service obligations. In relation to 2024, no reductions to services were implemented, especially regarding unscheduled care commitments and meeting HSE KPI targets.
