Dear Deputy,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister of Health for response.

Please note, currently HSE is unable to provide actual spend/value of call offs per Framework.

For Mini Competition Frameworks, 'Payment' represents the estimated total spend of contracts awarded under that Framework from 1st Jan 2022 to 9th June 2025, whereas for Direct Drawdown Frameworks, 'Payment' represents the estimated total spend over the lifetime of each Framework.

It should be noted that IFMS, the single national Integrated Financial Management & Procurement System for the entire Health Sector, envisages the functionality to track spend per Framework, Contract, etc.
