*The above figures are recorded on the National TrolleyGAR report for CHI. These breaches are recorded three times per day at 08.00, 14.00 and 20.00. the above figures are the number of breaches, not the number of patients. Please note that the same patient could be counted more than once if they are in the emergency department at the above mentioned times.

CHI does not keep records of individual patients waiting on trolleys, and we are unfortunately unable to identify the number of patients and age groups.

CHI can advise that patients are not placed on trolleys in wards and the above data is only reflective of the Emergency Departments at CHI.
