PQ Question: To ask the Minister for Health the current waiting list figures for ADHD assessments by county; and the reduction targets or timelines being set under Budget 2026.

Dear Deputy Clarke,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The HSE Adult ADHD National Clinical Programme (NCP) was launched by Minister Butler in 2021. Since then, she has funded all 11 catchment area teams over the past 3 years. Seven services are now in place with the service funded late 2024 due to open this November. The three remaining services funded this year are in the process of being established by the NCP's Clinical Lead who is working closely with the relevant Mental health Management Teams involved regionally.

The existing services have all been negatively impacted by very high referral numbers multiples of those anticipated when the NCP's Model of Care (MoC) was designed pre-pandemic. In addition, the HSE recruitment embargo meant this was compounded by staff vacancies not being filled. These vacant existing posts have been gradually filled this year. However, in one Region (Dublin South Central/West) there is a delay in getting approval for 2 vacant posts to be filled a delay of 2 years in filling a nursing post in the Sligo/ Leitrim/ Donegal Service

The table below shows the waiting list numbers and time for each service.

As a consequence of the unprecedented high referral numbers, the NCAGL Mental Heath in conjunction with ADHD Ireland asked the NCP's Clinical Lead and ADHD Ireland's Clinical Lead to consult and design a proposal to better meet the need for assessment of ADHD in adults in Ireland. This Report is under consultation and, if approved, will lead to the development of a Primary Care Hub working in tandem with each existing service. It also identified amendments to the current MoC which would enable existing services to continue to function and specifically accept GP referrals. These amendments are being piloted in the Midlands Service and will also be implemented in the four new services being established.
