PQ Question: To ask the Minister for Health the number of adult ADHD assessments which have been conducted annually from 2020 to date in 2025, by CHO, in tabular form. -Holly Cairns

Dear Deputy Cairns,

The Health Service Executive has been requested to reply directly to you in the context of the ADHD in Adults Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The Adult ADHD National Clinical Programme modified its data set in late 2023 to enable it to collect accurate figures on the number of Adult ADHD assessments completed by each team. Prior to that, patient contacts rather than precise numbers of people accessing the service were collected and this provided no meaningful information.

The total number of people assessed in 2024, Q1 & Q2 2025 and a breakdown by CHO (LHO) are shown in the tables below.

Each team has been adversely impacted by the recruitment pause introduced in the last quarter of 2023. This is reflected in the tables as the clinical capacity of the team. For instance, if there should be four clinicians in a team and one post is vacant, the team then has a clinical capacity of 75%.
