PQ Question: To ask the Minister for Health to provide a breakdown of all mental health allocations made since Budget 2024, including the amount drawn down by the Health Service Executive regions to date and which projects or community services remain unfunded –Ken O'Flynn

Dear Deputy O'Flynn

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The table below outlines the Mental Health budget for 2024 and 2025 per the National Service plan. Development funding outlined below was allocated to Mental Health for 2024 and 2025 which is broken down further in the more detailed initiative breakdown below. The funding allocations for these initiatives are allocated to the Regional Health areas according as these posts are filled. It should be noted that all of these initiatives have progressed for recruitment and are at various stages in the recruitment process.
