To ask the Minister for Health the daily 8am trolley counts for Cork University Hospital for each day of July – September 2025, the number of single- room isolation beds available and occupied each day in the emergency department and admission areas; the number of suspected or confirmed respiratory-virus patients cohort in non-isolation areas; and the actions taken since 1 August 2025 to reduce trolley numbers at Cork University Hospital, with the outcomes referencing HSE trolley GAR and INMO datasets.

Dear Deputy O'Flynn

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

I can confirm that on each day all isolation facilities were occupied and used to support PCHAI

Number of suspected or confirmed respiratory-virus patients cohorted in non-isolation areas - We are unable to track this currently due to a lack of bed level designation on our patient information system and administration deficits. We have achieved funding for the steps required to enable a system called ICNET. We are hopeful that we will have this system rolled out by Q2 2026.

Actions taken since 1 August 2025 to reduce trolley numbers at Cork University Hospital, with the outcomes referencing HSE trolley GAR and INMO datasets are as follows:

- We have commenced a 7 day Acute Medicine model to provide more medical support for acutely unwell patients and increase conversion to discharge from the Acute Floor.
- We are recruiting increased capacity into our F.I.T Team and are waiting for the National agreement on 7 day pay structures for HSCPs to enable more capacity at weekends for the 75+ and increased capacity for conversion to discharge

- We are recruiting additional capacity into our Acute Medicine and Emergency Medicine
   Teams for senior decision making 7 days
- We are working hard to build increased bed capacity within our current infrastructure. We
  are working on an additional 6 beds in a current ward space and on converting a current
  OPD space into in-patient beds to give us more capacity.
- We are working to streamline our process for daily unscheduled and scheduled bed capacity management; important to site that most of our scheduled activity into beds is for Time Critical interventions.
- We are working with our Regional performance and development manager on the Capital development plan for more capacity and our RHA are also working on a model of egress for older persons in Blarney and in Mallow General Hospital


I have attached the trolley GAR numbers and the single-room isolation beds as requested.
