To ask the Minister for Health to set out the amount spent by the HSE in procuring medicines each year, and the amount spent per individual medicines supplier, from 2019 to 2025, in tabular form. -Marie Sherlock

Dear Deputy Sherlock,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question (Reference 48342/25), which you submitted to the Minister for Health for response.

The Primary Care Reimbursement Service (PCRS) is part of the HSE, and is responsible for making payments to healthcare professionals, like GPs, dentists and pharmacists, for the free or reduced costs services they provide to the public. PCRS does not procure medicines from suppliers. It is the community pharmacy contractor who procures a medicine on the Reimbursement List and submits reimbursement claims to PCRS for payment.

The Statistical Analysis of Claims and Payments reports published online give a breakdown of the payments made under the primary care schemes, including the General Medical Services Scheme (GMS), Drugs Payment Scheme (DPS), Long Term Illness Scheme (LTI), Dental Treatment Services Scheme (DTSS) and Community Ophthalmic Services Scheme (COSS). It includes details on the number of eligible persons availing of these schemes. There are also details on the number of pharmacy items dispensed and the number of dental treatments and optical examinations that took place. Included in the reports are the payments to suppliers and manufacturers of High Tech drugs and details of hospital payments in relation to the National Cancer Control Programme, the National Hepatitis C Treatment Programme and Multiple Sclerosis Services.
