Inter-Agency Collaboration:

In view of the need to have inter-agency collaboration between HSE and local authorities, Dept of Housing, etc., and as detailed in the National Housing Strategy for People with Disabilities and the Terms of Reference for the Housing & Disability Steering Groups, I note on page 26 that "HSE does not maintain any records to indicate the number of people they support with a disability that may have applied for social housing". How can a Council plan to meet the housing need of people with a disability without knowledge of and/or update on the status of the Assessment of Independent Living Support Needs and the corresponding funding?

Planning for Future Supported Living Needs for people with disabilities: In answering the previous question submitted to HSE on its planning for future supported living needs for people with disabilities, it was noted that HSE's answer was: "As a result there is a cohort of people with disabilities still living inappropriately at home or in large community group homes that are not a priority for HSE support at this time" (page 26). Based on a review of the NIDD (National Intellectual Disability Database) from the HRB, it is noted that the national capacity of accommodation for people with intellectual disability has reduced over the last 10 years, and at an accelerated pace over more recent years.

Therefore, "at this time" has been ongoing for over a decade. Based on this being contrary to Article 19 of UNCRPD and General Comment No.5, can HSE advise what timescale it?
