# 2. Health Service Executive Updates

HSE Service Executive Updates were circulated and noted by Members which included:

- Minister for Health announces two new appointments to the HSE Board
- HSE and Health Research Board launch EU Web Survey to explore current drug trends in Ireland
- Statement from Deputy Chief Medical Officer, Dr. Ronan Glynn on AstraZeneca COVID-19 Vaccine
- HSE National Renal Office marks World Kidney Day on Thursday 11th March 2021
- HSE announces extended Counselling Supports for those affected by Illegal Birth Registrations
- The HSE launches three-year Corporate Plan
- HSE 2021 National Service Plan published Unprecedented €3.5 bn increase in health service funding
- Minister Feighan welcomes British Irish Council ministerial agreement to cooperate on policy initiatives to reduce the harms of drug and alcohol use
- Minister for Health and Minister for Mental Health and Older People welcome new Visitation Guidance for Nursing Homes

# 3. Presentation on Progressing Disability Services for Children and Young People – National Reform Programme by Ann Bourke

Frankie Keena introduced Ann Bourke to the Forum Members. Ann gave an overview on the background on children's disability services and why the change is needed and the current status and timeline for PDS Implementation, to address the gaps and inequities in access to services. Anne spoke about the lack of clarity for families and referrers on access to services. The objectives of PDS will be based on the child's individual needs, not a diagnosis, working in partnership with families and the best use of resources to help them.

Ann spoke about what is required to implement PDS, the National Access Policy which was developed and agreed between Primary care and disability services and each CHO is responsible for implementing this as well as setting up the Children's Disability Network Teams. Collaborative working between Education & Health, especially when a child is transitioning eg preschool to mainstream school. And also implementing a family centred model, which places the child and family in the centre from day one.

Ann spoke about setting up the 91 Children's Disability Network Teams (CDNT) aligned with the 96 Community Healthcare Networks. Each network will have 1 CDNT for children with complex

needs from birth to 18. Each network will be managed by an agreed Lead Agency. CHO Governance Structures agreed by Chief Officers and Lead Agencies

Ann spoke about how this will move away from the traditional model of 1:1 block therapy and move to supporting and empowering families to work with their child, evidence has shown this is 3 times for effective

Ann finished the presentation by going through the timelines, all Children's Disability Networks will be established by the end of this week and by the end of Q2 all Children's Disability Networks services will have commenced

A discussion took place after the presentation whereby many members raised questions and were answered accordingly. The Chairperson and Councillors thanked Ann Bourke for her informative presentation.

"That the HSE provides confirmation that the disposal of the Crooksling site has been halted as per the direction of the Minister for Health to request a review of the Matter" All the councillors agreed to give their support

Anne O'Shea Chief Officer CHO7 spoke from an estates and services perspective She advised the Forum that she is preparing a briefing note to the minister who has expressed interested in the site and that will be made available in the next day of 2 and is very happy to share this information from a HSE perspective.

It was agreed that a letter on behalf of the members of the forum unanimously give their support for the retention of the Crooksling site under HSE ownership, the members are completely against the sale.
