The NAS operates a singular platform for all call taking and dispatch and utilises a range of models to respond to emergency and urgent calls. The primary NAS receiving facility in the Mid-West is the University Hospital Limerick (UHL) which is the largest hospital in the UHL Group. It is the only hospital in the Midwest that has a full 24/7/365 emergency care and critical care service for those who require more complex medical and surgical care. The hospital has a dedicated coronary centre that treats patients who had serious heart attacks, and a thrombolysis centre provides vital care for acute stroke.

NAS, depending on patient condition, transports patients to the closest most appropriate Emergency Department. Thus, this will be dependent on what location the patient starts their journey from in County Clare. I.e. University Hospital Galway may be closer to North West, Clare.

During times of acute service pressure, we follow our escalation plan, which includes additional ward rounds, identifying patients for discharge or transfer to our Model 2 hospitals and other measures. As a last resort, reductions in scheduled care may also be necessary to decongest the UHL site and improve patient flow.

We have reviewed our escalation plan in review to the significant increase in demand over recent months.

A team from the HSE, UL Hospitals Group and the Mid West Community Healthcare is currently being established to devise and implement specific actions to deal with the challenges in responding to the unprecedented level of demand for services at UHL and the wider region in recent months. This team will examine, among other things, how we optimise existing resources and improve patient flow.

The establishment of this new group follows a review of unscheduled care at UHL carried out by HSE personnel in May and June. The team is similar to teams that have recently supported services in both Cork University Hospital and University Hospital Kerry.

In addition, the CEO of UL Hospitals Group has commissioned Deloitte to conduct an external review of patient flow at University Hospital Limerick. This review is intended to provide an independent and comprehensive overview of patient flow through the ED at UHL while at the same time looking at the use of resources, processes in place and identifying any constraints. Our community and GP colleagues in the MidWest are also being consulted as part of this review and the final report from Deloitte is expected in the coming weeks.

The longstanding efforts of local management and staff, and of the HSE nationally, to alleviate pressure on the ED through adding capacity, resources and providing alternatives also need to be acknowledged.

#### These include:

- Increased activity in our Injury Units with an annual growth in attendances (YTD April 30th) of 68% at Nenagh
  Injury Unit so far this year and 27% at Ennis Injury Unit. In April 2022, Nenagh Injury Unit had its busiest
  month to date and Ennis, its second busiest.
- Attendances at our Medical Assessment Units in Ennis and Nenagh grew by a combined 19% between 2019 and 2021. In the first five months of this year they have seen a further annual increase of 17% combined.
- An increase in staff of 37% across UL Hospitals Group since December 2019.

- An increase in bed capacity at UHL of 98 inpatient beds and 10 critical care beds since the start of the pandemic.
- More patients receiving care than ever before at UHL with an increase of 24% in inpatient discharges between 2019 and 2021 and a further year-on-year increase of 12% in the first quarter of this year.

In addition management and staff have put in place integrated care pathways, hospital avoidance and other initiatives to improve patient flow. These include

- Red2Green an electronic patient flow system is completed twice daily by ward managers and the information
  inputted is available to patient flow, bed management and senior nurse management in order to assist in
  managing patient flow on a daily basis. The focus is on predicted date of discharge, transfers and identifying
  complex discharges early and ensuring discharge plans are in place for all patients. This also ensures there is
  a hospital wide focus on ensuring patient flow from our ED, Acute Medical Unit and Acute Surgical
  Assessment Unit.
- OPTIMEND a new model of delivering ED care to elderly people involving a multidisciplinary team of health
  and social care professionals (e.g. physiotherapy, occupational therapy, speech and language therapy,
  medical social work, clinical pharmacy) has been introduced in UHL. The overall aim of the OPTIMEND team
  is to commence early assessment and intervention of frail older adults within the ED with the view of
  facilitating discharge home. In 2021 the team saw 804 patients with an average discharge rate of 70%.
- There are plans in place to introduce the Pathfinder Programme in Mid-West region. Recruitment campaigns for a Clinical Specialist Physiotherapist, Occupational Therapist, Senior Physiotherapist and Senior Occupational Therapist are ongoing to support the launch of this service. In addition, the National Ambulance Service has identified two Advanced Paramedics to support this programme. Once staff are in place we will be able to indicate when the Pathfinder Programme will launch in the Mid-West region.
- Twice daily teleconferences are chaired by the Unscheduled Care Lead and focus on patient flow in UHL and
  across the entire group. All directorate teams and sites participate and barriers to flow are escalated and
  addressed.
- Weekly discharge teleconference calls are held with Community Healthcare Mid-West to manage and agree plans for patients who are Delayed Transfers of Care, as well as planning for complex cases who are not yet ready for discharge.

We are also working with colleagues in HSE Mid West Community Healthcare on integrated care pathways and hospital avoidance, including initiatives focused on older people living with frailty. These include:

- Integrated Care Programme for Older Persons (ICPOP) is a Community-based specialist service that provides rapid access to a multidisciplinary-delivered comprehensive geriatric assessment (CGA) for older adults living with frailty or at risk of developing frailty. To date this year, ICPOP teams in Clare, Limerick and North Tipperary have received approximately 400 referrals and completed approximately 3,000 assessments and interventions.
- Almost 6,000 radiology tests completed up to the end of April 2022 under the direct GP access Community Diagnostics Programme.
- Community Intervention Teams (CIT) based in Clare, Limerick and North Tipperary focus on hospital avoidance and early supported discharge to the person's home.

Through this continued work on patient flow, hospital avoidance and on discharge planning, UL Hospitals Group, in spite of its capacity challenges, has persistently met national targets for average length of stay for medical and surgical patients; day of surgery admissions etc. We have also performed relatively well on delayed transfers of care.

We are committed to working with the national team on improving patient flow. However no amount of these projects will address the fundamental shortfall in acute bed capacity in the MidWest.

Historical bed capacity shortages in the region have been well documented. ULHG has the lowest inpatient bed capacity when benchmarked per population against other Model 4 Hospitals, an additional 200 inpatient beds would be required to bring ULHG in line with the national average.

Below is a breakdown of how inpatient bed capacity and emergency attendances at UHL compare to other Model 4 hospitals:

We welcome the recent significant investment and bed capacity provided in response to the COVID-19 pandemic, however it does not sufficiently address the well-documented bed capacity shortcomings in the Mid-West region, nor does it adequately address the continuing growth in demand for emergency care.

In 2021, the ED at UHL saw a record 76,473 attendances, an increase of 17% on the previous year. In the first four months of this year, we have seen a further 26,548 ED attendances, an increase of another 20% on the corresponding period for 2021. The number of over 75s attending our ED has risen by an even greater proportion.

Our next significant project in terms of bed capacity is the 96-bed block for UHL which was granted planning permission earlier this year.

Private dental practitioners contracted under the Dental Treatment Services Scheme (DTSS) provide dental services to medical card holders (adults over 16 years of age). Under the scheme, a medical card holder is entitled to a limited range of dental treatment in a calendar year i.e. one dental examination, two fillings, a scale and polish and as many extractions as necessary. There are additional dental treatments available but they require the approval of the Principal Dental Surgeon in the Community Healthcare Organisation (CHO) area prior to the commencement of such treatment (e.g. dentures). The Dental Surgeon can advise the patient of the treatment(s) available to them under the scheme.

I am attaching the list of DTSS dental practitioners who are based in Co. Clare. There are DTSS contracted dental practitioners based in Shannon, Ennis, Sixmilebridge, Scariff, Killaloe/Ballina and Kilrush.

Please note that the name of a DTSS contracted dental practitioner can only be removed from the list of contracted dental practitioners if they advise the DTSS Office in the CHO area in writing that they no longer wish to participate in the scheme or if they are leaving the CHO area. Therefore, there may be contact details on the attached list for dental practitioners who no longer participate in the scheme.

A medical card holder is not confined to attending a practice in their local area and many patients travel from Co. Clare to a dental surgeon/practice in Limerick to receive treatment under the scheme. A medical card holder can attend any DTSS contracted dental surgeon/practice anywhere in the country if they are in a position to take them on as a patient.

The transfer of land at Knockaphunta, Castlebar from HSE to Mayo County Council has taken a lot longer than anyone could have expected or desired mainly due to impact of changes in personnel within both the HSE & Mayo County Council, followed by COVID. At the time of the 'Part 8 process' covering the site at Knocknaphunta there were various iterations of the land transfer maps which have subsequently required clarification/ verification as to what was approved in the Part 8 and what was approved by the HSE property transaction process, also flood risk maps have since become available and been considered in more recent interactions between the parties. The process of reconciling of maps is now substantially complete. Discussions at the time also recognised the need, to jointly service the future requirements of Mayo County Council which at the time of the Part 8, were for playing fields and associated amenity lands with regard to road access, parking and utilities and the HSE requirements albeit different and less defined at that time but none the less needed to cater for known and unknown future healthcare developments on

the adjoining land. Since last year there has been engagement between the parties which has provided a better understanding of matters of concern. In line with the HSE's Property Protocol, HSE will notify the property committee in the coming weeks of minor boundary amendments at Knocknaphunta. The land transfer can then be progressed in parallel with this and the process to outline a phased masterplan, for orderly development of the roads and utilities to serve the lands at Knockaphunta lands.

The Emergency Department (ED) of an acute hospital is seen as the "front door" of the hospital, which specialises in emergency medicine and provides acute care to patients who present without prior appointment. The ED deals with all care that cannot be scheduled in advance due to the acute presentation of some of the condition and the unscheduled presentation of patients.

Where patients have an non-acute chronic condition they should be directed to AMU or OPD services.

Emergency medicine is a medical specialty focusing on the prevention, diagnosis and management of acute and urgent aspects of illness and injury affecting patients of all age groups with a full spectrum of undifferentiated physical and behavioural disorders.

The current status across Community Healthcare West is as follows:-

- 2 respite beds available in Ballina District Hospital.
- Respite is currently available at Dalton Community Nursing Unit and St. Fionnan's Community Nursing Unit.
- 12 respite beds funded by the HSE and available in the Western Alzheimer's Unit in Ballindine.
- HSE have contracted 5 respite beds in Ballyhaunis, Co. Mayo and are available for convalescence care for older people.

Older People's Services (OPS) are currently reviewing beds in the District Hospitals in Mayo with a view to increasing availability of respite in the county.

In addition, the HSE fund Western Alzheimer's Society of Ireland to provide the following services for people with Dementia in Mayo:

- In-home respite and Day Care
- Day services in Castlebar which is open
- "Befriending service" which assists families caring for older people at home. Currently Western Alzheimer's
  have 43 befrienders active across Community Healthcare West and a number are in process of being placed
  with clients to support them and their families at home.
- All of these are forms of respite and support people living at home

Community Healthcare west have an emergency respite protocol in place, to deliver emergency respite either through in-home supports or placement in a nursing home.

The HSE encourage all family carers to apply for the Carer's Support Grant, previously called the Respite Grant, which is €1,850 and can be used to pay for respite care. This grant is not means tested.

It should be noted that the above availability is reflective of the current situation in Community Healthcare West and not on our contracted respite capacity- which is the respite capacity we contract agencies to deliver.

The available respite bed nights available have been reduced this year owing to a number of factors such as accommodating three emergency residential placements in respite settings, Covid 19 and staffing challenges. However, all bed nights available are being maximised right across Community Healthcare West.

There are a number of issues reducing respite capacity in Mayo.

- Emergency residential
- Significant staffing challenges across the sector with recruitment and retention of staff.
- Covid-19 still has an effect on service provision in terms of numbers that can access and staff availability.

Respite in Community Healthcare West is delivered by our non-statutory service providers. This Respite to families and children is delivered in a number of different formats such as centre based respite Home Share/Host Families, Outreach, Day respite, In-home respite supports, community/evening respite and children's holiday camps. We are actively progressing options with our non-statutory service providers to increase capacity across all types of respite supports.

A full design team has been appointed to progress the Emergency Department and Medical Assessment Unit project at Mayo University Hospital. The design team is developing a preliminary scheme design based on the requirements and site constraints. It is anticipated that the preliminary outline design (stage 1) will be available August 2022. Delays have been experienced on this project when the design team were temporarily diverted to progress the scheme for the CT replacement project. A planning permission application is anticipated in due course once the design process has been sufficiently advanced. This project is included in the HSE Capital Plan and sufficient funding is available in 2022 to meet the anticipated cash flow requirements arising. The timeline for commencement of construction is dependent on the time required to complete the design and tender process. The overall project programme is currently being reviewed in parallel with the preliminary design process (stage 1).

This project will require Government approval on the PBC and at two other project milestones prior to any contractor procurement or construction. In addition the project may be subject to an independent review and assurance mechanism as indicated in the Public Spending Code.

Once the PBC is approved, we will move towards the detailed design and tendering process. We will be able to provide a date for the planning application for the new ED and Women & Children's development at UHG once that is complete.

We have received funding as part of the national CAMHS waiting list initiative and we are allocating this to recruit experienced CAMHS professionals (0.4 WTE CAMHS Consultant and a 0.5 WTECAMHS Staff Nurse) and expect them in place by the end of June 2022. We plan to address a substantial element of the existing waiting list over the next 6 months.

Riverview inspected on the 16<sup>th</sup> August 2017. Please note Covid-19 has impacted on this.

Current staffing including current Consultant Psychiatrist input and numbers of residents and day attendees:

- 3 CNM11's, 7 staff nurses, 6 MTAs.
- Weekly Multi-Disciplinary Team meeting led by Consultant Psychiatrist.
- 5 residents and 13 outreach attendees

Complaints were logged on the 11/7/2021, 25/7/2021, 12/8/2021 and 21/8/2021. These were dealt with at local level within 24 hours.

Complaints are dealt with under either Your Service Your Say or through the Clinical Complaints Committee. Where complaints or concerns are identified in relation to a specific service users the standard practice is to review the service user and the relevant risk assessments following any incident or events. These reviews are carried out by either the Non Consultant Hospital Doctor or the consultant and the review includes consideration of the risks for the service user and the community. As the residents of Riverview are not detained persons under the Mental Health Act 2001, their freedoms and rights have to be respected and this can give rise to incidents involving persons in the community over which the service has no control.

We endeavour to address all issues in relation to complaints.

#### **Testicular Cancer**

Testicular cancer is relatively rare, accounting for 1.3% of new cancer cases in men in Ireland, equating to approximately 165 new cases annually. Median age group at diagnosis of testicular cancer is 30-34 years, and >90% of cases occur in men aged <50 years. Testicular cancer is typically diagnosed at early stage disease, and survival rates are very high. Testicular cancer has the best 5-year survival among common invasive cancers in Ireland, at 96%. Testicular cancer is not a common cause of cancer death in men, accounting for an average of seven deaths per annum between the years 2016-2018.

Initiatives undertaken by the HSE National Cancer Control Programme (NCCP) towards improving the early diagnosis of cancer include the development of a suite of resources, including posters, leaflets and factsheets, to raise awareness of the signs and symptoms of cancer and to encourage people to contact their GP immediately if they develop signs or symptoms that could indicate cancer. These resources include a <u>testicular cancer information leaflet</u> to educate men on the signs and symptoms of testicular cancer and how to perform testicular self-examination. This resource is freely available on the NCCP website, and has been approved by the National Adult Literacy Agency (NALA) for Plain English<sup>5</sup>.

#### Healthy lifestyles and early detection of cancer for men and boys

The NCCP have undertaken and continue to support healthy lifestyles and encourage early detection and treatment of disease in men and boys. This includes

- Member of the Men's Health Forum group organising activity for Men's Health week annually

The following resources are available to provide ongoing support to men living with prostate cancer in CHO2/nationally.

#### Prostate Cancer<sup>6</sup>

Prostate cancer is the leading cause of cancer in men<sup>6</sup> (excluding skin cancer). Nearly 3,500 men are diagnosed with prostate cancer in Ireland each year. The cumulative lifetime risk (to age 74) of prostate cancer diagnosis is 12.5% and accounts for 29.2% of all invasive cancers in Ireland. For prostate cancer, there was a marked increase in five-year survival from 66% to 92% between 1994-1998 and 2009-2013.

Community Cancer Support Centres are in most local communities and provide support services for cancer patients, their families and carers. They have a wide range of individual and group programmes and supports available including counselling and psychological support, manual lymphatic drainage, physical activity programmes, survivorship programmes and complementary therapies. The Community Cancer Support Centres have adapted to continue providing their services and programmes remotely during the COVID pandemic. They are currently open and delivering face-to-face services. There are approximately 50 Community Cancer Support Centres throughout Ireland, all of whom provide professionally delivered services to cancer patients and their families free of charge. <u>Survivorship Programmes, including the Cancer Thriving and Surviving (CTS)</u> <u>Programme</u>, help patients with the transition from active treatment to living well with and beyond cancer. The CTS Programme helps and empowers patients as they finish treatment and transition and move into the survivorship period. The programme includes sessions that address the recovery of self-confidence, adjustment to a changed self, and confidence to self-manage cancer-related problems and to promote recovery of well-being and successful transition to survivorship, following a cancer diagnosis. The programme has been adapted to run remotely during the COVID pandemic.

LACES (Life and Cancer- Enhancing Survivorship) is a signposting and information workshop for cancer patients, developed by the NCCP and ICS. It runs weekly in cancer centres and is open to all patients (over 18 years) who have completed their treatment i.e. radiation therapy, surgery, chemotherapy and for advanced cancer patients. The LACES workshop allows patients to access appropriate information and signposting to improve their quality of life after cancer. The focus is on health and well-being, enhancing the use of community supports and survivorship programmes.

NCCP Prostate Cancer Survivorship Self-directed follow-up pilot

The NCCP have commenced the development of a prostate cancer survivorship self-directed follow up pilot, with three locations identified. The provision of an integrated model of care that uses risk stratified follow-up and surveillance, and supported self-management pathways for prostate cancer survivors. This will ensure patients have standardised follow-up and surveillance protocols for routine follow up, access to survivorship programmes and support and rapid re-access to acute services if needed.

#### **Cancer Prevention and Awareness**

Initiatives undertaken by the HSE National Cancer Control Programme (NCCP) towards improving the early diagnosis of cancer include the development of a suite of resources, including posters, leaflets and factsheets, to raise awareness of the signs and symptoms of cancer and to encourage people to contact their GP without delay if they develop signs or symptoms that could indicate cancer. These resources include a <u>testicular cancer information leaflet</u> to educate men on the signs and symptoms of testicular cancer and how to perform testicular self-examination. This resource is freely available on the NCCP website, and has been approved by the National Adult Literacy Agency (NALA) for Plain English<sup>7</sup>.

#### Healthy lifestyles and early detection of cancer for men and boys

The NCCP have undertaken and continue to support healthy lifestyles and encourage early detection and treatment of disease in men and boys. This includes

#### **Cancer Information Resources:**

Provision of resources specific to male cancers including

- o It's never too late to quit smoking male leaflet
- o Being smoke free can reduce your risk of cancer: male cancers
- o Drinking less can reduce your risk of cancer: male cancers
- o Skin cancer prevention resources, with a particular focus on male outdoor workers
- o Know the signs, spot cancer early video (male focus)
- o Early diagnosis of prostate cancer fact sheet
- o Having your prostate checked: what you should know
- The NCCP co-ordinates the Irish Cancer Prevention Network (ICPN) which includes the voluntary sector stakeholders who also play a key role in raising awareness of cancer signs and symptoms. The ICPN work together to deliver cancer risk reduction initiatives. For example, information on testicular cancer is freely available on the Irish Cancer Society and Marie Keating Foundation websites.

In particular to CHO2 a pilot of SunSmart lesson plans was undertaken in 2021 and now is being piloted in other CHO's. This was delivered to boys and girls in the area. A strong relationship with CHO2 Health and Wellbeing and the NCCP is growing with plans for future work in cancer risk reduction and early diagnosis.

The total number of patients who received a new parenteral systemic therapy in April was 37. The guidelines for receiving a new parenteral systemic therapy in the day ward setting is that patients should receive treatment within 15 working days as per National Cancer Key Performance Indicators.

Not all of these patients were seen within the guidelines due to a number of different reasons, some of the patients were not medically fit to commence their treatment, and there were capacity issues within the day services unit. Currently, the facilities department at LUH are working on plans for the reconfiguration of the existing Oncology Day Unit to increase capacity and a Business Case has been submitted to Saolta to extend the working hours of the Haematology/Oncology Day Ward. The NCCP are aware of the capacity issues within the unit at LUH.

The Saolta Executive have strategically identified the requirement for new infrastructure for the Cancer Programme for region in the National Development Plan 2021 – 2030 which includes an Cancer Ambulatory Centre for LUH.

There is an Injury Unit at Roscommon University Hospital, which is open from 8am to 8pm, 365 days per year.

The Injury Unit at Roscommon University Hospital (RUH) opened in July 2011 and offers GP or self —referral services for a range of injuries which are not life threatening and are unlikely to result in serious long term disability. The range of injuries which can be treated in the Unit is based on a standardised list which has been agreed by the National Emergency Medicine Programme. The list of treatable injuries includes suspected broken bones (extremities), sprains and strains, burns, wounds, bites, abscesses and minor chest and head injuries amongst others. The Unit treats adults and children aged 5 years and older, and is open from 8am to 8pm, 365 days a year. Diagnostics including xray, CT and ultrasound are also available 365 years a year for patient attending the Injury Unit. The Unit has established pathways of care for different specialties, as required.

A Registered Advanced Nurse Practitioner (ANP) in Emergency Medicine was first appointed to the Injury Unit in 2016, with a second Registered ANP appointed in 2020, and a third in 2022. In addition, the Unit also has four candidate ANPs currently in training. It is expected that one of the candidates will be registered in September 2022, and the remaining three candidates will be registered at various stages over the next two years.

Attendances to the Injury Unit have increased year on year since it opened back in 2011, and there has been significant increases in attendances in 2021 and 2022 in particular. See table below

In the expanded Emergency Department area in Sligo University Hospital, a dedicated 4 bay Minors area has been created to see these patients present with Minor Injuries. This is supported by Advanced Nurse Practitioners to help streamline patient through the Emergency Department. No plans are in place for the development of a separate Minor Injuries Unit in Sligo.

UL Hospitals Group has three Injury Units—in Ennis, Nenagh and St John's Hospital—where tens of thousands of people over the age of 5 years are treated every year for minor injuries such as sprains, breaks and burns. UL Hospitals Group's Injury Units help to ensure that the Emergency Department at University Hospital Limerick can prioritise emergency care for the sickest and most seriously injured patients who need it most.

For patients over the age of 5 years who suffer sprains, breaks and burns, the Injury Units are the most efficient treatment pathway. The Injury Unit teams can also treat sports injuries, including hand and ankle injuries, and can remove foreign bodies from the eye, ear and nose. Staff also provide quick access to diagnostics and x-rays, make the necessary arrangements to refer patients to specialist care when required, and arrange follow-up appointments within the Injury Unit where necessary.

The Injury Unit teams are composed of emergency medicine physicians, advanced nurse practitioners, nurses, health care assistants and administrative support, working together to provide a high quality and timely service for people with a wide range of non-emergency injuries. Registered Advanced Nurse Practitioners (RANP) and Candidate ANPs play a particularly important role, with their ability to perform full episodes of care on patients from admission to discharge, as well as organising follow-up appointments and ongoing reviews, and referral to expert care when required.

In 2021, a total of 33,853 patients attended all three units. In the same year, attendances at our three Injury Units (Ennis, Nenagh and St John's) increased by 13% on the previous year (2020) and by 2% attendance levels in 2019, the last full year pre-pandemic. Growth in attendances in our Injury Units continues in 2022. Activity at Nenagh Injury Unit has grown by 68% so far this year (YTD April 30th) and 27% at Ennis Injury Unit. In April 2022, Nenagh Injury Unit had its busiest month to date and Ennis, its second busiest

All three Injury Units are open seven days, 365 days a year.

The available bed nights have been reduced to date this year owing to a number of factors such as accommodating emergency residential placements in respite settings, Covid-19, staff shortage challenges across the sector with recruitment and retention of staff, and the level of complexity of need is increasing among children. All bed nights available are being maximised right across CHW.

Accommodating emergency residential placements for children and young people in crisis in respite settings has reduced access to respite for other families.

Community Healthcare West Disability Services is exploring every possible option to resolve the above situation so that the full quantum of respite that families were availing of in these respite settings can be restored.

#### **HSE Mid West Community Healthcare**

There are currently three testing sites across the HSE Mid West Community Healthcare area, namely Ennis, Limerick and Nenagh. In 2021, there was a high turnover of staff working within community testing with fluctuating staffing levels throughout the year. The lowest staffing level was 77 WTE and the highest staffing level was 103 WTE. An average of 96 WTE were employed in community testing in 2021.

There are 101.3 WTE employed in testing in the Mid West Community Healthcare as of the 31st May 2022.

- For the year 2022 to date, 18 staff members are now working or are being processed for alternative roles within the HSE
- For the year 2022 to date, 10 staff members have resigned their posts from testing and have left the HSE
- From the 30<sup>th</sup> of June 7 WTE will return to their substantive posts within the HSE
- From the 30<sup>th</sup> June 59.1WTE number of staff contracts will cease

A range of supports have been offered to the staff affected by these changes.

- Ongoing and regular communications advising of all job opportunities that have arisen throughout the Mid West Community Healthcare area over the last number of months. Weekly e-mails are sent to all team members.
- Information sessions have been held at each community testing centre in relation to job opportunities e.g. with the home support team
- In conjunction with HR, a job preparation workshop was developed and rolled out to all the community testing team. Each team member was given the opportunity to attend.
- Expressions of Interest have been sought from across our Divisions to give members of the Testing the opportunity to work in other areas, i.e. Ukraine project, Operational side of community testing, Dental reception, HR, MTA posts.
- A Plan was implemented across the Testing Centres to give the community swabbers the opportunity to gain further clerical experience.
- Support with job applications and CVs.
- 1-to-1 conversations have been held between community testing team members and senior managers to ascertain their area of work interest with a view to encouraging them to proceed with their career within the HSE and to advise them of future and current opportunities that are available to them.

#### Saolta Group context:

Cancellations have been historically difficult to quantify in a validated and systematic way within the limitations of the existing systems in place.

There are a number of reasons for cancellations including hospital cancellation, patient cancellation, consultant cancellation.

During COVID 19 surges, scheduled hospital activity was severely impacted across all of our sites, with patients not being scheduled in significant numbers.

Since march 2022, the HSE Business Intelligence Unit are now centrally collating hospital specific cancellations. This involves hospital sites doing a weekly manual return of hospital cancelled procedures and appointments so that accurate data around cancellations will be available going forward.

There are multiple measures taken to try and reschedule patients who have not received their appointments.

- 1. Patients are facilitated into the first available appointment slot following their cancellation, often getting priority over long waiting patients.
- In 2022 additional outpatients activity has allowed for 15,825 patients to be removed from the waiting list; the acute clinical prioritization pathway has facilitated 1,385 patients year to date across the group. NTPF outsourcing has facilitated 4,438 patients year to date, insourcing has facilitated 2,113 and intensified

- administrative validation cycles have allowed 7,889 patients to be removed from waiting list (no longer required, seen privately) ensuring all capacity is maximized for patients who actually require it.
- 3. For **inpatient and day cases** patients were removed; 1,421 through NTPF outsourcing, 343 through insourcing, 238 through Safety Net 4 and 872 through intensified administrative cycles.
- 4. For **scope** there was 2,892 patients removed; 1,053 through NTPF outsourcing and 1,839 through insourcing initiatives.

From an outpatient perspective patients who were cancelled during the COVID period were generally booked back into clinic when we were able to start seeing patients again as this would be our normal process, so the majority of cancellations will have since received their appointment. What the various COVID related clinic cancellations and restrictions left us with was a significant backlog of patients, because we had to re-book the cancellations into the next free slots the next patient on the waiting list couldn't get booked in and as a result waiting times are longer. There are various initiatives going on to try and provide additional capacity to get patients seen a bit quicker.

NTPF Outsourcing: The NTPF set up a new outpatient outsourcing programme during 2021 which gave us allowed us to send outpatients out to the private sector for initial assessment, diagnostics and if required treatment. GUH have been sending patients out from a number of specialties including ENT, Orthopaedics, Urology amongst others. To date around 2,250 patients have been outsourced.

Insourcing Initiatives: we have a number of initiatives set up to increase/improve access in a number of specialties for example we have set up additional Plastic Surgery Clinics in Portiuncula University Hospital, we are also in the process of engaging insourcing providers to help us clear the backlog of patients waiting for Breast Triple Assessment and Gastroenterology outpatient appointments. These are just a few examples of a number of initiatives we have set up.

<u>Inpatient/day cases/day treatments</u>: As with the outpatients most of the cancelled patients will have been given a new appointment at the time, however this has pushed the other patients on the waiting list who in normal circumstance would have been seen in the capacity used for the re-bookings. As above there are a number of different things we are doing to improve access.

GUH is also scheduled to start a piece of work looking to increase our current outpatient clinic capacity for two sessions per day to three.

NTPF Outsourcing: The hospital continue to utilise all opportunities to outsource patients to the private sector to help get patients treated a little quicker.

<u>Insourcing Initiatives</u>: GUH also have various initiatives set up in-house to provide more capacity. An example of this would be the recruitment of an insourcing provider to run weekend lists (every fortnight) in Endoscopy.

<u>Safety Net 4 (SN4) and Local Service Level Agreement (SLA)</u>: We have been making good use of SN4 which provides some additional access to the private hospitals to help us deal with some of our longer waiting patients, the key difference between SN4 and normal outsourcing is we can essentially do any procedure where as NTPF work to select group of high volume procedures. The local SLA also provides our surgeons access to theatre lists in the Galway Clinic.

Where possible we are also sending patients to our colleagues in the Level 2 and 3 Hospitals across Saolta, unfortunately the numbers would be low at present as they are also dealing with the impact of cancelled activity during COVID.

The orthopaedic theatres in MPUH opened on Friday 10<sup>th</sup> June and operating at current level of 10 sessions and on a phased basis we hope to increase back up to 16 sessions and then eventually 20 sessions which will assist improving access and waiting times, however this is dependent on staff being recruited which is in progress.

#### **Roscommon University Hospital:**

1128 elective procedures were cancelled in Roscommon University Hospital in 2021. However it should be noted that this includes procedures which were cancelled and re-booked within short periods of time due to operational changes in the Hospital (e.g. to facilitate unplanned or other leave, or changing a Theatre session to a different day of the week).

Where possible, the hospital scheduled additional sessions and implemented insourcing and outsourcing initiatives in order to facilitate patient procedures.

#### Portiuncula University Hospital:

There were 197 hospital initiated cancellations at PUH in 2021. These cancellations were due to bed pressures, increased COVID presentations to the site and the HSE Cyber Attack.

Portiuncula regularly discusses scheduled care activity to mitigate against cancellations and to ensure that any vacant theatre and endoscopy appointments are fully utilised. In addition in the final quarter of 2021 the hospital introduced a weekend endoscopy initiative which is continuing in 2022. All patients are pre-operatively assessed either in-person attendance or via telephone to ensure that they are fit and available for surgery for the designated date and times.

LUH continues to prioritise the scheduling of appointments and/or procedures that were cancelled as a result of the Covid-19 pandemic. The hospital has also submitted and been approved funding from the Scheduled Care Transformation Programme to commence initiative clinics in a number of specialities. In conjunction with this the hospital is also working with:

- The NTPF to offer outsourced appointments to the longest waiting patients for both consultation and procedures, as well as funding to support in-house initiatives in a number of specialities,
- The SafetyNet 4 agreement to access available capacity in private hospitals,
- The Acute Hospitals Initiative 3 funding to access procedures not covered by the NTPF where capacity is available in the private sector and patients

#### Sligo University Hospital:

The total number of patients who had procedures cancelled in 2021 is 94. However, significant numbers of patients were not scheduled due to Covid-19 and the cyber attack.

#### A. Cosgrove, COO, Saolta University Health Care Group

Since March 2020, the COVID-19 pandemic caused significant disruption to health services in the Mid-West and nationally. Scheduled care was reduced in hospitals across the country during surges of the disease, in line with the national pandemic response policy, which aimed to ensure that essential, time-critical care could be provided to those most in need of it.

The ebb and flow of COVID-19 surges have been disruptive and difficult to manage, and we apologise to all who have been affected. We're committed to ensuring that all patients whose appointments have been deferred during the pandemic will be rescheduled as soon as possible.

The 2022 Waiting List Action Plan and HSE National Service Plan 2022 published by the Department of Health both set out new targets on waiting lists, with a focus on the longest waiters.

We are addressing waiting lists through a number of scheduled care initiatives that come under the National Treatment Purchase Fund (NTPF), the Hospital Safety Net Service Agreement, and the Advanced Clinical Prioritisation Programme. Under the Private Hospital Safety Net Service Agreement, UL Hospitals Group has referred urgent surgical and medical cases to private hospitals.

In addition, virtual clinics are being used to identify patients who can be progressed to in-person treatment, whether for diagnostic imaging, minor procedures, or full episodes of care.

The HSE has also established the Scheduled Care Transformation Programme to ensure a sustained, system-wide transformation process that tackles the challenge of scheduled care waiting times, improves access to scheduled care services, and ensures the safe delivery of care.

There are also a number of key drivers which will help improve waiting lists in 2022 including the recruitment of additional:

- Consultants
- NCHDs
- Advanced Nurse Practitioners
- Clinical Nurse Specialists
- Extended Scope Physiotherapists
- Clerical/Admin Staff Grades

While the pandemic was a major factor for procedures being cancelled by the hospital, appointments can also be cancelled for other reasons, including by the patients themselves or their parents/guardians. In total, 8,886 inpatient and day case procedures were cancelled across UL Hospitals Group in 2021.

Of the 8,886 procedures cancelled in 2021, more than 5,100 were cancelled by the hospital or team (reductions in scheduled care in line with escalation policy; pandemic related cancellations; theatre over-runs etc); more than 3,700 were cancelled by the patient or guardian (patient unable to attend or could not be contacted; Covid-19 precautions; patient did not pass pre-operative assessment etc) and a small number of cancellations occurred for reasons beyond the control of the hospital or patient, such as adverse weather and industrial action. Emergency and time-critical services continued to operate at all times throughout the COVID-19 pandemic.

Despite the challenges presented by the COVID-19 pandemic, during 2021, 38,536 inpatient and day-case procedures took place at University Hospital Limerick.

increase in numbers over the summer months what plans are being put in place to deal with the expected annual winter surge.

The construction of the interim (temporary) ED commenced in June 2021 and is programmed to be completed in Q3 2022. This accommodation shall serve as an enabling advanced works project to clear the site for the permanent ED and Women & Children's development. The handover of the Phase 1 temporary Emergency Department is scheduled for handover from the contractor in mid-July 2022 and then commissioning will take approx. 3-4 weeks. Phase 2/Internal area is scheduled for handover in September 2022.

The temporary ED will have more capacity (43) than ED pre-Covid (34). The temporary ED will provide all single closed cubicles & extra Resuscitation bays providing greater dignity and privacy for patients.

GUH has relocated the Cardiothoracic Ward to a new area and plan to open 14 beds in St Nicholas ward for which staff are being recruited.

Restoration of the Acute Medical Unit pathways and the Acute Surgical Assessment pathways to assist with flow and streaming from ED is underway. This streaming ensure that patients receive the right care in the right place.

The Green and Red pathways are being reconfigured and the hospital is also seeking to recruit additional ED Consultants.

GUH has a GP working in ED to support Rapid Assessment. Re-establishing the Rapid Access Nurse Role will result in earlier sign posting/streaming for patients.

The GP Liason Nurse, a recent appointment to the ED, responds to GP alerts. They discuss these patients with triage staff, GP's and the ED medical team.

The Mars (Multidisciplinary Allied Response Team) and FFD (frailty) team are present in ED and ensure early intervention for frailty screening and pathways to minimise Patient Experience Time and also admission avoidance.

In 2022, Galway University Hospital will work with colleagues in National Ambulance Service to introduce Pathfinder, an alternative care pathway.

This new service aims to safely keep vulnerable older people who have phoned 999/112, in their own home rather than transporting them to the ED for assessment. A specific team of staff will be employed to deliver this service including Advanced Paramedics (AP), Occupational Therapists (OT) and Physiotherapists (PT); will include a Rapid Response Vehicle (RRV) and an Electronic Patient Care Record (EPCR).

Saolta is working closely with the community on the enhanced community care programme of work. Under the programme, GPs will be supported by specialist community teams in the management of chronic diseases. One of the key deliverables will be the expansion of community diagnostics to support chronic disease management and GP direct access, thus avoiding hospital referral.

Preparation of the planning submission documents for an ambulance base at the old health centre at Recess are at an advance stage. The intention would be to lodge planning application late July/ early August 2022.

The North Connemara crews' (1 Emergency Ambulance and 1 Rapid Response Vehicle) are currently commencing and ending their shift in Clifden. During their shift, they are then dynamically deployed within the area. E.g. If Carraroe is out they cover or if Clifden is out they cover. If both Clifden and Carraroe are at the station they cover in Ballinrobe deployment point until such times as they are required back in either Clifden or Carraroe. This is a temporary measure until such times that the premises are ready in Recess.

In 2021 Lifford Unit was due to be reregistered for a further 3 year period similar to other units in Donegal, however HIQA had concerns regarding the suitability of the premises to deliver quality care. The Older People Services engaged with HIQA and it was agreed that that no further admissions would take place until upgrading works were complete. These include roof repairs, fire safety upgrading, infection control and extensive refurbishment. From the 6.8.2021 the Unit closed to facilitate these essential works.

Meetings between National Older Persons Service, National Estates and CHO1 took place and it was agreed that a Business Plan for Capital submission would be made for Lifford. A business case for both an 18 bed refurb and a 21 bed refurb were submitted in early 2022, however with further appraisal it was agreed that the most appropriate solution, both locally and national, would be a 25 bed build on a green field site. We are also engaging with other relevant stakeholders to expand the facility to include wider health and social care services. The final updated costed Business Case including the schedule of accommodation is nearing completion and will be submitted to the National Capital & Property Steering Committee for their consideration. As such, the timeframe for the proposed development can only be assured after the proposal has been considered, accepted and ratified

Over the last 10 years HSE -Capital & Estates have carried out a number of projects on St Conals campus which included internal refurbishments (which have seen a number of services in rental properties relocate to St. Conals) an ongoing programme of Fabric Upgrade works to secure the fabric of the buildings by replacing the roof coverings, re-rendering the external facades and window repairs is continuing.

The Design Team for the Fabric Upgrade works have reviewed the entire main buildings and made recommendations on removal of a number of interjections which have been added to the original building over the years.

HSE Regional Counselling Services provide a range of Counselling options across Donegal and Sligo/Leitrim including Bereavement Therapy, CIPC [Counselling in Primary Care], NCS [National Counselling Service] Counselling for Adults with a history of childhood adversity and SHIP [Self Harm Intervention Programme]: a bespoke self-harm intervention counselling service for young adults between the ages of 16 and 25. All services are free and delivered locally in a variety of settings.

With regard to the impacts of the Covid 19 pandemic we recommend the CIPC option which takes referrals directly from GP's and offers up to 9 sessions for adults presenting with mild to moderate issues related to here and now issues including adjustment, depression, anxiety, stress and relationship issues, loss etc.

If more significant issues emerge clients can later be referred on to one of our dedicated service options or an assessment made with Mental Health Services for more specialist treatment and care.

For information regarding referral to CIPC Counselling in your area contact your local GP who will make the referral for you and you will then be contacted by our local staff to arrange the next steps.
