Hypoxic Ischemic Encephalopathy (HIE) is a term used to describe an injury that occurs when the brain does not get enough blood and/or oxygen. In maternity services, a HIE can occur during labour, the birth of a baby or immediately after the baby is born.

Therapeutic hypothermia (TH), also known as therapeutic cooling, is an effective treatment for babies who suffer a moderate to severe HIE event. In the Irish maternity services, when a baby requires TH they are referred to one of four tertiary neonatal centres, where the cooling treatment is provided by skilled neonatologists. The four tertiary units are the Rotunda, National Maternity Hospital, The Coombe Hospital and Cork University Maternity Hospital.

HIE can be mild, moderate or severe. The HSE reports on the number of babies that receive therapeutic cooling, and these figures are included in the annual Irish Maternity Indicator System (https://www.hse.ie/eng/about/who/acute-hospitals-division/woman-infants/national-reports-on-womens-health/irish-maternity-indicator-system-national-report-2023.pdf). The incident rate for the maternity hospitals in the Regional Forum Area West, are set out in the table below. Please note that the most recent data is 2023.

In addition to reporting via the IMIS, all occurrences where a baby requires TH are notified to the Obstetric Event Support Team, which is a unit within the National Women and Infants Health Programme of the HSE. The OEST will visit the hospital where the HIE event occurred, meet with the local team, make a recommendation as to the nature of the review that is required, and extract any learning that can then be shared nationally.

At present the Galway East City & County ICPOP team have their clinical and office space in part of the Aras Mhuire building.

The team is made up of the following:

- Advanced Nurse Practitioner
- Clinical Nurse Specialist x2
- Senior Occupational Therapist

- Senior Physiotherapist
- Senior Dietitian (0.5WTE)
- InterRAI Care needs Facilitator
- Physiotherapy Assistant
- Occupational Therapy Assistant
- Operational Lead
- Assistant Staff Officer

We are currently running clinics here in our hub on Monday/Tuesday/Thursday/Friday's onsite (with the exception of every second Tuesday in Merlin Park/ every second Thursday in Loughrea)

We are also providing cognitive stimulation group classes from our OT/OTA and Postural Stability classes from our PT and PTA (mainly on Wednesday's)

The National Integrated Care Programme for Older Persons' continues to develop end-to-end pathway that describes cohesive primary, secondary and acute care services for older people, with a specific focus on those with more complex needs and frailty. Our region has in operation **ICPOP** Teams & **Frailty at the Front Door** (**FFD**) Teams as part of the ECC Programme.

Under a Sláintecare pilot project, the Galway team was developed to provide Comprehensive Geriatric Assessment and Care for Older People in CHW in a community setting through the implementation of the ICPOP '10 Step Framework'. The multi-disciplinary team will focus on developing integrated pathways for patients with Cognitive Impairment / Falls / Frailty. This initiative has been mainstreamed under the ECC umbrella and is providing great learning and support for the evolving ICPOP teams across the region.

Patient safety is always a priority and every effort is always made to locate a patient. We include family and the Gardai to assist in the location of a patient, where necessary. It is important to also note that our sites are not locked and patients are free to go outside and we advise all patient's to notify staff if they are leaving the ward prior to doing so to prevent unnecessary concern.

This incident has been thoroughly reviewed as part of the internal incident management process within Mayo University Hospital (MUH) and in line with the Incident Management Framework. Patient safety remains a priority focus in MUH and all absconscion incidents are reported and investigated under the Incident Management process.

MUH has a detailed policy to follow when a patient goes missing, in the event that a patient leaves the hospital and does not advise staff of their intent this policy is followed. Where there is an identified risk of a patient being vulnerable of risk absconding there are extra measures put in place to maintain their safety.

If a patient leaves the site and is identified as missing an incident is raised and this then follows the incident management process. Where there is specific learning or changes required from these incidents then these are actioned as quality improvements.

It is important to note that hospital staff have no authority or legal right to prevent an adult patient with capacity from leaving a ward or the hospital. The main exceptions include children and a person detained under the Mental Health Act; patients who have been deemed to lack the mental capacity to act and make decisions in their own right.

In accordance with hospital policy and in line with the HSE Incident Management process, a Preliminary Assessment Review (PAR) of all stillbirths are completed.

Any loss of a baby is a devastating and traumatic event for parents and families. However, at this time, based on available quality and safety information, there is no indication that MUH is an outlier for these occurrences.

In the Irish Maternity system, the perinatal mortality rate is measured as a very important measure of obstetric and neonatal care. Stillbirths account for 66% of all perinatal deaths. The national measurement systems operate at both individual maternity service level and at national level. The rates found are benchmarked against best international practice, with the perinatal deaths included encompassing stillbirths, the loss of a baby during labour and the loss of a baby up to seven days after birth. Based on the data and quality and safety information available, the rate at Mayo University Hospital is within national norms.

Of those stillbirths experienced by woman and their families, most are caused by specific placental anomaly or by a major congenital anomaly. In these specific circumstances, there is often very little that could have been done to avoid these tragic outcomes. Care and management in these circumstances is primarily targeted at supporting the family through their grief and endeavouring to provide women and their families with much needed answers so that they are supported to make decisions about any future pregnancies.

All incidences of stillbirth are monitored and discussed at local level in individual maternity services with engagement and reporting also taking place at regional level through maternity networks and their relevant quality and patient safety structures in terms of overall numbers, specific circumstances of individual cases etc. In some cases of stillbirth, a determination may be made that an external review is needed, and this will be commissioned by the hospital itself.

It is important to note that reviewing adverse outcomes is a standard practice in healthcare. These reviews are commissioned and conducted to facilitate learning and improve the quality of care. The fact that a case is under review does not necessarily imply that there was any deficiency in the care provided.

The quality and safety of our maternity services is of critical importance to the HSE and we want to do all we can to ensure the safety of women and their babies in the antenatal and postnatal period.

Over the last ten years there has been sustained focus and investment in developing our maternity services and making them safer. Since 2016 more than €70million has been invested in maternity services in Ireland. This has enabled us to develop new services, to access new technology and develop better facilities. We have also greatly increased the number of staff working in our maternity services across all staff categories and this includes the appointment of Directors of Midwifery, additional Consultant Obstetricians and quality and safety managers in our 19 maternity units.

In terms of assuring and supporting safety in the services, it is important to note that the performance of maternity services is reported and monitored across a range of metrics which account for multiple aspects of maternity care.

MUH in 2023

There were seven stillbirths in Mayo University Hospital in 2023, five of these occurred in the last three months of the year. Based on the Irish Maternity Indicator System (IMIS) report for 2023, Mayo University Hospital perinatal mortality rate is within the national range.

- The rates for total and adjusted still births in Mayo University Hospital were in line with the National average in 2023
- As per the national incident management framework, all seven underwent local preliminary review.
- Two met the definition for serious reportable incidents (SRE) and full external reviews were commissioned on these cases.
- There were no indications of commonalities in these cases.
- One of these reviews has been completed and shared with the family and the second is underway.

Overall staffing levels within the National Ambulance Service (NAS) have increased by over 400 people since December 2019. Over 400 existing staff are registered with the Pre-Hospital Emergency Care Council (PHECC) as an Advanced Paramedic. However, there is no specific employment grade within the HSE called Advanced Paramedic and a variety of grades of staff may be registered as an Advanced Paramedic. Hence, the HSE, following sanction from the Department of Health, has created a new employment grade, called Specialist Paramedic, to address how staff with MSc. level education, are employed and deployed to meet patient' needs.

Health services in Ireland continue to see a considerable growth in older patients with more 999 patients needing interventions and clinical decisions which are not within the scope of practice of either Paramedics or Advanced Paramedics. In this context, PHECC has developed a Framework for Community Paramedicine in Ireland while NAS has prioritised education capacity on both growing the Paramedic workforce to improve access for patients, and the development of Community Paramedics who have the capacity to treat patients in the community setting and thus avoid an unnecessary ED attendance.

To facilitate the broader implementation of this transformation of urgent and emergency care, the HSE and relevant trade unions are engaging under the auspices of the Workplace Relations Commission (WRC), on a range of matters including how Advanced Paramedics are graded and deployed. The outcome of this work is expected to enable a re-calibration of educational priorities, including the commencement of an MSc. in Specialist Practice (Community) programme in September 2025 and an MSc. in Specialist Practice (Advanced) programme in 2026

In the West/North West Region, planning is conducted on a regional basis, with ongoing efforts to develop additional service improvements for 2026. This year, a key focus is on expanding Community Paramedic services in Galway, Mayo, and Roscommon, as well as further strengthening Intermediate Care services across the region.



The Framework for Safe Nurse Staffing and Skill Mix is an evidence-based approach to determining nurse staffing levels that puts safety and patient needs first, focusing on delivering positive patient outcomes

In relation to the management of surge beds, nurse leadership assign staff based on professional judgement and clinical need.

The determination of correct staffing levels at ward level is influenced by a number of factors including patient needs, nurse staffing and organisational elements. GUH uses a software system called *Trendcare* to measure the care hours required per patient, which also forms part of our safe staffing plan.

Trendcare is an acuity tool that measures nursing hours available with patient acuity and calculates the variance between the two and ensures there is safe staffing, this allows us to review current Whole Time Equivalents on the wards.

During periods of escalation, whereby additional nurses may be required and staffing deficits arise, agency nurses are employed to support the service.

In February 2024, Government approved an enhanced budget of €1.88bn for the National Paediatric Hospital Development Board for the design, build and equipping of the new children's hospital project. The main contractor BAM has committed to a substantial completion date of June 30, 2025. The National Paediatric Hospital Development Board is continuing to engage with BAM to ensure that the new children's hospital reaches substantial completion as soon as possible and to the specifications set out in the Contract.

Once substantial completion is achieved, the hospital will be handed over to CHI for a post-substantial completion operational commissioning period of nine months.

The HSE Home Support Service aims to support older people to remain in their own homes for as long as possible and to support informal carers. The HSE recognises the valuable contribution of carers who care for family members, relatives and friends.

In addition to the care being provided by family, carers, Day Care Centres and the Meals on Wheels Service, the Home Support Service assists clients by providing personal care services as per the Schedule of Care tasks, which are specific to each client's individual assessed clinical needs.

Home Support is provided to a total of 539 service users in County Leitrim. In addition to this, 97 people avail of Meals on Wheels Services with 116 people availing of Social Day Centres funded by the HSE. 62 people avail of sitting services and 20 people avail of overnight services.

With regard to the recruitment of additional health care assistants, please be advised that between January 1st 2024 and February 25th 2025, a total of 21 new HCAs (Home Support) were recruited to the HSE across Sligo Leitrim & West Cavan. Currently, the Home Support Service in Sligo, Leitrim & West Cavan is running a rolling recruitment campaign for HCAs. The Home Support office for the region have met with private providers regarding their recruitment plans and identification of geographical areas being targeted for recruitment to further build capacity.

Also of note, within the business case a greenfield site has been identified as potential development location for a Surgical Hub if this was approved in due course.

Older People's Services:

Home Support Hours from the National Service Plan 2025 target set at 24 million hours nationally of which 4,316,693 hours are for the RHA West and North West.

Response for the West (Galway/Roscommon/Mayo) are as follows:

- Galway and Roscommon have been allocated a budget of €51,894,227 to provide 1.562 million hours.
- Mayo has been allocated €20,990,577 to provide 617,592 hours.
- Nationally the home support target hours has increased from 22 million to 24 million in the full year.

Disability Services:

In 2023 €1.85m has been provided nationally to fund an additional 70370 PA hours which have been allocated based on population.

For 2024 this was increased to €2m nationally to fund an additional 80,000 PA hours.

In respect of CHO2 covering Galway, Mayo and Roscommon this equates to €176,000 funding for 2023 and €189,000 funding for 2024.

This represents a further investment year on year in this service in recent budgets.

Despite increases in investment there are still significant challenges in providing adequate home support packages to all service users.

Outside of budgetary issues, staffing shortages is an ongoing concern in this sector.

NAS Emergency Ambulances are built on a Mercedes Sprinter chassis. In order to maintain the inspection and warranty work these vehicles are repaired at authorised Mercedes dealers. The approved garage in Galway which had been used by NAS is no longer in a position to carry out repairs on our vehicles. As an alternative Mercedes Ireland/MDL are trying to sign a repair contract with another garage in the Galway

In order to keep the fleet in the Galway region mobile a number of actions have taken place:

- a. Mercedes Garages in Sligo, Cork, Offaly and Limerick were asked to repair additional NAS vehicles from the Galway catchment area
- b. A number of resilience EAs were placed into the Mid-West and West regions to allow for additional repair/travel time of vehicles having to travel further for repair.

An escalation policy has been adopted by HSE Mid West acute hospitals to respond to periods of high demand for emergency care.

This allows us to better manage risk associated with variation in demand and/or available resources and to ensure that safe care can continue to be delivered to patients in the ED.

The internal escalation framework for the Emergency Department at UHL flows from and is compatible with the overall escalation framework for HSE Mid West acute hospitals to better ensure our response to periods of high demand. Various triggers are set out in the escalation framework, arising from which staff will follow particular actions. Such triggers include the number of patients present in the Emergency Department at any one time; the number of patients waiting to be seen; the number of admitted patients waiting for a bed; the acuity of the patients; the availability

The framework is very much a dynamic tool and the level of escalation can change over the course of any given day.

Measures taken under our escalation plan include opening surge capacity; transferring patients on trolleys to our inpatient wards; additional ward rounds by medical teams to expedite discharges or identify patients suitable for transfer to Ennis, Nenagh and St John's Hospitals; working closely with our colleagues in the community in order to expedite discharges and regular review of scheduled care.

Background:

Prior to February 2023, the psychology complement on the Nenagh CMHT was one senior clinical psychologist and one staff grade psychologist. The Nenagh staff grade psychology post became vacant in February 2023 and immediately went through a recruitment process and was expressed to national staff grade panels on two separate occasions (Q3 & Q4 2023). The post was not was not accepted by anyone on the panel. This staff grade position has now been approved for filling on February 19th 2025 and is currently in the recruitment process.

In addition a senior clinical psychology post has been accepted and the successful candidate is due to take up their position with a start date of 23 April 2025.

The staff grade psychology post is now going through recruitment.

The senior clinical psychology post has been filled.

Nursing

Background:

The clinical nurse specialist post became vacant in April 2023. Recruitment process was undertaken and I can confirm a candidate took up position on 3rd March 2025. Therefore, there are no nursing vacancies on the Nenagh CMHT. The vacant position has now been filled.

Social Work

This post has become vacant recently and the social work manager is supporting the team.

Occupational Therapy:

Background:

The staff grade occupational therapy post became vacant in 2023. It was advertised for filling on three occasions and no candidate accepted the position. The Mental Health Service took the decision to upgrade the position to a 0.8 senior post to make it more attractive for filling. The post is now going through recruitment and we are confident of filling it as a senior post. We are currently working with HR to progress the filling of the vacancy.

Administration Staff:

Background:

A staff member 0.5 retired in June 2024 and approval for filling was received in December 2024 and filling of this post is going through the recruitment process.

Has this been done?

Significant developments have occurred in HSE Mid West acute services regarding the treatment of endometriosis. These include:

- The appointment of two consultants specialising in endometriosis. These consultants have been enhancing our capacity to manage complex cases.
- Two monthly endometriosis clinics have been established in Ennis and University Hospital Limerick with a specialised physiotherapy service for endometriosis patients ensuring timely access to specialised care.

Recruitment of Specialists:

The recruitment process for a clinical nurse specialist and a psychologist is currently underway, aiming to provide holistic support to patients.

Service Development:

Ongoing efforts are focused on expanding and improving endometriosis services, reflecting a commitment to addressing the needs of those affected.

These initiatives demonstrate a concerted effort to reduce delays in diagnosis and treatment, and ensure that healthcare professionals receive the necessary training and resources to manage all stages of endometriosis effectively.

In relation to the national framework announced by the Minister for Health in 2023, this will set out for the first time a defined clinical care pathway for women with endometriosis. The HSE's National Women and Infants Health Programme has led on the development of this national framework which will be implemented on a phased basis.

The framework identifies how care for women in this area needs to be delivered, with this care spanning primary care to local hospital care to specialist complex care. It is anticipated that this national framework will be finalised and published during the course of 2025.

During 2023, the Minister for Health announced the development of the National Endometriosis Framework, which sets out for the first time a defined clinical care pathway for women with endometriosis. The HSE's National Women and Infants Health Programme has led on the development of this National Framework which will be implemented on a phased basis.

The framework identifies how care for women in this area needs to be delivered, with this care spanning primary care to local hospital care to specialist complex care. It is anticipated that this national framework will be finalised and published during the course of 2025.

Services

The HSE has commenced the establishment of two supra-regional complex endometriosis services in Tallaght University Hospital (TUH) and Cork University Maternity Hospital (CUMH). Once all funded posts are recruited, services in the supra-regional sites will be multidisciplinary, with a focus on a holistic approach to care and with access to specialised surgery as and when clinically indicated.

These supra-regional services are designed to offer specialised care to severe and complex cases of endometriosis, which may incorporate surgery for deeply invasive endometriosis involving the bowel, bladder, ureter or outside of the pelvis. The HSE has estimated that approximately 350 severe cases per year would need treatment through the supra-regional endometriosis services.

The two supra-regional, complex endometriosis services will be supported by a network of five endometriosis hub services located across the country. It is envisaged that each hub will be positioned to provide interdisciplinary care to women experiencing endometriosis up to a moderate stage (women whose symptoms cannot be managed appropriately in primary care or in their local gynaecology service but who do not require the expanse of highly specialist services within the supra-regional services).

Allowing for a holistic care package for women in this area, which the HSE has identified as critical, additional personnel that are being invested in at both supra-regional and regional level include clinical nurse specialists, dietitians, physiotherapists and psychologists. Work to implement the five structured regional hub services has commenced, with further personnel to be recruited into these services this year.

Endometriosis Professional Network & National Information/Guidelines

To support the implementation of the framework, the HSE has established an Endometriosis Professional Network to help drive a standardised approach to endometriosis service delivery and care. Furthermore, the HSE National Clinical Guideline for the Assessment and Management of Endometriosis has now been finalised and is available on the National Women and Infant Health Programme's section of the HSE website. The HSE is also aware that the Irish College of General Practitioners is also currently working on educational documentation for GPs that will promote awareness of endometriosis and support GPs to recognise endometriosis.

HSE Mid West operates under the auspices of the national HSE Pay and Numbers Strategy 2024, where WTE baseline ceilings are founded on the 31st December 2023 position.

The HSE Pay and Numbers Strategy has been approved by the Department of Health and the Department of Public Expenditure and Reform.

Under the strategy, the HSE Mid West Region has been provided with its own specified number of WTEs and can, within that approved number, replace, recruit and prioritise posts. This provides greater flexibility for health regions to respond to the needs of the population and prioritise posts appropriately. Recruitment is ongoing across all staff categories in the HSE Mid West.

It should be noted that acute hospital services within the HSE Mid West have received an uplift in staffing of 145.5 WTE for new service developments since January 2024.

The below table sets out the current level of vacancies in the main staff categories across acute services within the HSE Mid West. Note positive values in the variance column denote staff categories where the numbers in post are above the current funded ceiling. Negative values denote vacancies.

Similar to any organisation, a significant part of vacancies which arise are due to shorter term leave types such as sick leave, maternity leave etc. and also in the form of natural attrition such as resignation and retirement. Presently, the labour market is very competitive particularly in the area of skilled medical personnel. This challenge is not unique to the HSE but rather is being felt on an international scale.

Total staffing numbers have increased significantly across our services in recent years. Employment reports <u>published</u> <u>on the HSE website</u> show overall staffing numbers increased by 34% within the HSE Mid West between December 2019 and December 2024.

During 2024, 6,062 patients left the Emergency Department at University Hospital Limerick before completing their treatment.

This represents a slight decrease on the 6,144 such patients in this category in 2023 and a significant decrease of 40% since 2022.

The most recent available data shows that in the year 2025 to date, 6.9% of patients in UHL left ED before completion of care, compared to a national average of 6.1% and ahead of six of the eight major regional hospitals (range 7.3% - 14.1%).

Improving the patient experience at our Emergency Department is a priority for HSE Mid West. Emergency Departments (EDs) and their associated hospitals must clinically prioritise those who must be treated first, and those who may need to wait, or those who may need to attend a more appropriate care setting.

To ensure this process is clinically safe for patients, Irish hospitals use the internationally tested Manchester Triage Tool which prioritises patients into a number of categories based on their clinical needs. Where a patient is seriously ill or injured, their needs will be prioritised above those with less serious conditions. Ideally, hospitals would be in a position to treat patients on their arrival. However, as demand inevitably overtakes capacity, prioritisation and consequential waiting may occur. In this regard, some patients with less serious needs may choose to avail of alternative options.

This is not to minimise the frustration of the many patients who face long waits to see a doctor. We are committed to reducing patient experience times (PET) for admitted and non-admitted patients, and continue to promote alternative options to ED where this is appropriate.

The total attendances at the Emergency Department for 2024 were 81,027. Of this overall figure, 3,400 are recorded as 'Did not Wait to be Seen'.

The GP Liaison Nurse in the Emergency Department follows up all patients who did not wait for the ED Doctor assessment.


- This nurse will follow up all GP referrals regardless of their triage category. They email or phone the GP Practice to inform them that the patient did not wait and of any investigations that were undertaken. If the results were abnormal, they can email a copy of any results.
- The Nurse then follows up all the Triage category 1, 2 and 3 patients who self-refer and depending on their presentation, will decide if they need to contact the patient, contact their GP or inform any other services i.e. Psych Liaison, COPE/ Simon community, PHN etc.
- The GP Liaison Nurse also attends the Psychiatry Liaison ED huddle every morning where they discuss with the Psychiatry Liaison team, any psychiatric patients who have left without being seen from the ED the 24hrs previously.

There is a Standard Operating Procedure in place.

The HSE is aware of the difficulty with accessing Dental Services for medical card patients under the DTSS Scheme (Dental Treatment Services Scheme) and is actively trying to find solutions for this problem.

The HSE endeavours to keep the list of private dentists as up to date as practically possible.

Dental Treatment Services Scheme

Aware that the Consultant CAMHS ID position for Sligo was approved by the Consultant Applications Advisory Committee on the 14th of May 2024; and aware that the post was advertised by the Public Appointments Service on the 18th of June 2024 without applications being received; and aware that the Service sent a request to the agency framework to explore whether a suitable consultant could be recruited pending ongoing recruitment efforts; and further aware that the post was filled by an Agency CAMHS ID consultant who commenced in the service on the 19th of November 2024, and resigned from the service on the 26th of November when he discovered there was no multidisciplinary team in place to operate the service; can the Forum be advised as to why efforts were made to have the Consultant CAMHS ID position approved when the HSE management was aware that there was no multidisciplinary team in place to provide the clinical service alongside the

The National Model of Care for CAMHS-ID outlines the roles of MDT members trained in supporting children with intellectual disabilities and mental disorders. The team includes a Consultant Psychiatrist, health and social care professionals, medical and nursing staff, and administrative support. While not all teams will start with full membership, the national CAMHS ID programme aims to establish baseline teams in all areas, including a Consultant Psychiatrist, Senior Psychologist, Clinical Nurse Specialist, and administrative support.

In SLMHS, approvals for the recruitment of other MDT members are progressing through internal HSE processes, in addition to efforts to progress appointment of the team's Consultant Psychiatrist. This MDT would form the makeup of the CAMHS Intellectual Disability team.

As the CAMHS ID MDT is established and becomes operational in Sligo/Leitrim Mental Health Services, the Consultant Psychiatrist will support joint CAMHS ID and CDNT therapy for children with complex disabilities, based on their assessed needs.

Primary Care Occupational Therapy Adult Services

Primary Care Occupational Therapy (OT) Adult Services currently operates with a staff allocation of 7.94 Whole Time Equivalent (WTE) OTs. However, this number was temporarily reduced to 6.94 WTE between November 2023 and January 2025.

All adult referrals received by the Service, classified as Priority 1, are assessed within five working days.

Waiting times for all other categories are dependent on location and the number of Priority 1 referrals, being processed at any given time. The average waiting time for patients in non-Priority 1 categories is approximately four months.

To address these waiting times, the Primary Care OT Clinical Manager and the Community Healthcare Network Manager recently completed a service redesign aimed at reducing waiting times across all adult categories.

For adult service we have seen an increase in both referrals and attendances in last 6 months As a snap shot of adult service (Adult services OT returned from Mat leave in Jan 2025): In Aug 2024 Adults had 110 referrals and had 1 to 1 interventions for 106 adults.

In Jan 2025 Adults had 124 referrals and had 1 to 1 interventions for 157 adults

Paediatric Primary Care Occupational Therapy Services

The Paediatric Primary Care OT Services currently has a staff allocation, of 3.33 WTE, which is temporarily reduced to 1.5 WTE.

This reduction in WTE began in Q4 2024 and will extend until the beginning of November 2025.

All paediatric referrals are assessed on a priority basis. Currently, the waiting time to access Paediatric OT Services is between twelve and eighteen months.

In response to these extended waiting times the Primary Care OT Clinical Manager has introduced a telephone advice line for parents of children on the waiting list.

For paediatric service we have seen a reduction in attendances due to 2 x vacant posts:

In Aug 2024 Paeds OT had 1 to 1 interventions for 51 children.

In Jan 2025 Paeds OT had 1 to 1 interventions for 26 children.

The telephone advice clinics do not replace 1-1 interventions but are in place as a support for parents while they await appointments for their children.

Primary Care OT Services remain fully dedicated to comprehensively meeting the needs of all eligible adult and paediatric patients and regrets any delays caused because of reduced staffing levels.

However, it is important to note that the service must be delivered within the resource allocation and funding available, with the level of activity and associated costs being managed in a way that ensures people with the greatest need are supported within the overall expenditure of the delivery of services while not exceeding the available funding allocated.

The project is currently at Detailed Design after which the Bill of Quantities will be developed. At the end of this stage, approval must then be sought to issue tender documents to the market. It is expected that Detailed Design and Cost verification would be completed Q3 2025. Once approval to proceed to tender is received, the tender process will follow, currently scheduled to commence Q4 2025.

Tree felling was carried out in February 2025 and an enabling works package is planned to be progressed during summer/ autumn 2025. An enabling works package is required to carry out the installation and alterations of site utility services and segregation of access routes for the operational Service and the Contractor prior to the main construction contract commencing. The phased enabling works are designed to minimise disruption to the existing operational Community Nursing Unit, whose Services will be maintained at St Anne's over the duration of the works.

There are currently 73 spaces dedicated parking spaces (including 6 disability spaces) outside of the new Outpatients building in Merlin Park University Hospital. There is pay and display parking to ensure parking is available for patient use.

GUH are working off a mobility management plan for the site. As part of this plan, we did link with Bus Eireann and notified them of the route change on the site (one way system) being introduced. We are served on the site by the 402 which runs on a frequent basis into the city and on to UHG and serves across the city as far as Knocknacarra. This bus runs every 30 minutes from 6.30 a.m. to 11 p.m.

We also provide a Hospital Shuttle Bus service which crosses the city every 20 minutes at peak times and every 30 minutes thereafter from UHG to MPUH and patients can avail of this service from 7 a.m. to 9 p.m. Monday to Friday. This is outlined on the Outpatient Appointment letters which are sent to all patients.

We are aware that there are city connect plans underway and as part of this we are informed that a link with Oranmore /train station will be provided.

There are 39 additional parking spaces which will be provided in the near future on the site as part of the Surgical Hub project. Further proposals are being considered for the site.

From the outset, Primary Care Services have acknowledged and understood the distress that the lack of power caused particularly to those most vulnerable in our society.

In advance of Storm Éowyn, HSE services had already considered the possible impacts on vulnerable clients and in so far as possible made alternative arrangements for their care.

Our Galway and Mayo Primary Care Occupational Therapy Department have a register of Hoist and Powered Wheelchair users as per the Pre Planned Maintenance Contract with Healthcare 21.

Galway, Mayo and Roscommon Public Health Nursing Department (PHN) has access to a register of local client's with electrical equipment. Galway Primary Care PHN collated a list of Service Users in advance of the onslaught of the storm who were in possession of Air Mattresses.

This list enabled the PHN Team to target those Service Users specifically and swap mattresses requiring power for alternative Foam Mattresses. The HSE Oxygen supplier was also involved in providing support to service users on oxygen therapy.

It was agreed at the After Action Review meeting post Storm Éowyn that a Register of High Risk Service Users with life-critical equipment would be developed that could then be cross referenced with Multi-Disciplinary Team.

The After Action Review determined that Information Leaflets/Escalation Plans will be developed for families and Service Users. These will cover equipment usage, preventative charging, battery life, alternatives for prolonged outages, priority life-critical equipment, and charging hub locations. Additionally, pre-text messages with advice for high-risk Service Users during a Red Warning are under consideration.

A Business Case is being developed for the purchase of generators for areas such as the Islands, Vaccine Centres located in Shantalla Newcastle Road Galway, Roscommon Primary Care Centre and Castlebar Primary Care Centre and rural isolated zones and there is also a plan to establish a network of wheelchair accessible charging hubs for life-critical equipment.

Mobile Medical Diagnostics have worked locally with the HSE Older People Services Team to ensure all GPs and Nursing Homes are aware of the mobile x-ray service. Since the service commenced in December 2023, we have visited 46 patients in nursing homes / CNU's (Carna, Aras Chois Fharraige, Aras Mhic Dara, Clifden/St Annes Nursing Unit). We also responded to 19 housebound referrals from GPs.

The unique nature of the service means we are mobile and responding to calls in all areas across Galway, Mayo and Roscommon. 91% of all urgent x-rays referred to us are performed within our service level agreement KPIs and our Consultant Radiologist reports are returned to the referrer within 4 hours of image acquisition on 97% of cases. The service unit covering Connemara spans across Mayo, Roscommon and Galway. We respond to all calls on a clinical urgency basis and if in the unlikely event that we cannot respond in a timely manner we communicate directly to the GP and Nursing Home or NOK where necessary.

Mobile Medical Diagnostics are a service provider on behalf of the HSE. They have advised that should they be requested to expand the service to serve the general community they are open to discussing this with the HSE, however, it would need to be in a fixed setting due to regulatory restrictions on mobile x-rays.

University Hospital Limerick became a Dose Adjustment For Normal Eating (DAFNE) accredited centre in 2023.

This education programme gives patients with diabetes the necessary skills around insulin administration.

The aim of the course is to improve health outcomes for type 1 diabetes patients by providing well-structured information and guidance.

Please see below details of training provided to staff:

- DAFNE educator training was provided to diabetes dietitians.
- DAFNE revalidation course undertaken by one dietitian in 2024.
- There has been DAFNE educator attendance at DAFNE network meetings and webinars throughout the year.
- One administration staff member completed DAFNE training in November 2023.
- There are currently three certified DAFNE trainers in UHL.

A number of UHL doctors have also trained in DAFNE. We also have doctors on the specialist register in endocrinology and diabetes mellitus, with experience in insulin pump management.

In 2023, dietitians attended a two-day course on insulin pump therapy delivered by Leicester Diabetes Team.

We are at present unable to give a precise timeline for the commencement of pump initiation for adults within our service. This is due to a significant increase in activity in the existing diabetes and endocrinology services. Additional staffing and

resources particularly in dietetics will be required to commence this service, this will be partially addressed with the imminent recruitment of a further consultant in Endocrinology

We do, however, accept patients established on pumps from elsewhere and these patients are managed under the care of a consultant endocrinologist. The largest group of these patients are those who have transferred from the paediatric diabetes service in UHL. All of our insulin pump patients are seen in University Hospital Limerick.

HSE Mid West recognises the need for additional resources within our adult diabetic services.

This issue is a core focus for HSE Mid West and we are committed to improving this service for our patients. Developing services around insulin pump therapy in particular requires us to fill further specialist posts, including nursing and dietitian posts.

I can confirm that education on the risks associated with vaping/e-cigarette is addressed in secondary schools in the Junior Cycle Social Personal and Health Education (SPHE) resources developed by the HSE Tobacco Free Ireland (TFI) / National Health & Wellbeing Service.

The HSE collaborates with the Curriculum Development Unit, Department of Education and Skills in relation to health-related subject matter and lesson plans are delivered by class based teachers as stipulated by the Department of Education. Evidence/research supports this class based approach.

In May 2023, the Department of Education and Skills invited the HSE's Tobacco Free Ireland (TFI) Programme to write to all primary and secondary schools to update them on the potential harms of e-cigarette use in children and young people, advocating that they consider and develop policies to address this area. A key component of this work included the review of resources to support schools, parents, guardians and teachers. A range of updated and new resources for schools was made available – see link- e-cigarette resources. The inclusion of e-cigarettes in substance misuse policies and procedures is also an important step which many schools have taken to protect children and young people from the significant harms associated with vaping. The HSE also encourages parents and guardians to discuss vaping with their children.

In Donegal, Sligo, Leitrim, South Donegal and West Cavan, the HSE has circulated the vaping prevention resources to schools and requested they make parents aware of materials available online to support them in discussing vaping with their children. We have also uploaded these resources on the Parenting Platform which is an online support for parents in the North West - parenting platform

In response to one of the recommendations from 'What's the Panic about Vaping' Report (2023) in Sligo/Leitrim and concerns that vaping is an increasingly prevalent issue among young people in the area, a short film was commissioned by Foróige, in partnership with the North West Regional Drug and Alcohol Task Force (NWRDATF) and Mayo, Sligo and Leitrim ETB (MSLETB) has been developed. At a recent screening in March 2025, 800 students from primary and secondary schools in Sligo got the opportunity to see the film and there are plans for a similar screening in Co. Leitrim. The film will also be available shortly for wider distribution.

A 'QUIT4Youth' Resource was also circulated to all Youth Services to support them in their response to the needs of young people who smoke and use E-cigarettes.

Furthermore, funding has been allocated to develop a national media awareness prevention campaign on vaping and young people. Work has commenced on scoping same and I expect this will be launched later this year/early 2026.

In the meantime, the HSE will continue to work with parents and guardians, schools, the Department of Education and Skills, Department of Health and all stakeholders to ensure we protect children and young people from the harms of smoking and e-cigarettes.

Due to the geographical spread of Co. Donegal, most centres operate both children and adult respite services on an alternate week basis. There is no dedicated children's respite centre in the county currently.

There are four centres in Donegal that are registered with The Health Information and Quality Authority (HIQA) to provide respite services for children and adults with disabilities on alternate weeks. The four centres are as follows:

- Drumboe Respite House, Stranorlar
- Riverwalk Respite House, Carndonagh
- Ballymacool Respite House, Letterkenny
- Seaview Respite House, Mountcharles

<u>Ballymacool Respite House, Letterkenny</u> - Ballymacool Respite House offers respite services to 104 children per annum on alternate weeks six nights per week, operating alternate weeks for adults and children.

<u>Seaview Respite House, Mountcharles</u> - Rehab Care Seaview Respite House provides respite services to 50 children on seven nights per week, operating alternate weeks for adults and children.

In addition, alternative respite supports such as direct payments and intensive support packages have been offered to service users and their families whist the availability of respite is reduced

<u>Riverwalk Respite House, Carndonagh</u> - Donegal Disability Services are planning to reopen respite services at Riverwalk Respite House four days per week from 3rd April 2025. Riverwalk Respite House has three beds which will operate on alternate weeks for 3 adults and 3 children.

Ballymacool Respite

Approval has been received to extend respite services at Ballymacool 7nights per week. Recruitment has been successful and the additional staff required to operate the service safely are going through pre-employment clearances with the HSE. Once complete Ballymacool will operate 7 nights per week for adults and children on alternate weeks.

The following outlines the status of the outstanding staff positions at Riverwalk Respite House that are required to be filled:

- Healthcare Assistants (HCAs): Two HCA candidates are undergoing pre-employment clearance, while another has been cleared to begin work.
- Staff Nurse: No interest has been expressed in the vacant staff nurse position in Riverwalk Respite House from the existing staff nurse panel. As a result, HSE Human Resources are extending the search to additional staff nurse panels in Donegal, Sligo, Leitrim, Cavan, and Monaghan Community Services.

Once these positions are filled, Donegal Disability Services plan to expand respite service provision in Riverwalk Respite House to seven days per week. In the meantime, the HSE workforce in Riverwalk Respite House will be supplemented by agency staff and bank staff to ensure safe staffing levels are in place to resume respite services.

<u>Drumboe Respite House</u> - Due to the urgent need to provide emergency residential placements for four individuals with disabilities, respite services at Drumboe Respite House are currently suspended. Donegal Disability Services are actively working to secure alternative accommodations for these individuals. In the meantime, service users are being supported with home care packages and are being offered alternative centre-based respite services at Ballymacool Respite House. Drumboe Respite House has five beds which will operate on alternate weeks for 5 adults and 5 children when respite services resume.

The HSE Alcohol & Substance Misuse Service provides a range of therapeutic interventions to people and their significant others, including counselling, therapeutic day programmes, relapse prevention, aftercare and onward referral for detoxification, stabilisation and rehabilitation. The service works closely with prescribers for community detox and facilitates detox admission on need. The services delivered directly by the HSE across community locations in Co. Donegal are listed below in **Table 1**.

It is important to note that the majority of residential treatment services funded by the HSE are available nationally, i.e. a person does not have to live in a particular area to avail of a treatment. These residential and detoxification services are listed by county location in **Table 2**.

The HSE also provides funding to community and voluntary sectors to deliver addiction services across the North West region. The services commissioned by the HSE include education; prevention and treatment to people who use drugs and alcohol in a harmful way; and family support programmes for people whose lives are affect by another person's alcohol or substance misuse. A list of the HSE-funded services can be found below in **Table 3.**

The HSE Community Addiction Service does not routinely collect data on the number of people waiting to access addiction services. The service does, however, collect the waiting times to access treatment nationally through performance indicators across all addiction treatment services. The average wait time for an appointment with the HSE service in Donegal is 1 - 3 weeks, depending on the preferred location of the service user. The recent introduction of the individual health identifier will make reporting on data easier going forward.

Donegal Mental Health Services (DMHS) have identified the need to transition Radharc na Sleibhte from a residential model to a recovery-focused crisis intervention/set down facility. A feasibility study was undertaken by HSE Estates to incorporate a 10-bed crisis/step-down and respite facility supported with 24-hour staff cover. This phase was completed in December 2024.

A seven-day outreach service will support those who require it to remain in their own home and integrate with their local community. This is a recovery-based model promoting independence, hope, and choice for all and will be a further development of initiatives such as the wellness café that have been developed over the last few years. We now plan to use part of the building to provide this service.

Included in the plan is a Day Hospital service for more acute short-term service users, which will reduce the number of admissions to the Department of Psychiatry. This will support a number of service users with acute conditions to receive appropriate interventions while continuing to live in their own home. Provision will also be made for the current long term residents.

The design team has completed and presented the initial drawings including floor plans for the:

- Outpatients Department, talking therapies, OT kitchen (all a shared space)
- Upstairs (1st floor) is a 10 bedded en-suite facility for service users
- A further section downstairs is for a therapeutic space for our 10 service users including a dining facility.

Meetings were held on Friday the 8th of November 2024 and 23rd January 2025 to update all relevant stakeholders including service user representatives, families, and elected representatives.

The timeline for this project is eighteen months from date of commencement. The start date will depend on the confirmation of the funding.

Mental Health Services submitted a proposal nationally last year after receiving approval from Senior Management in Community HealthCare West for a new Acute Adult Mental Health Unit in Roscommon. Following a review of national priorities for acute units, it was agreed that we should reassess our number of bed requirements, considering future

planning and population growth in Roscommon and the surrounding area. A MDT Subgroup has been established under the leadership of the Head of Service, with contributions from both Acute/Community Services and Estates, to develop a detailed plan for a new 50-bedded unit in Roscommon. Work is currently underway to complete all necessary documentation, and we anticipate that our finalised business case/project brief will be ready for submission to national estates for approval by the end of Quarter 2 in 2025.

When service users present to Emergency Departments with suicidal ideation, a mental health assessment is conducted to assess the severity of the crisis and establish a plan for the presenting symptoms. If the assessment indicates that an acute mental health admission is necessary, arrangements will be made for an admission to an acute bed. If the service is at capacity, alternative beds will be sought in accordance with the escalation policy.

Mental Health Services across Galway, Mayo and Roscommon are actively advocating for an increase in the number of mental health beds in the area. We are presently in the early stages of planning an expansion of acute bed capacity across the region. A working group has been established at both the Galway University Hospitals (GUH) site and Roscommon University Hospital to develop these plans.

Additionally, we have established a Crisis Resolution Team for Galway City, which will comprise a Consultant Psychiatrist, a Non-Consultant Hospital Doctor (NCHD), a Senior Social Worker, three Clinical Nurse Specialists, and a Clinical Nurse Manager.

We also aim to recruit two Suicide Crisis Assessment Nurses (SCAN Nurses) and a Clinical Coordinator for the Crisis Team in 2025.

Mental Health Services across Galway, Mayo and Roscommon also created West Be Well, a website and communications network that provides information on voluntary, statutory, and community groups engaged in wellbeing, mental health promotion, and suicide prevention initiatives in Galway, Mayo, and Roscommon.

The HSE are considering the proposal in the context of the property and procurement protocols that we are obliged to adhere to. The timeline for completion and specifics on the clinical and ancillary spaces will likely be confirmed as the project moves forward, in accordance with the relevant statutory regulations and public procurement guidelines.

- 2 Registrars
- 1 Intern

Administration Staff - Haematology Service UHG:

There are 2.8 WTE Medical Secretarial posts currently supporting the service. Approval for 1 WTE temporary post has recently been received but has not yet been recruited.

Nursing Staff:

There are currently 4.5 WTE Haematology Clinical Nurse Specialists (CNS) that work with the Haematology Consultants and their teams. These CNS attend clinics and meet, educate and organise all further diagnostics for the new patients who are diagnosed with a malignancy.

A Business Case has been submitted to secure another CNS as the Service is growing exponentially.

The Nursing Staff in OPD is separate to the CNS staff but there are usually 2 Staff Nurses assigned to each clinic.

Portiuncula University Hospital:

The wait time for a new appointment is up to 3 months & there is no wait time for reviews- patients are scheduled to be reviewed as clinically required.

Portiuncula University Hospital run one Haematology clinic twice a month.

Portiuncula University Hospital have achieved Sláintecare wait time targets for Haematology

Letterkenny University Hospital:

All haematology referrals that are received are reviewed by the consultant for clinical triage, where indicated, advice letters are issued to the GP or requests for further information and/or tests are made. Red flag urgent referrals are issued with an appointment within 4-6 weeks and the weighted average wait time for all other first appointments is 9 months.

Patients who are due for review appointments within 3 months are scheduled and those for review outside of this are added to the review waiting list with an indicative date and scheduled in chronological order according to that date.

LUH continue to strive to reduce the waiting times for haematology appointments and have engaged in a number of initiatives including :

- Validation of the waiting lists to ensure that lists are kept up to date and that all patients listed still require appointments.
- The creating of a generic waiting list for new haematology referrals, to enable chronological scheduling of patients within clinical priority.
- LUH will also be submitting a funding request to the NTPF to support initiative clinics in 2025 that will specifically target the longest waiting patients in chronological order.
- Letterkenny University Hospital has secured funding from the NTPF for a 3rd Haematologist, to provide additional support

County Donegal does not have a HSE minor injuries unit. However, in early 2024 the HSE commenced a plan to roll out a number of Minor Injury Units across the country, including one in Letterkenny. The Management Team in LUH are working with the HSE to develop and deliver this project. The work is expected to require additional funding.

In the interim Letterkenny University Hospital has introduced a streaming service as part of a Quality Improvement initiative directing injured patients through a separate pathway once triaged - the aim was to provide a more streamlined improved service in a dedicated area "The Injury Assessment and Treatment Area" within the Emergency Department.

There are two ring fenced cubicles within the Emergency Department to treat and assess minor injuries. There are 2 x WTE RANP and 2 x WTE CANP staff who work from 8am to 8pm seven days per week. This has led to a major reduction in waiting times for patients.

Last year the Emergency Department managed 54,400 new attendances, 14% of those who attend with an injury can be safely treated by an RANP via this separate pathway. Children under the age of 16 years account for one-third of these presentations

In Letterkenny, Affidea have launched a Minor Injuries and illness Clinic in Scally Place which will operate five days per week from 10m to 6pm treating a range of minor injuries traditionally treated in the Emergency Department.

Letterkenny University Hospital:

LUH continue to strive to reduce the waiting times for respiratory appointments and have engaged in a number of initiatives including:

- 1. Validation of the waiting lists to ensure that lists are kept up to date and that all patients listed still require appointments.
- 2. The creating of a generic waiting list for new respiratory referrals, to enable chronological scheduling of patients within clinical priority.
- 3. LUH have also secured funding from the NTPF to support initiative clinics in 2025 that will specifically target the longest waiting patients in chronological order.
- 4. The 3rd permanent consultant has also taken up post last week which will also contribute to reductions in waiting times for both new and review appointments.

The current wait time for a first appointment with the respiratory service in LUH is 18-21 months.

All Respiratory referrals that are received are reviewed by the Consultant for clinical triage, Red flag urgent referrals are issued with an appointment in line with clinically recommended timeframes.

Patients who are due for review appointments within 3 months are scheduled and those for review outside of this are added to the review waiting list with an indicative date and scheduled in chronological order according to that date.

Sligo University Hospital:

There is no significant waiting list for Respiratory appointments.

>60% current referral are for possible OSA.

Changes introduced with new appointees:

- Single point of triage for all (IC, Resp and Sleep) referrals to avoid duplication of referrals and also distribute patients to most appropriate clinic
- Increasing numbers seen in Consultant led and IC Nurse/Physio led clinics
- Disease specific Clinics facilitated by development of OPD appointment Slip- right patient right place reducing review appointments
- Friday pm new Respiratory Referral opd 5-6 new patients per week (currently at least 33% discharge rate- to be confirmed)

- Spark funding application for additional Sleep Assessment technology- app for follow up
- Spark funding application for additional Sleep Testing Equipment

Roscommon University Hospital:

Currently there are 56 patients on the Respiratory Waiting List. 46 patients have a TCI date with 10 awaiting a date. The referral basis in RUH is from Consultant to Consultant as we do not have a Consultant Respiratory Physician as part of our team on site. The clinic is delivered by a Registered Advanced Nurse Practitioner at RUH.

The longest waiting patient is 3 weeks with a DOL 11/02/25.

The review appointments are advised to the patient at the time of attendance at their appointment and booked there and then. RUH does not have Review Waiting Lists.

RUH is involved with the following actions in order to meet the targets and minimise waiting times and numbers:

- 1. Continual validation of Waiting Lists,
- 2. Running initiative lists at weekends and evenings
- 3. Activated two way text messaging services in order to remind patients of their appointments and if they opt not to come that the appointment can be filled by someone else on the list.
- 4. Registered Advanced Nurse Practitioners who can see patients independently are also being employed in a number of specialities in order to support early appointments for patients.
- 5. Compliance with the NTPF OP Waiting List policy and active management of DNA and Cancellations.
- 6. Review of activity at Performance Meetings
- 7. Patient Initiated Review (PIR) to be shortly activated for this clinic service.

Galway University Hospitals:

We do not hold a review/follow up waiting list. Patients are booked to appointment slots within the timescales advised by the clinical team.

The Waiting List Office is working with the service to set up some additional out of hours sleep study clinics and will be undertaking a validation exercise in the first instance to ensure we are prioritising the correct patients.

A service plan submission and priority for the Medical MCAN is to seek an additional Respiratory Consultant with special interest in Sleep as well as a Clinical Nurse Specialist, Respiratory Physiologist and Administration support for the service.

Portiuncula University Hospital:

The wait time for new appointments is up to 14 months with 96% of patients waiting less than 12 months & there is no wait time for reviews- patients are scheduled to be reviewed as clinically required

PUH are providing additional clinic sessions to help meet Sláintecare Targets. A second Consultant Respiratory Physician is currently in recruitment.

Mayo University Hospital:

At present, MUH does not hold data for wait lists for review appointments.

In order to drive these wait times down for first appointment, MUH have secured NTPF funding for weekend clinics in respiratory from April 2025. There has also been a new appointment of a respiratory technician to assist with diagnostics.

A Letterkenny University Hospital (LUH) Capital Programme Oversight Board will be established in 2025 with membership from both WNW Region Management, LUH, Capital & Estates and others as required to oversee the creation of the Development Control Plan (DCP) for the LUH campus.

A Health Planning Consultancy will be appointed to develop the clinical scoping brief and collaborate closely with the design team to support the development of a comprehensive masterplan/ Development Control Plan (DCP) for the campus. The Health Planning consultants will assess and identify both the immediate and future clinical requirements, determining the scope of priority projects. They will contribute to the overall DCP, ensuring it provides a strategic framework for the optimal development of the LUH Campus in alignment with its long-term goals and operational needs of the population served.

Evaluation of tender submissions from Health Planners is currently underway with the tender of the Design Team for the DCP to be issued in Q2 2025.

LUH has prioritised four key major infrastructural projects. Each of these projects can proceed independently of each other on the campus but form part of an agreed overall integrated DCP. The delivery of each, either individually, or in parallel, will result in significant improvements in the capacity of the hospital to meet the needs of the population into the future. When all four projects are complete, they will integrate fully to become a functioning Model 3 hospital for the region.

The four key projects are:

- Bed Expansion
- Emergency and Urgent Care Capacity
- Critical Care Capacity
- Ambulatory Care Block

Ongoing Capital Projects in LUH including Roof Upgrades, Expansion of the Renal Department, New Heating Centre and various other minor capital projects are underway to increase capacity in the short and immediate term in addition to addressing urgent priorities on the LUH Campus.

The LUH Pathology Department continue to outsource 5.5% of the total GP workload and 3.3% of the total Pathology Department workload. The volume of GP tests referred out to a third party provider is the absolute minimum to relieve the excessive pressure on the provision of service in the Blood Science Department.

LUH continue to explore all options in an attempt to resolve the Blood Science laboratory capacity issue.

Carndonagh Day Services will become operational from 14^{th} April 2025. The day service will be located in the Spraoi agus Sport facility in Carndonagh. It will operate on a two day per week basis, Monday and Tuesday. Transport has been arranged to assist people in attending the centre. The day service will operate between 10am and 3.30pm and it is anticipated that between 10 - 15 people will attend per day. The activities in the day service will be based on "What Matters to Me" which is a document for older persons to fill out that enables Health care staff to plan care/activities, based on the individuals' preferences. From the day care perspective, the information from the attendees will allow day care staff to plan a schedule of activities from their preferences. Referrals for the service is through local Public Health Nursing. Any queries can be sent to the Director of Nursing, Carndonagh Community Hospital.

The provision of a Primary Care Centre in Carndonagh is currently at appraisal stages.
