Since the inception of the Advanced Paramedic Programme in 2004, there has been a considerable shift in patient needs. Twenty years on in 2025, 50% of all NAS patients are over 65 years while 33% are over 75 years. Less than one third of patients seen by NAS require hospital admission. The Advanced Paramedic Training and Education Standard increasingly does not meet the needs of these patients.

To mitigate this issue, and ensure the total number of specialists remains consistent going forward, NAS having consulted with the trade unions, established a new role, sanctioned by the Department of Health, for Specialist Paramedic.

As such NAS will concentrate its efforts in training specialist paramedics through 2025. In 2024/25 an additional 5 specialist paramedics have become operational across the region.

Galway base operates a dedicated RRV on a 24/6.5 basis which takes 4 staff to operate. This is the same numbers as was in 2018.





In line with International Best Practice, the NAS operates a dynamic deployment model which results in the closest ambulance being tasked to respond to high acuity Purple calls (Life Threatening cardiac or respiratory) or Red calls (life threatening illness or injury other than cardiac or respiratory arrest). This call taking and dispatch function is operated by the NAS National Emergency Operations Centre (NEOC) which operates across two sites, Dublin and Ballyshannon. All NAS resources are dispatched to calls across the country from the NEOC on a nearest available (to the incident) basis and not on a county boundary basis.

KPIs are set based on the expected level of rising demand compared to the level of funded capacity available to respond to that demand. KPIs set out in the NSP are national aggregate targets rather than locality-based targets and reflect the geographical and rurality challenges and diversity faced in achieving such targets. Therefore, reporting and publishing of response times on a county by county or IHA basis is not a requirement.





The ongoing reviews at the PUH Maternity Unit are specific to the care delivered to individual women and their infants. The HSE will be unable to publish those reports in full as the contents of each report will be specific to the women and baby involved and retaining their anonymity is paramount. Specific elements of the reports and recommendations may be published with the prior consent of the women.

Following the publication of the 2018 Walker Report (which covers the period 2008 – 2014) all recommendations were implemented and overseen by a senior team which included representation from the Saolta Group and PUH management teams. In May 2019 the HSE National Acute Operations, Quality Assurance and Verification teams, and the National Women and Infants Health Programme (NWIHP) examined the progress made on implementing the recommendations. The validation team reported that good progress had been made by the Saolta Hospital Group in implementing the recommendations of the Walker Report, and ensuring the quality and safety of the maternity and neonatal services in PUH.

The external management team placed in PUH will be working closely with the Maternity services team and overseeing the implementation of any recommendations made in the reviews that are currently in progress, as well as addressing other aspects of the service including governance, workforce, access and training and education needs.

In the aftermath of Storm Éowyn, more than 200 vaccination sites contacted this inbox and received information regarding their vaccine stock. The National Immunisation Office contacted every site in the country which receives vaccines, both in advance of the storm and while power outages continued, with advice on maintenance of the cold chain during power outages. Sites were advised on vaccines which could still be used and on the return process for damaged stock. Many sites were able to rescue vaccines by working closely with the Pharmacy Team within the National Immunisation Office. Damaged stock can be collected when a site receives a vaccine delivery, which is a fortnightly service. As necessary, vaccination sites were accommodated with emergency vaccine deliveries to replace any stock damaged due to power outages.

Additionally, the HSE has in place a comprehensive guideline for the maintenance of cold-chain in vaccine fridges and management of vaccine stock.

The purpose of the guideline is to define the Standard Operating Procedures (SOPs) for the maintenance of the cold chain in vaccine fridges and vaccine stock management, at vaccine storage sites. Additionally, the guideline outline a detailed standard operating procedure to be followed for management of breaks, such as power outages, in cold chain as well as wastage disposal. The guideline has been recently updated (dated August 2024)

In the first instance we acknowledge and understand the distress that the lack of power causes particularly to those most vulnerable in our society.

In advance of Storm Éowyn, HSE services considered the possible impacts on vulnerable clients and in so far as possible made alternative arrangements for their care. ESBN have a Vulnerable Customer policy and associated Vulnerable Customer Register in place.

There is a process in place for the HSE to engage directly with the ESBN in the context of prioritising health service requirements which was activated and utilised extensively during Storm Éowyn, this ensured that our main acute, residential and associated services were maintained but unfortunately due to the scale of the impact of Storm Éowyn a significant time before power was restored to some areas across the West, North West and Midlands was experienced by some people.

HSE services in so far as possible supported vulnerable clients during this difficult time a number of ways including working with partner agencies – Local Authorities, An Garda Siochána and the Voluntary Emergency Services to mitigate the effects of power outages.

As with all significant events a lessons learnt piece of work will be completed by agencies including the HSE and ESBN. This will ensure that these issues are considered in the context of our experience and learning from the impacts and scale of Storm Éowyn and will inform our planning going forward.

There are currently no GMS GP vacancies in Co Donegal. There were seven GMS GP contracts processed by the Primary Care Development Unit for Donegal GPs in 2024. To date in 2025 there has been one GMS GP contract awarded in January with another contract to be issued in the coming week. It is very positive to see that vacancies are being filled in a timely manner including those within practices in more rural parts of the county. The Primary Care Development unit continues to offer ongoing support to GPs in organising and planning for future replacements. Vacant posts are widely advertised and details of all vacancies are circulated and communicated through the GP Community and the GP Training Schemes Network in Sligo and Donegal. The number of Doctors accepted into the GP Training Schemes across the country (including Donegal) has increased substantially in the last number of years, with plans for further increase in numbers over the next three years. The training schemes operate over a four year cycle and it is hoped that a number of the newly qualified GPs will be attracted to take up GP posts in Ireland and that the GP training programme will go some way to addressing GP shortages especially in rural areas.

In addition, the new 2023 GP Agreement includes measures to try and maintain GMS GP services in isolated rural communities including initiatives targeted at addressing hard to fill vacancies and initiatives addressing the current challenges of filling vacancies in rural and deprived areas.

All HSE services including primary care, older persons, mental health, and disabilities, in so far as was possible, prepared in advance for the impacts of Storm Éowyn. Despite preparations put in place, the scale of this storm impacted all agencies in a way that was unprecedented resulting in interruption to power supplies and communications. Many services, including those provided by the HSE West and North West, were impacted as a result and whilst every effort available was made to support vulnerable clients before, during and after the storm, including the provision of generators, admissions to alternative settings with power and working with partner agencies – Local Authorities, An Garda Siochána and the Voluntary Emergency Services – it was not possible to fully mitigate the effects of the scale of the power outages and the challenges associated with same.

As with all significant events, a "lessons learned" piece of work will be completed by agencies including the HSE, ESBN and other statutory bodies. This will ensure that these issues are considered in the context of our collective experiences and learning from the impacts of a storm on the scale of Storm Éowyn and will inform emergency management planning going forward across the HSE West and North West area so that vulnerable persons can be supported to the greatest extent possible during any future storm events.

LUH and the West North West Region welcomes the confirmed approval of a Consultant Neurologist and Clinical Nurse Specialist. This will significantly improve access to Neurology services for patients in Donegal.

Whilst LUH proceed with documentation to get formal approval at the Consultant Application Advisory Committee (CAAC) and subsequent permanent recruitment through the Public Appointment Service (PAS), LUH has in the interim interviewed a number of candidates and has offered a locum Consultant position to a successful candidate. This candidate has verbally accepted the position and is awaiting registration on the Specialist Division of the Irish Medical Council.

The SUH lead Neurology Service continues to hold 3 Consultant outpatient clinics in Letterkenny each week.

Clearances are currently in process with the Medical Workforce Department, so we expect a start date for end of Q2 of 2025.

SACT activity in all of our units are challenged due to increased demand, increase in demand is multifactorial other than the predicted doubling of cancer incidence, including:

- new drugs increasingly approved for use
- development of immunotherapy and cellular therapies (CAR-T) and associated complexities
- Increased tolerability of new drugs meaning patients with comorbidities can now be treated but are more complex to treat
- With the development of more modern drugs, treatment cycles now last longer and often indefinitely
- Increased duration and complexity of infusion times
- Increased survival rates due to more effective treatments leading to increased requirement for more lines of subsequent treatment when cancer returns or progresses
- Patient survival has improved, but this is associated with significant increase in demand for cancer services in general and cancer treatments, particularly the Day Wards.

Medium - Long-term Plan to address capacity deficiency:

The National Cancer Strategy 2017 – 2026 and the National Development Plan 2021 – 2030 (NDP) are committed to major capital investment in cancer infrastructure nationally with investment in quality infrastructure within Saolta specifically called out in the NDP: 'in accordance with balanced regional development, a cancer care network for the Saolta region (West, Northwest) with a Cancer Centre at Galway University Hospital, with appropriate infrastructure will be delivered'.

The cancer centre infrastructure requirement at Galway University Hospital (GUH) is progressing as part of the Model 4 hospital site development.

The HSE West North West vision for cancer infrastructure in each of the model 3 hospitals is to develop appropriate Ambulatory Cancer Centres (ACC) at Letterkenny University Hospital, (LUH), Mayo University Hospital, (MUH), Portiuncula University Hospital (PUH) and Sligo University Hospital (SUH) in line with the NDP.

GUH plan in progress to add an additional 6 chairs

PUH plan to add an additional 2 chairs (q2 2025)

LUH added 4 additional treatment bays as an extension to the day ward situated on the in-patient floor

Plans to address these issues

In light of the vacancy rates within all services across the community in Donegal, the following actions have been undertaken to enable occupational therapy staff to safely continue to provide a quality, client-centred service to the people of Donegal who are presenting with highest clinical need:

- Contingency Plan for Adult Primary Care OT Service implemented since September 2024, which outlines a number of actions and priority measures.
- OT Managers currently providing clinical cover for the Specialist Seating Service.
- Escalation of risk assessments to senior management to outline the risk issues pertaining to continued OT Service provision.
- Plan to complete waitlist validation by mid-2025 for Paediatric Primary Care Services.
- Employment of agency OT to assist with Intellectual Disability Services and completion of Housing Adaptation Grant Assessments.
- Implementation of triage and prioritisation initiatives within Primary Care Adult OT services to increase clinical capacity.
- Caseload management reviews and professional supervision for OTs by OT managers.
- Review of referral data to inform service planning and allocation of limited resources by management team.
- Staff health and wellbeing initiatives to support staff to perform their duties safely.
- Engagement with union for support and clarity on service planning.
- Reallocation of clinical resources due to planned and unplanned leave.

The HR department in Integrated Healthcare Area Cavan Donegal Leitrim Monaghan Sligo, in collaboration with ATU, are funding a bursary for OT students who are then committed to working for the HSE for two years on graduation. The next cohort is due to graduate in June of this year. There is a rolling local recruitment campaign for OTs to fill approved, funded posts.

Occupational Therapy are fully committed to providing health care to all eligible patients, however it is important to note that the service must be delivered within the resource allocation and funding available, with the level of activity and associated costs being managed in a way that ensures people with the greatest need are supported within the overall expenditure of the delivery of services while not exceeding the available funding allocated.

In 2023 Sligo Leitrim Mental Health Services (SLMHS) were allocated a budget of €30.618 million. The 2024 budget allocated was €31.87million. We have not yet received formal notification of the 2025 budget allocation.

In 2025 the Government announced an additional €16million allocation in Ireland for the enhancement and expansion of services.

Under Släintecare recommendations the Government has set a target for mental health funding to be at 10% of overall health spend.

The overriding requirement continues to be the prioritisation of the delivery of safe and effective services and continued improvement on other aspects of quality including patient and service user experiences.

Donegal Disability Services are planning to reopen the respite service at Riverwalk Respite House, Carndonagh, four days per week, from the 3rd of April 2025. Further recruitment to approved positions will allow for further extension of the service.

The following outlines the status of the outstanding Riverwalk Respite House positions to be filled as advised by the HSE Human Resources department:

- Healthcare Assistants (HCA): One HCA post is on boarded and the second HCA post is at post acceptance stage of recruitment.
- Staff Nurse: No interest has been expressed in the vacant staff nurse position in Riverwalk Respite House from the
 existing staff nurse panel held by the HSE Human Resources department. The HSE Human Resources department are
 extending the search to additional staff nurse panels in Donegal, Sligo, Leitrim, Cavan, and Monaghan Community

(d) How many GPs are signed up to ShannonDoc at present?

ShannonDoc is a private co-operative which is owned and part funded by 170 members (i.e. General Practitioners) located across counties Limerick, Clare and North Tipperary.

I wish to advise that under the Winter Support Measures for General Practice Services 2024/2025, the HSE provided additional funding to all of the grant funded GP Co-ops across the country. This exceptional measure enabled GP Co-ops to roster additional doctors in Out of Hours Treatment Centres between 6 p.m. and 10 p.m. (Monday to Sunday incl.) between the 27th December 2024 to 26th January 2025 incl. and it ensured that more patients would receive in person consultations at ShannonDoc Treatment Centres.

The additional funding allocated to the Mid West under this measure was €108,000 with €72,000 made available to ShannonDoc and €36,000 to Limerick Doc.

ShannonDoc have confirmed that during the period 27th December 2024 to 26th January 2025, they rostered 710 additional doctor hours. They also confirmed that the total number of contacts to ShannonDoc increased by 34% when compared to the same period last year, in person consultations at Treatment Centres increased by 36% and the referral rate to ED is similar to the same period last year.

Prior to 2020, the Day Centre in Regina House operated five days per week, providing services to older persons in West Clare. These services were temporarily closed in 2020 due to public health restrictions as part of the response to the Covid-19 pandemic.

In mid-2022, a decision was made to reopen the Day Centre. However, due to staffing challenges this has not happened to date.

We have been in contact with voluntary agencies in Clare with a view to providing day services to older adults, including people with dementia, from Regina House. An options appraisal has been completed to determine the best approach to the operation of the day centre and will be considered this month.

The Department of the Environment, Climate and Communication is responsible for the Emergency Call Answering Service (ECAS) is responsible for 112 and 999 calls and texts, providing a vital link between the caller and the Emergency Services (Garda, Fire, Ambulance and the Coast Guard).

ECAS is a Stage 1 Public Safety Answering Point (PSAP). Its role is to establish the Emergency Service being requested by a caller and the location of the caller or incident for the purpose of routing the call to the most appropriate Emergency Services centre.

The Communications Regulation (Amendment) Act 2007 provides for the establishment and operation of the ECAS and enables the Minister to enter a contract with an entity to provide the service. BT Communications Ireland Limited (BTCIL) currently holds the contract to operate the service.

As such, queries on infrastructure should be directed to the relevant government department, Department of the Environment, Climate and Communications.

- 1. The Land Development Agency (LDA)
- 2. Prescribed State Entities (Ref: DPER Circular 17/2016)
- 3. The open market

In accordance with the HSE's Protocol for Acquisition & Disposal of Property Protocol and associated legislation Steps 1 and 2 above must be completed prior to offering the property to the open market. We are currently at Step 2 of the process and the Local Authority have expressed interest in the property.

All proceeds from the disposal of assets must be remitted to the Department of Health.

As Carrigeens Health Centre is deemed no longer suitable as a day centre for older persons, the HSE plans to relocate the service to a potential new location in Maugherow.

To facilitate this, the HSE has been exploring a service level agreement for delivering day services at Maugherow Community Centre. The centre requires upgrade works and Sligo LEADER has been supporting Maugherow Community in the development of a parish committee to run the facility and to support the committee in applying for relevant grants. The committee has been actively seeking grants and is currently awaiting the outcome of the applications for funding.

A day service is currently operating in the North Sligo area in Cliffoney on 3 days per week (Tuesday, Wednesday and Thursday) which has availability to support additional attendees on all days. Clients can either self-refer to this service or a public health nurse can refer them.

BreastCheck is Ireland's free breast screening programme. We screen women who have no symptoms of breast cancer so that we can find and treat breast cancer at the earliest possible stage. We aim to invite women for their first screening test by the age of 52 - in some cases it will be 53; and every two to three years after that, up to the age of 69. We provide access to

appropriate care for those who need further tests and treatment. We work to make BreastCheck services accessible to all; for example, providing longer or group appointments, and information in braille and international languages.

We have four BreastCheck static screening units and 24 mobile clinics across the country. Since 2020, we have introduced three additional mobile units to increase capacity. We are looking at introducing more units to further reduce barriers for women, enabling greater access to screening. We update our breast screening locations regularly on our website.

Mobile clinics enable us to provide breast screening for more women across the country. They typically stay at a location for between three months and two years and we invite eligible women living in the area for screening. The units then move to another location, where we invite eligible women in that area. We work to ensure that women have an equal and equitable opportunity to attend screening close to where they live. Our website provides more information on our mobile units and how they improve access for women.

Most recently, a mobile unit was in Sligo town from October 2021 to March 2023. The unit was in Sligo town for a longer period than normal so that women in both Sligo and Leitrim who were due for screening could attend. We screened in Tubbercurry from April 2023 to March 2024 and the mobile unit has been in Carrick-on-Shannon since then. We plan for the mobile unit to move to Sligo town during the second half of 2025. Women in the area can also attend for screening in Ballina or Galway.

Women who have been unable to take up a previous screening invitation can contact the BreastCheck Western Unit on 091 580 600, Monday to Friday between 8am-5pm, and we will aim to find the most suitable place, date and time for them to attend.

The establishment of Health Regions allows each area to plan and deliver services around the specific needs of people in each area, and to provide a consistent quality of care across the country. Each region has its own budget, leadership team and responsibility for local decision-making.

The HSE recruitment embargo ended on Monday 15th July 2024 with the release of a Pay and Numbers Strategy. This was approved by the Department of Health and the Department of Public Expenditure and Reform. This provides for a new approved maximum Whole Time Equivalent (WTE) staff figure for the HSE and Section 38 Agencies of 129,753. (This excludes disability services, pre-registration nursing and midwifery students, and 76 special assignment temporary posts). The figure of 129,753 includes an additional 3,310 new service development posts.

The HSE North West Region has been provided with its own specified number of WTEs and can, within that approved number, replace, recruit and prioritise posts. The Health Regions have been actively working to fill posts via Agency conversion, new Development Posts and vacancies arising in 2024.

Workforce reports are analysed on an ongoing basis and are also published on the HSE website. These reports are updated on a monthly basis and provide data on the health service personnel and WTE census. The Health Service Personnel Census WTE as of the 31st December 2023 for the West and North West region (excluding service development posts) is 23,417. This

is the WTE limit in the context of the Pay and Numbers Strategy for the region, excluding service development posts. No individual staff ceiling is set for specific care groups or services.

Clinical leads within services are required on an ongoing basis to consider the staffing resource available to them in their respective areas and to take the appropriate measures within their teams to adapt to the non-replacement of staff.

Recruitment is continuing across our services in the context of the WTE limits applicable. These includes clinical and clerical/management/administrative roles. Service development posts approved in 2024 and New Service development posts for 2025 are also being progressed to recruitment in the context of the National Service Plans. These include posts attached to our Mental Health Services across the region.

Based on the findings of a demand modelling study, a Development Control Plan (DCP) for the University Hospital Galway (UHG) Campus is in final draft and represents a Masterplan for development of the Campus to 2045. A draft of the DCP, addressing all feedback received to date, is due to be completed in the first Quarter of 2025.

Considerable enabling, decanting and site clearance works are required to facilitate delivery of the major projects and these have been identified as distinct package of work.

All infrastructure projects are subject to the requirements of the Public Spending Code and the associated Infrastructural Guidelines (IG). Given the scale of investment required a number of proposed projects at UHG will constitute 'Major Projects' (i.e. will have an estimated capital cost in excess of €200 million) and as such will require additional approvals including review by the Major Projects Advisory Group and Government Approval.

It is intended that a Strategic Assessment Review (SAR) for the DCP be submitted to the HSE and the Department of Health for review and comment in Q2 2025. A Business Consultant has now been appointed to assist in preparing this SAR.

Individual projects are then intended to proceed on a phased basis in accordance with the sequencing described in the DCP. A tender is currently being prepared to appoint a single Business Consultant to progress all individual projects through further stages of the Infrastructure Guidelines, starting with preparation of PBC's.

Tender competitions to set up a number of new Design Team Frameworks - to progress all projects including enabling works - are also currently being prepared. It is intended that all consultants/Design Team members to progress the major projects and related enabling works will be appointed over the course of Q2/Q3 2025.

Progress and completion of the major scope of work set out as the 'mid state' projects in the DCP in a timely fashion will be dependent on the relevant approvals being obtained, on availability of required funding, and on the provision of sufficient internal resources to manage the design and construction processes in an effective manner.

In Limerick there are a range of suicide bereavement supports for children and adults as follows:

- The HSE Mid West employs **two Resource Officers** for Suicide Prevention, one of whom covers Limerick city and county.
- Pieta Suicide also employs a Bereavement Liaison Officer for the Mid West who works with both adults and children.
- Blue Box Creative Learning Centre are a charity based in Limerick providing supports to children including suicide bereavement support. Further information is available on www.bluebox.ie
- **Healing Untold Grief Gently (HUGG)** are a national suicide bereavement support group funded by the National Office for Suicide Prevention. They hold a bimonthly support group in Limerick city. While this is for adults only, if adults are supported they will in turn be able to support children.
- An illustrated story book, Safe Harbour, supporting children who have been bereaved by suicide, is now available online through the following link https://www.childhoodbereavement.ie/safeharbour. Written by Patricia Forde and illustrated by visual artist Bronagh Lee, this free new HSE resource will empower parents or carers to have difficult conversations safely with their child around this sensitive topic.
- **Limerick Bereavement Network** is a group of organisations in the Limerick area that provide general bereavement supports,
- There are a range of other agencies that will support children and young people bereaved by suicide while these services are not specifically focused on suicide bereavement, they include Family Resource Centres, Jigsaw, and Limerick Youth Services.

Children's Grief Centre Funding:

The Children's Grief Centre provides support to children and young people affected by loss through death, separation or divorce. It also offers a safe and supportive listening service for children, young people and their families who are grieving. The Children's Grief Centre moved to their new location at Mount St. Vincent, O'Connell Avenue, Limerick in 2023.

The HSE Mid West provides €15,000 core funding to the Children's Grief Centre annually. In addition to the core funding, the HSE Mid West also allocated an additional €30,000 once off payment in both 2024 and 2025. This additional funding was allocated in recognition of the valuable service provided by the Centre in supporting children and families across the Mid West.

The HSE received approval to provide €450,000 to the Children's Grief Centre towards the cost of their new Centre in O'Connell Ave. These monies will be transferred to the Grief Centre as soon as ongoing legal issues have been resolved.

The post continued to be advertised until 31st January 2025 when an application was received; recruitment is now progressing to the next stage with interviews being arranged.

This Consultant when appointed will require a CAMHS ID Multidisciplinary team to provide this clinical service alongside the CAMHS MHID Consultant. We will have to examine ways to give this support.

The referrals for these children are currently not being accepted.

Community Services Cavan, Donegal, Leitrim, Monaghan, Sligo (CS CDLMS) Disability Services management met with the Head of Operations for Rosses Punto on July 16th, 2024, regarding re-opening of the hydrotherapy pool at the former Cregg campus. Rosses Punto had agreed, in principle, to re-open the hydrotherapy pool for an interim period of six months at that point. However CS CDLMS Disability Services could not meet the cost of what was being sought by Rosses Punto from within its existing allocated budget and the service could not recommence. Funding has not been allocated as per the 2025 national budgetary allocation process to re-open the hydrotherapy pool at the former Cregg campus.

Two Consultants providing the Chronic Pain service in SUH have both moved to new roles in other hospitals.

Recruitment to fill these 2 vacant Consultant Anaesthetic posts in the Pain service is actively ongoing, with permanent posts advertised and closing date of 13th February 2025. Shortlisting dates are being agreed currently via Public Applications Service with interview board nominees which are likely to take place by early March.

In the interim, while the process for permanent filling of posts is undertaken temporary posts advertisements have been active in all appropriate websites and agencies, One temporary post has been offered and we are waiting confirmation that this is accepted with start date likely March / April, if accepted. Medical Manpower are working on finalising an agreement plan for the commencement of a temporary consultant as early as possible.

A temporary Consultant commenced in July 2024, to oversee the governance of the Pain Management and Education Programme (PMEP) a psychologically-based rehabilitative treatment for people with persistent pain. This has allowed the PMEP programmes to continue as normal.

In addition to the care being provided by family, carers, Day Care Centres and the Meals on Wheels Service, the Home Support Service assists clients by providing personal care services as per the Schedule of Care tasks, which are specific to each client's individual assessed clinical needs.

Home Support is provided to a total of 539 service users in County Leitrim. In addition to this, 97 people avail of the Meals on Wheels Services funded by the HSE, 116 people avail of Social Day Centres funded by the HSE, 62 people avail of sitting services and 20 people avail of overnight services.

There has been no change in policy to the nature of tasks undertaken by Health Care Assistants (HCAs) under the Home Support Service, Older Persons Services. The Home Support Protocols document was devised in November 2024 for local use and was circulated to staff to provide clarity on the roles that do and do not fall under the remit of the HCA (Home Support) as there had heretofore been some misunderstanding that domestic duties are performed by HCAs, and this is not the case. The approved tasks for HCAs (Home Support) include duties such as showering, washing, medication prompt, meal prompt, dressing, assistance from/to bed. The Home Support Service does not provide domestic duties such as cleaning, washing floors, dusting, vacuuming etc. Clinically qualified professionals, such as the public health nurse or GP, perform nursing and medical care duties such as wound dressing or medication administration.

The HSE Home Support Service aims to support older people to remain in their own homes for as long as possible and to support informal carers in caring for older people. The HSE recognises the extremely valuable contribution of carers who care for family members, relatives and friends.

In addition to the care being provided by family, carers, Day Care Centres and Meals on Wheels, the Home Support Service will assist clients in providing personal care services in line with the Schedule of Care tasks specific to each client's assessed clinical need. These tasks can include showering/washing, dressing, continence care, meal heat and serve / meal prompt, medication prompt and any other assessed clinical need identified by Public Health Nursing (PHN)) which is essential for the person's care and relative to the role of the HCA (Home Support).
