In 2020 a Service Level Agreement was put in place between Galway University Hospital (GUH) and Children's Health Ireland (CHI) to provide a service and local access for GUH Paediatric patients with Developmental Dysplasia of the Hip (DDH).

These surgeries were carried out by Paediatric Orthopaedic Consultants from Crumlin. Since that time, any paediatric patient who required surgical intervention for DDH has had their procedures carried out in CHI at Crumlin.

Following the audit a review was undertaken as requested by the HSE. From the initial review, we identified that a small number of surgeries took place in GUH by CHI Paediatric Orthopaedic Consultants. Upon further review of our data and broadening of the scope, we can confirm that there are 22 patients who had their surgery performed in GUH between 2020 & 2023 by surgeons from Crumlin.

The recent audit reported that children who had surgery in CHI at Crumlin were found to have been appropriately selected for surgery based on the current standards used by the auditor.

Appropriate follow-on communication and care will be provided to these children in line with best practice and recommendations from the audit.

Mayo Home Support delivered **48,458 hours** to **1,595 clients in April** Mayo home support **waiting list** at the end of April is, **245** 

The average home support hours per week per client in Mayo is 6.3 hrs. Our allocation ranges from zero to max of 17.5 hours depending on care needs. However in exceptional circumstance it can increase to 21 hours home support to support complex care needs of client. We also provide short term care to facilitate discharge from hospital following post-operative surgery, e.g. total hip replacement, back surgery, etc.

Home Support do not have an I.T. System available to collate the information as per request, i.e. the number of clients receiving 1 hour, 2 hours or more, etc.

Please note an I.T. System for the Home Support Statutory Scheme has gone to Tender nationally and this will include a reporting feature to capture this data.

Any decision to transfer a patient for care and treatment from Mayo University Hospital to another health care facility is based on the clinical need and the service best placed to meet or provide the treatment required. In line with National treatment pathways (head injury for example) there are established receiving hospitals.

There may be cases (for example in elective or less-urgent situations) where a patient may have a preference (based on an established treatment relationship with a specific consultant) and if appropriate and accepted for the transfer by the consultant, a patient would transfer to that facility.

Where a patient is an adult and has capacity, decisions about their care and transfer are informed by the patient's clinical need and discussion with the patient.

- Currently, 1 CT Colonoscopy is performed per week, in the Radiology Department.
- These CT speciality exams take approximately 50 / 60 minutes to perform from start to finish.
- Currently, both CT scanners in use in GUH are providing imaging for 75-85 inpatients & outpatients per day.
- Recently, a piece of digital equipment (insufflator) was approved for these speciality CT exams which will
  assist in reducing the length of time taken to perform the exam (i.e. to 30 minutes approximately). Radiology
  Registrars are currently undergoing training on how to use this equipment which should be completed in
  the coming weeks.

Once, training is completed, the new piece of equipment will be used for this exam. This will enable Radiology in GUH to perform an additional number of CT Colonoscopies per week i.e. an increase of 2 patients a week. This will be 3 in total, which will be kept under review.

This will reduce wait times for our patients, provide early diagnosis and timely follow up treatment/surgeries.

GUH have a mobility management plan for the Merlin Park University site. As part of this plan we have identified the requirement to liaise with Bus Eireann.

We are served on the site by the 402 which runs on a frequent basis into the city and on to UHG and serves across the city as far as Knocknacarra. This bus runs every 30 minutes from 6.30 a.m. to 11 p.m.

We also provide a Hospital Shuttle Bus service which crosses the city every 20 minutes at peak times and every 30 minutes thereafter from UHG to MPUH and patients can avail of this service from 7 a.m. to 11 p.m. Monday to Friday.

With the announcement of funding for this initiative in the West, a working group has been established and includes clinical and management representatives from both Primary Care and Children's Disability Network teams. The working group will review criteria and access for children on both Primary Care and Community Disability Network Teams waiting lists with regard to DCD- Dyspraxia services. Networks 4, 5, 6 in Galway have been selected as a pilot hub in which to offer this initiative, with plans to roll out this programme across wider hub networks in Roscommon/ East Galway and in Mayo. The initial pilot will focus on children from age 8-13 years old. Services will include diagnostic assessments, hand writing assessments, 1:1 interventions, groups and education sessions. Holiday days and various camps will also be offered.

An Occupational Therapy led review of waiting lists across both CDNT and Primary Care services is underway to identify children for inclusion in this initiative.

#### Actions being taken to address CDNT vacancies at a national and local HSE level include:

- The HSE Human Resources department have continuing CDNT rolling campaigns in place. Interviews for these rolling campaigns take place routinely across all grades for CDNTs, and interview dates are arranged with CDNTs on an ongoing basis.
- Continued focus on establishing and updating panels across all grades is supported by rolling campaigns.
- Posts are expressed to all panels held for the discipline/grade in an effort to fill.
- Information on all vacancies is tracked on a weekly basis to ensure any appropriate follow up actions are progressed as timely as possible.

An external Health & Safety Audit inspection was carried out on the orthopaedic theatres and all required actions will now be progressed.

Regarding the resumption of elective activity, theatre lists have recommenced and work is ongoing to agree dates for the cancelled patients in the coming months.

#### **Immediate Actions:**

Immediate repairs were carried out by the HSE Maintenance team week after Easter break following leak on Good Friday. The HSE Maintenance team identified water ponding on roof after heavy rainfall and appointed a Roofing Contractor to install drainage channels within existing roof build up to take excess water to roof outlets. The cost of the works permitted direct negotiation with the contractor in this case. These works were completed week ending 9<sup>th</sup> May. The roofing contractor also identified other potential water ingress points at the junction of plant room louvres and roof upstands. Additional flashing has been added to plant room wall to divert water outside upstand.

There has been heavy rainfall in the intervening period since the remedial works were completed and there has been no evidence of further leaks in the theatre space.

#### **Roof Replacement**

The more permanent solution proposed to address any deficiencies with the roof is to upgrade the entire roof area over the theatre department. These works are currently out to tender and works are due to be completed Q3 2025.

A new dedicated Ambulatory Gynaecology Unit opened on the 1<sup>st</sup> April 2025 and this is facilitating the transfer of some gynaecology procedures away from the main theatre. We are also progressing the development and opening of a Maternity Day Assessment Unit in the coming weeks.

A Distributed Antenna System (DAS) was installed in the new 50 bed block with very good results on testing.

DAS helps ensure users have reliable connectivity even in locations with walls, flooring, and other obstacles that degrade cellular coverage. DAS technology is most commonly used in indoor, high-density locations, such as airports, hotels, offices, and other commercial buildings, stadiums or arenas, and outdoor spaces such as urban areas and campuses for first responder communication. This distributed network of antennas ensures that the cellular signal is evenly dispersed and maintained, even in areas with very high user density and demand, typically such as stadiums, convention centres, malls, underground transportation, or large office buildings.

The average home support hours per week per client across Galway & Roscommon is 6.3 hrs. Our allocation ranges from zero to max of 17.5 hours depending on care needs. However in exceptional circumstance it can increase to 21 hours home support to support complex care needs of client. We also provide short term care to facilitate discharge from hospital following post-operative surgery, e.g. total hip replacement, back surgery, etc.

Home Support does not currently have an I.T. system available to collate the requested information, such as the average days of absence that have resulted in individuals receiving home support services being left without care for a period of time.

Additionally, we are unable to extract data specifically for East Galway from the broader Galway dataset. Please note that a national tender process is underway for the development of an I.T. system for the Home Support Statutory Scheme. This new system will include a reporting feature designed to capture this type of data.

The GVLO review and submit the application to the National Vetting Bureau (NVB) for processing. At the end of the NVB's processing and background searching the NVB return the vetting outcome to the GVLO who inform the local service. The opening hours of the new cath labs at University Hospital Limerick are as follows:

- Cath Lab 1: Monday to Friday 08:00 to 18:00
- Cath Lab 2: Monday, Wednesday and Friday 08:00 to 14:00

The new cath labs create the capacity to increase the volume of cardiology procedures and expand the range of procedures available to cardiology patients in the Mid West.

The laser-guided therapy technology allows for higher imaging quality, management of more complex cases here in the Mid West, and greater safety for cardiologists who are exposed to higher radiation doses than any other healthcare worker.

The new facilities, which have been generously supported by the Munster Heart Foundation and the JP McManus Pro Am, will further enhance UHL's capacity as a nationally-designated 24/7 primary percutaneous coronary intervention (PPCI) centre. UHL is already one of Ireland's best-performing centres for care of patients with STEMI heart attacks, which are among the most serious of coronary events.

New procedures available include renal arterial denervation for life-threatening hypertension, currently being trialled, and structural procedures such as cardiac valve replacement. The new labs also create the capacity for future provision of electrophysiology procedures for complex arrhythmias and other electrical activities of the heart.

The new labs are a major step forward in tackling waiting lists for procedures and wait times for routine outpatient appointments. This means fewer referrals outside the region or to the private sector, and less reliance on lifelong drug therapies for conditions not surgically treated.

Following consideration a decision has been made not to progress/pursue a business case pertaining to the re-opening of the hydrotherapy pool at the privately owned former Cregg Campus.

A number of factors were considered in reaching this decision. Substantial financial resources would be required in order to bring the pool to a standard which both adheres to safety regulations and also comprehensively meets the needs of people potentially requiring the service. Furthermore, the HSE is mandated in utilising available resources in the most beneficial, effective and efficient manner. The re-opening of the hydrotherapy pool is not economically viable. Ultimately, the HSE is closing out all its arrangements within the former Cregg Campus. This decision is in line with current national HSE policy, such as the New Directions Policy for Adult Disability Day Services, which focuses on shifting from traditional, disability specific and centre based models of care to more individualised, outcomefocused supports including community inclusion and active citizenship i.e. a community based social model of care. Furthermore, the decision was made following cross care group consultation within the HSE, the future and anticipated demand for hydrotherapy and with the needs of service users to the fore.

Finally, any service user, who is clinically identified as requiring the use of a hydrotherapy pool, may be facilitated in Our Lady's Hospital, Manorhamilton, Co. Leitrim.

LUH has two Endoscopy rooms which have been insufficient to meet demand for these critical diagnostic procedures. Consequently, LUH has been required to rent a mobile Endoscopy Unit since 2016 to provide additional endoscopy capacity. Following a procurement exercise the contract of extension for the mobile endoscopy unit

currently in situ with EMS Group Solutions Ltd has been extended to the 31<sup>st</sup> January 2028 with a guaranteed option to extend to 2030. Despite the modular unit providing a third endoscopy room, the endoscopy service is currently having to alternate between a six day week (Monday to Saturday) and a 7-day week (Monday to Sunday) in order to meet patient demand.

The Hospital management Team and all clinical staff within the Endoscopy service are committed to see the development of an endoscopy unit with sufficient capacity to meet the population health needs of Donegal. The current preferred option to achieve this is to incorporate the existing endoscopy service within a larger facility in the LUH Ambulatory Care Centre supported by one remaining room to provide emergency endoscopy procedures in the main Hospital complex.

The provision and location of endoscopy services will be assessed as part of the Health Planning Project currently underway with confirmation of appropriateness for the permanent location confirmed within the Hospital's Development Control Plan.

LUH has been identified as a Pilot Site for the implementation of recommendations as set out in the Model 3 Hospital Consultant Recruitment and Retention Report (2023) which was commissioned by the RCSI and National Doctors Training and Planning. This strategy is in the final draft stages and awaits consultation with the Regional Chief Clinical Director and Management of the HSE West Northwest.

A Donegal IHA Capital Programme Oversight Board had been established under the chairmanship of Mr. Dermot Monaghan, IHA Manager with membership from services across Donegal IHA and also from HSE Estates. A LUH Health Capital Planning Project Team is being established under the chairmanship of Seán Murphy, Hospital Manager LUH with membership from LUH Clinical Directors and Managers, HSE Estates, and PwC Health Planning Team. The Project Team will report into the Oversight Board. The Project Team will be supported by: a Clinical Advisory Group (including LUH consultants and senior nursing & midwifery managers); User Groups for specific patient pathways; and a Health Planning Team led by PwC.

The Health Planning Consultancy team has been appointed to develop the clinical scoping brief and collaborate closely with the design team to support the development of a comprehensive masterplan/ DCP for the campus. The Health Planning consultants will assess and identify both the immediate and future clinical requirements, determining the scope of priority projects. They will contribute to the overall DCP, ensuring it provides a strategic framework for the optimal development of the LUH Campus in alignment with its long-term goals and operational needs of the population served.

Furthermore, the HSE is mandated in utilising available resources in the most beneficial, effective and efficient manner. The re-opening of the hydrotherapy pool is not economically viable.

The HSE's decision regarding the hydrotherapy pool is in line with the HSE policy such as the New Directions policy for Adult Disability Day Services which focuses on shifting from traditional, disability specific and centre based models of care to more individualised, outcome-focused supports including community inclusion and active citizenship i.e. a community based social model of care. The availability of accessible aqua facilities throughout communities including the Sligo area was also a consideration in the HSE's decision. Furthermore, the decision was made following cross care group consultation within the HSE to inform the future and anticipated demand for hydrotherapy and/or aqua facilities and with the needs of service users to the fore.

Finally, any service user, who is clinically identified as requiring the specific use of a hydrotherapy pool, may be facilitated in Our Lady's Hospital, Manorhamilton, Co. Leitrim.

The staff employed across Galway Roscommon Mental Health services are employed to staff our Acute Approved Units, our residential facilities and our Community Mental Health Services. The role of each individual staff members varies across the service.

In relation to the numbers and roles of each health staff person employed to deal with mental health issues in the Galway/Roscommon area the following are the staff census figures for June 2025 by staff category:

- Medical 95.3 WTE's
- Nursing 401.9 WTE's
- Health and Social Care Professionals 120.6 WTE's
- General Support Staff 34.6 WTE's
- Patient and Client Care 173.5 WTE's
- Management/Admin 94.9 WTE's

Health and Social Care Professionals groups refers to Social Workers, Psychologists, Occupational Therapists, Dieticians and Speech and Language Therapists.

General support staff refers to catering, cleaning and maintenance staff.

Patient and Client Care refers to Health Care Assistants, Multi Task Attendants, OT assistants etc.

Psychiatrists play a crucial role in mental healthcare by diagnosing, treating, and preventing mental health disorders. They are medical doctors specializing in mental health and can prescribe medication, provide therapy, and manage other medical treatments for various conditions, from depression and anxiety to more severe illnesses like schizophrenia.

The role of Mental health nurses is to support individuals with mental health challenges, promoting recovery, and improving their overall well-being. They work in various settings, including hospitals, community services, and specialized units, to provide individualized care and support to patients and their families.

The role of Social Workers in mental health is providing support and resources to individuals and families navigating mental health challenges. They assess needs, develop care plans, and connect people with necessary services, while also advocating for their rights and promoting well-being.

The role of Psychologists in mental health is to assess, diagnose, and treat a wide range of psychological and emotional issues. They utilize various therapeutic approaches to help individuals understand and manage their thoughts, feelings, and behaviours, ultimately promoting well-being and resilience.

The role of Occupational therapists in mental health is to help individuals participate in meaningful activities and develop skills to improve their daily lives and overall well-being. They focus on how mental health conditions impact a person's ability to engage in self-care, work, and leisure activities. Through tailored interventions OTs support recovery, enhance social participation, and promote a balanced and satisfying routine.

Dietitians play a crucial role in mental health by addressing the impact of nutrition on mental well-being and supporting individuals with mental health conditions through dietary interventions. They help manage the nutrition-related aspects of mental illness, including side effects of medications, disordered eating patterns, and overall nutritional needs. Dietitians also work to improve catering and menu planning within mental health settings, ensuring healthy food options are available.

Healthcare assistants (HCAs) and Multi-Task Assistants (MTAs) play vital roles in supporting mental health care, often working alongside nurses and other professionals to provide comprehensive care and support to individuals experiencing mental health challenges. HCAs, in particular, contribute significantly to the well-being of individuals with mental health conditions by providing practical and emotional support, promoting independence, and fostering a sense of security. MTAs, while primarily focused on supporting other healthcare professionals, also contribute to a positive patient experience, which indirectly benefits mental well-being.

Management and admin staff support the clinical services in the administrative role and function within the services. Management Admin staff, in addition to supporting frontline clinicians are also involved in back office supports and functions which including payroll, accounts, superannuation, PPP etc.
