Ireland's strategy is to distribute all COVID-19 vaccines that we receive, subject to ensuring availability of the second dose. At the beginning of last week, Ireland had received approximately 520,000 vaccine doses and by the end of the week approximately 500,000 doses were administered, a measure of the programme's efficiency. Vaccines continue to be administered very quickly after their arrival into the country. At the moment, vaccine administration is limited only by the supply of approved vaccines and that is dependent on manufacturers meeting their supply commitments.

In relation to General Practitioners, the position is that at the conclusion of the first phase rollout of the programme last weekend, the HSE has confirmed that the majority of patients aged 85 years and over have received their first dose of the vaccine as scheduled. GPs have also begun administration of vaccine to people aged 80-84. In total over 1,300 GP practices, representing in excess of 3000 GPs and their Practice Teams have delivered over 90,000 vaccines by last weekend and a further 37,000 vaccines being distributed this week (w/c 8 March). The programme has also involved a number of large scale GP clinics, which have taken place in the Helix DCU, MTU in Cork and Merlin Park Galway with over 1,500 over 85's receiving the vaccine at these locations.

There are a very small number of practices, less than 30, who are due to receive first delivery this week for their over 85s and it is also intended to commence the vaccination of those who are homebound as arrangements have been put in place in conjunction with GP's, local community teams and the National Ambulance Service and will commence this week and also patients in our acute hospitals. The HSE has acknowledge that there were problems with communication with GPs generally and that some issues have arisen with the distribution of vaccines to some GP Practices over the last week and we wish to apologise to GP practices, their teams and the patients who may have been impacted by these.

The vaccination programme is limited internationally by the supply of vaccine and our programme to date has ensured that all available vaccine is distributed and administered as quickly as possible. The supply required for the completion of the programme by mid-May remains on target. However, due to a re-profiling of the Moderna vaccine delivery schedule, the total vaccine doses available for distribution in the coming weeks is now slightly less. The available vaccine supply is approximately 15% less than the required amount to meet the total over-80 cohort. This means GPs may not receive the total order for these coming weeks but, in all instances, GPs will be advised on the amounts they will receive and any shortfall in vaccine for the over-80 age group will be allocated in the next order and so on through March with a significant ramp-up in vaccine delivery in April as increased supplies arrive in Ireland. Unfortunately, these supply issues are outside of our control. However, if any additional supply becomes available, this will be provided to General Practitioners at the earliest opportunity. Importantly, we expect that the totality of the over-70s programme will be completed within the original timeframe of mid-May.

With regard to the Vaccinator Role, the Statutory Instrument (SI 698 of 2020) is the relevant SI which includes pharmacists as one of those disciplines which can vaccinate for the purpose of rolling out the Covid Vaccination Programme subject to their being registered with their regulatory body (PSI) and subject to agreement by the regulatory body on required training. (The DoH introduced a new SI (81 of 2021) which added dentists and optometrists to the list of disciplines approved as vaccinators subject to registration etc.)

The COVID-19 Vaccinator Recruitment Initiative for the HSE is being supported by CPL Healthcare. Registered optometrists and registered dentists can apply to become COVID-19 Vaccinators from 2pm, Tuesday 2nd, March 2021.

There is a National Clinical Programme in Eating Disorders which is aimed at providing services nationally to children, adolescents and adults with eating disorders and a Model of Care has been developed as part of this programme. Sligo has been designated as a mini-hub for adults on this model of care and no specific funding from the National Programme in 2021 has been identified.

Through the 2021 HSE service plan, CHO1 Mental Health Service has received approval to recruit an additional three Senior Dieticians to support children and adults with Eating Disorders. Each CHO1 MHS catchment area - Cavan Monaghan, Donegal and Sligo Leitrim – will be allocated one post. This will broaden the range of expertise available to treat the specific needs of this population.

Cavan Monaghan and Sligo Leitrim Mental Health Service, each have one Eating Disorder Therapist, providing specialist therapeutic intervention to people with eating disorders.

The Eating Disorder Team in SLMHS, the CAMHS team and the Mental Health Liaison Team in Sligo Leitrim work closely with the medical and paediatric teams in Sligo University Hospital (SUH) to provide multidisciplinary care and best practice for those - adults and children - admitted to SUH with severe Anorexia Nervosa using the MARSIPAN guidelines. In addition children requiring community care receive physical monitoring, mental state review, weight restoration and therapeutic intervention; nursing staff in CAMHS have trained in CBTE in recent years, and aim to provide a clear evidence based care pathway of care to young people under 18 with a primary eating disorder.

Working from home arrangements are assessed on a case-by-case basis by line managers. They are primarily administrative in nature as most staff are required on site to support clinical, patient facing or management roles. Line managers in the first instance ensure that service needs will not be impacted by having staff work from home. In addition, the situation is fluid as short term arrangements can be made to enable people to work from home for child-care purposes or if they are designated as close contacts of a Covid-19 positive case.

A number of factors are considered by line managers before assessing if an employee has the necessary supports in place to work from home such as equipment and technological infrastructure.

All staff attendances are recorded on SAP, however there is no facility to record if a member of staff is working from home, and therefore it's not possible to provide a definitive number as arrangements are managed at a local/team level.

Group 3 - People aged 70 and older

GPs will contact their patients when the vaccine is available. Patients do not need to register for the vaccine. Donegal CAMHS Service have until now operated a two team model covering North Donegal and South Donegal. North Donegal also includes the Inishowen area.

Both teams are made up of Clinical Staff including a Child and Adolescent Consultant Psychiatrist, Non Consultant Hospital Doctor (NCHD), Senior Psychologist, Senior Social Workers, Nursing Staff, Occupational Therapists, Speech and Language Therapists and Social Care Workers. Teams are also supported by Administration Staff.

Unfortunately the COVID pandemic has negatively affected the numbers of people waiting to be seen by CAMHS Donegal. During the restriction levels, waiting lists have increased as professionals were unable to complete full assessments and observe the service user in their usual environment which is a key component of many mental health assessments. It has also been difficult to link with other key personnel such as teachers and other professional supports who may be working with the young person.

Whilst Donegal CAMHS acknowledge that the waiting list for children and adolescents waiting to be seen is above the acceptable levels (there are currently 144 young people waiting on their first appointment as of 31st January 2021) the service is currently developing performance improvement measures to address the waiting list.

Whilst Donegal CAMHS have had two Consultant Psychiatrist posts which have not been filled with locum consultants for some time, the service has recently been successful in attracting two permanent candidates to these posts which will see the development of a three team service the third team covering the geographical area of Inishowen. This coupled with a performance improvement plan will assist in ensuring that the young people in Donegal receive the mental health supports they require.

Donegal CAMHS operate on an outpatient basis but have access to the in-patient treatment beds at Merlin Park CAMHS In-patient unit, University College Hospital, Galway.

The role of Occupational Therapy with the fatigue management/energy conservation, for these and other clients, is one that needs to be further developed within our Primary Care services in order to be able to address people's needs at earlier stages in their conditions.

Whilst there are no specific psychological supports for people with ME, a person with ME, and who has co-morbid psychological difficulties or mental health difficulties, can be referred to the appropriate service in accordance with their needs.

The Living Well Programme is also a valuable resource to support people living with long term health condition to self-manage their condition and the skills taught are very relevant for living with any long-term condition. The project design team for the ED project at UHG were requested to assess the feasibility of including the development of the Women and Children's element of the new block, at the same time as the development of the lower ED floors. This feasibility report has been completed and has been considered by the HSE nationally. The intention is to now update the business case and progress the overall full project scope. The project timeline including the timeline for obtaining planning permission for the new block will also be updated .

In parallel, the design of enabling works for the site which impacts the critical path is being progressed. We have also proceeded with both Winter ED works to create a green stream ED and also the commencement of construction works in relation to the Interim ED building at UHG as part of overall response to COVID-19 and overall site needs.

All clinical members of CAMHS Community Mental Health Teams provide a keyworker for CAMHS service users. There are currently 95.96 clinicians on the Community Mental Health Team and the Acute Inpatient Unit.

The total number of active cases is recorded annually in the 1st and 3rd Quarter statistics. Quarter 3 2020 statistics are as follows:

South Galway 710 North Galway 588 West Galway 356 Roscommon/East Galway 514

These are due to be reported again in the March statistics i.e. Q1 2021.

Each service user is assigned a key worker and in some cases depending on presentation they may have more than one key worker. As previously indicated we do not have the electronic systems in place to allow use to identify how many service users are assigned to each key worker. Currently, however we envisage that a National I.T. system should have this facility in the future.

Since November 2020 – the CT Scanner has been out of operation on one occasion from the 26th December 2020 at 11:30am to Sunday 27th December 2020 at 16:30 hrs. Galway University Hospital facilitated diagnostics during this period.

As this occurred over the Christmas period – no Outpatient lists were affected and 3 patients were transferred to GUH for a CT Scan.

The identified priority for Portiuncula Hospital is the replacement of the Fluro X Ray machine (Siemens Iconos R200 installed 2001). The replacement of the Siemens Somotom 64 slice CT (install date 2007) is the next equipment

priority thereafter. The replacement of this CT machine in its existing location is not considered ideal due to space constraints and downtime implications. Therefore the proposed approach is to locate the replacement machine in a more suitable location. This will require infrastructural works to be carried out in the first instance. Capital funding will be sought for this approach with a view to initiating the project later this year and progressing the works and equipment replacement in 2022.

The Connecting for Life, Galway, Mayo and Roscommon Suicide Prevention Action Plan 2018-2020 was launched in 2017 ConnectingforLifeGMR. It is one of 17 local, multi-agency suicide action plans, developed throughout Ireland, which align with the goals and objectives in Connecting for Life: Ireland's National Strategy to Reduce Suicide, so as to ensure their local implementation, while also responding to particular local needs, strengths and challenges (ConnectingforLife). Connecting for Life nationally is being extended to 2024. A complete set of revised local action plans are also in the process of being developed to reflect activities until 2024.

In Galway, Mayo and Roscommon a Connecting for Life Implementation Steering Committee has been established, with wide representation from all key stakeholders. It is chaired by the Head of Mental Health Services, HSE.

The following are examples of some of the actions being undertaken in the *Connecting for Life Galway, Mayo and Roscommon Suicide Prevention Action Plan* to address the need to increase public awareness of the mental health supports available among second level school going young people and to target awareness and services in 'as gaeilge' to youth communities in Connemara:

• A 'Westbewell' Working Group was established in September 2020. Its membership includes those supporting young people. This working group aims are to: develop a coordinated Mental Health Communications Strategy for Community Healthcare West, including the promotion of timely, safe, evidence-based mental health messages and mental health supports; develop and build awareness of the Westbewell brand in Galway, Mayo and Roscommon; and support/reinforce national mental health campaigns at a local level. 'Numbers if you need them' materials (flyer, poster and wallet cards) are being widely distributed, including through traditional and social media in Galway, Mayo and Roscommon and online via www.westbewell.ie/poster and www.westbewell.ie/poster and www.westbewell.ie/walletcard).

The home page of www.westbewell.ie will be translated into Irish.

The next phase of this work currently underway is planning and delivering a communications action with young people, which optimises social media opportunities. To date, we have received feedback from young people linked through mental health services and an adolescent project in the region in relation to: where they currently receive their messages on mental health; and what they identify are the best ways of promoting these messages among their peers [Goal 1.3.1(a)].

 A project is currently underway in the development to strategically place Community Health and Well Being Boards in local sports clubs throughout Galway City and County, as part of a Sports Partnership, Mental Health Ireland and HSE initiative, funded by Galway City Council and Health Ireland, Galway County. This will help to promote supports for young people, for example, Childline, Text 50808 and Spunout.ie [Goal 2.2.1(a)].

- The START online, interactive suicide prevention programme, which is free to complete, has been made available by the HSE National Office for Suicide Prevention throughout Ireland, including the West. This programme is for those aged 18 years and older who would like to learn the skills and knowledge to keep others safe from suicide, including the adult school community who are engaging with second level students on an ongoing basis (to book a place see START) [Goal 3.3.2].
- Youth Work Ireland Galway continues to provide a free counselling service to young people (aged 12-21 years) in Galway City and County in 4 locations (Galway City, Loughrea, Tuam and Ballinasloe) over 16 hours weekly. This service is part funded by the HSE. An online service is being provided during the Covid-19 pandemic. In 2021, Youth Work Ireland received funding from the Children and Young People's Services Committees through the Community Resilience Fund to provide counselling in new areas of Galway County, i.e. Gort, Athenry, Oughterard and An Ceathrú Rua. The funding is short term, offering 64 sessions across these four additional areas.

The aim is to provide this service through Irish in Connemara [Goal 3.3.6(b)].

- Training on evidence-based wellbeing programmes, for example, MindOut, is usually delivered to teachers as part of the SPHE programme by HSE Health Promotion and Improvement through the Education Centre. However, with Covid restrictions, all training is currently on hold [Goal 3.1.6(c)].
- The Planet Youth project is an international evidence-based primary prevention model, developed in Iceland, which is being led out by the Western Region Drug and Alcohol Task Force in Galway, Mayo and Roscommon for a number of years. Part of this work involves administering a comprehensive lifestyle questionnaire to the 15-16 year olds in schools and Youthreach settings. This survey includes questions on young people's mental health. The data returned from the survey is used to inform the development of suitable interventions in the community that will help address the known risk and protective for young people and thus improve outcomes. A report is currently being compiled for data gathered in 2020 [Goal 3.2.1(b)].
- A National Mental Health and Wellbeing Promotion Plan is currently in development which aims to respond to the mental health and wellbeing needs of young people, based on findings from national surveys and studies carried out with this cohort [Goal 1.1.2(a)].

Jigsaw

Jigsaw is an early intervention, primary care service for youth with mental health issues. Jigsaw Galway offers free brief therapeutic support to young people aged 12-25 to help them to cope with the mental health challenges they may face. These challenges can include low mood, anxiety, sleep issues and stress. While supports were traditionally in the form of in person sessions, the restrictions of Covid 19 have seen Jigsaw successfully adapt to providing therapeutic interventions through video and phone sessions in addition to in person face to face appointments.

Schools

Jigsaw Galway has always worked closely with schools and communities across the county in providing resources and workshops. In 2019, we further developed our engagement with schools by piloting the One Good School programme which was rolled out to 5 schools in the county. The One Good School initiative supports the mental health and well-being of young people by developing a shared responsibility across the whole school community – including school leadership teams, teachers, parents and students and was delivered through interactive workshops, online tools and resources, and peer education programmes. While this pilot is currently being completed, Phase 2 is about to be rolled out and Jigsaw Galway will be working with schools interested in being involved in the next phase of this programme.

In response to the the challenging times that schools have experienced over the last 12 months following consultation with our school partners including our One Good Schools, we have developed The Jigsaw Schools Hub – our new mental health and well-being resource for schools. This Jigsaw Schools Hub provides supportive tools and resources which may indeed make the transition back to the classroom a little easier for staff, students and parents – we are currently communicating with schools in the county in relation to the new Jigsaw Schools Hub. www.jigsaw.ie/schools provides a growing range of resources for school staff, created in collaboration with young people, school staff, and parents. The resources contribute to delivering a mental health and well-being programme as part of the school curriculum and have been tailored to support school staff and students during the Covid-19 pandemic.

This includes:

- An Introduction to youth mental health toolkit to help school staff to explore mental health and well-being with young people in the classroom.
- Ways for school staff to support and look after their own mental health.
- What school leaders can do to create a whole-school approach that supports staff and students with their mental health and well-being.

Community

Jigsaw continues to work closely with the communities across the city and county to build confidence in supporting and promoting young people's mental health. We offer 14 workshops to parents, guardians and adults who work with young people. Many of our workshops have been converted for online delivery, which enables the Jigsaw Galway team to continue to support communities even in times of Covid 19 restrictions. Our current online workshops include One Good Adult, Self-Care for One Good Adult, One Good Coach, 5 A Day for Mental Health, My Mental Health, What Helps? and It's Time to Start Talking.

We are a member of the Galway Child & Young People's Services Committee and also attend the Child and Family Support Network for Gort, Connemara, West Side and Athenry

Jigsaw Galway is a member of the Steering Committee of Planet Youth and the Jigsaw Galway Youth Advisory Panel has recently been involved in consulting on the new West Be Well Platform, www.westbewell.ie. Our Youth Advisory Panel members actively promote the Jigsaw service among their peers and are about to commence a new project promoting the service through a poster and information campaign. They actively promote the service and positive mental health messages on Instagram.

To date in 2021, 41 % of young people who attended Jigsaw Galway for brief intervention support self-referred to the service, 35% were referred by a parent /guardian and 17% were referred by their GP. We continue to work with communities and schools to raise awareness of the services we provide to young people in Galway but we also work with other referral agents for example GPs and other services. We held an open morning in 2020 to provide general information on our supports and referral pathways and plan to engage again with these stakeholders later in 2021. We are also currently finalising an information pack for the Galway service which will be a valuable resource for stakeholders and referrers.

Online Supports

Jigsaw Galway is part of the wider Jigsaw network and as a national organisation, we have a number of online and phone offerings available to young people, their parents/guardians, concerned others and those who work with young people. These include:

- Jigsaw Online https://jigsawonline.ie/ which contains lots of information/reading on mental health and supporting young people with their mental health.
- web chats for young people with a trained member of staff to speak about any issue of concern they may wish to discuss.
- Group chats for young people aged 12-25 with a trained member of staff. Themes of such groups chats

- include 'Coping with Lockdown' and 'Managing Anxiety'.
- An 'Ask a Jigsaw Clinician' feature where a young person can ask a mental health question or query and it will be answered by a Jigsaw Clinician
- Our Freephone Service 1800Jigsaw (544729) was set up in response to Covid 19 and provides mental health support and advise to young people, and parents or concerned adults. A Jigsaw Clinician can also be contacted for support and guidance by emailing help@jigsaw.ie. Jigsaw Clinicians are available to speak to young people/parents/concerned other Monday to Friday 1.00pm 5.00pm.

Whilst CAMHS do not complete ASD assessments and the diagnostic service for ASD lies within Disability Services, it is common for young people who are referred to CAMHS with other difficulties to require an ASD assessment. Staff in CAMHS make this referral for parents, and support them through that process, providing information on the referral pathway. CAMHS will also make community referrals for supportive services as required for young people and families following assessment. On occasion when it is clear that there are complex mental health needs interacting with potential ASD, Mental Health Services have provided funding for an urgent ASD assessment, as this was considered to be in the best interests of the young person.

CAMHS also provide a range of therapeutic modalities, including, - Play therapy, Systemic Family Therapy, Cognitive Behavioural Therapy, Dialectical Behavioural Therapy (CBT), Cognitive Behavioural Therapy for Eating Disorder (CBTE), Eye movement Desensitisation and Reprocessing Therapy (EMDR), Psychodynamic Psychotherapy.

CAMHS works collaboratively with our colleagues in the Autism Support Service, and provide outreach clinics for the ASD service and regularly contribute to joint MDT meetings to care plan for young people with dual diagnoses of ASD and a moderate to severe mental illness.

In relation to ADHD, CAMHS offers a multidisciplinary assessment, which may include meeting with the young person and their family to gather a detailed psychosocial history, and complete a mental state examination, liaison with education professionals and other involved healthcare professionals and as well as use of internationally recognised standardised assessment tools. With consent, a diagnosis can be shared with the young person's school, and educational supports can be arranged. CAMHS staff also contribute to the roll out of community parenting interventions to the parents of all young people with ADHD.

CAMHS are committed to providing the appropriate interventions to young people with ADHD.

What mental health services if any will be provided at the two new primary care centres in North Sligo? Will there be any accommodation for Mental Health staff at these centres if required?

The new primary care centres have bookable rooms to facilitate outreach mental health services as requires

Are there any plans to build a purpose-built hub for Mental Health in North Sligo?

There are no plans to build a built in purpose HUB in North Sligo, however services will be provided on an outreach basis as required

Are there imminent plans to increase frontline staff in the Community Mental Health Services in Sligo?

SLMHS have increased frontline staff in the community Mental Health Services in Sligo over the last 6 months. In addition to these the Early Intervention Programme (EIP) and the Adults with ADHD programme have been launched within SLMHS and additional dedicated staff have been appointed to each of these programmes.

Are there plans to fill current vacant roles such as Mental Health Co-Ordinator role?

At present SLMHS have two Adult Community Mental Health Teams (CMHTS), one of which has a team coordinator. In addition SLMHS have a Psychiatry of Old Age (POA) Team and a Community Rehabilitation and Recovery (CRRS) Team both of which has a team coordinator and a CAMHS team which does not have a team coordinator. SLMHS therefore have two teams without a team coordinator at present. The vacant co-ordinator post will be filled immediately following national agreement between the HSE and relevant unions. It is intended that team coordinators reflect the multi-disciplinary membership of the teams.

What plans are in place to bring staffing levels of Dialectical behaviour therapy and Cognitive behavioural Therapy to a level that will reduce waiting times.

Adult Dialectical Behaviour Therapy (DBT)

The Sligo/Leitrim Adult Dialectical Behaviour Therapy (DBT) Service was established in 2013. It has consistently provided an evidenced based intervention to service users, and engaged in ongoing evaluation of its clinical outcomes.

A number of proposals are currently being considered by the Area Mental Health Management Team to increase staffing levels within the Sligo/Leitrim Adult Dialectical Behaviour Therapy (DBT) Service. These include:

- i. Releasing SLMHS staff members who have previously trained in DBT and are interested in returning to the DBT Service, from other duties for 1.5 days per week to re-join the DBT Service.
- ii. Facilitating some existing DBT Team members to increase their commitment (in terms of hours per week) to the DBT Service (this requires reducing their time commitment to their substantive role). Therefore this will need to be evaluated against demands in the core services.
- iii. Identifying suitable SLMHS staff to train in DBT.

We hope that these considerations will be progressed, and waiting times will consequently be reduced for this highly valued, evidence based intervention.

Adult Cognitive Behaviour Therapy (CBT)

As regards CBT, Sligo Leitrim Mental Health Service have a long tradition of delivering a high quality CBT service. In addition to the CBT service in each of our Adult Community Mental Health Teams, SLMHS have in the past 12 months begun the roll out of a CBT service to the Early Intervention in Psychosis (EIP) programme. This will provide psychotherapy to service users who present with a new onset of a severe mental illness or psychosis.

I am pleased to confirm that the recruitment campaign for the post of Geriatrician (integrated care) in Sligo was launched on the 5th February 2021 with the closing date in mid-April.

At present there is a Clinical Nurse specialist in Dementia care and an Older Person's Registered Advanced Nurse Practitioner (R ANP) with a special interest in cognitive issues. Both these staff members provide domiciliary care to clients and families living with Dementia/ Alzheimer's. They work under the clinical governance of a consultant

geriatrician who provides outreach services to the community from Sligo University Hospital.

Post Covid, CHO 1 in conjunction with the Alzheimer's Society is offering a variety of services for respite care including respite in the client's own home. This is offered for a number of block hours per week based on needs and risk assessment. The plan of care is tailored to individual needs and offers the carer some much need time out.

The government has indicated its intention to introduce a new home support scheme on a statutory basis similar to the Fair Deal Scheme in Nursing homes.

All Children with complex needs including children with Acquired Brain Injury are referred to the Children's Disability Network Team which provides services to all children and young people in the 0-18 age group. The Children's Disability Network Teams operate an interdisciplinary model of care which comprises of Occupational Therapy, Physiotherapy, Speech & Language Therapy, Psychology, Social Work and assigned Key Workers.

Children with Acquired Brain Injury and mental health difficulties are also referred to CAMHS and a joint care plan to address the child's needs would be developed.

In some cases where the child or the young person's needs are assessed as non-complex, their supports are provided through the appropriate disciplines in Primary Care Services.

In respect of the Mental Health Services specific query there are four [4] CAMHS teams in the Northwest regional encompassing 3 county areas, namely: two [2] for the catchment area of counties Sligo, Leitrim /West Cavan and two [2] for Donegal.

The HSE has been investing on the enhancement of the supports provided by these teams in recent years and this has been impacted by attracting and retaining the specialisms that CAMHS Teams require.

- In Donegal Mental Health Service a plan was set in place to develop a third CAMHS team and in that regard
 we have now secured 3 full time HSE Consultants for the whole county, as up to October 2020 there was
 only one [1] HSE Consultant in place. The established Heads of Discipline Team for Donegal are currently
 developing a waiting list reduction initiative and we hope this will be approved and progressed by Q3 2021.
- In Sligo Leitrim Mental Health Services, I can confirm that through an extensive recruitment campaign two [2] full time Psychologist are now at the final stages of the recruitment process and will be taking up their posts in Q2 of 2021. In line with Public Health guidance and the "Framework for Resumption of Adult Disability Services" which set out clear guidelines around the reopening of day services in a safe way, the HSE both nationally and locally worked very closely with all Service Providers over the summer months in 2020 to ensure the earliest possible resumption of services in August /September 2020.

However in complying with public health guidance and the need to keep all service users safe, it has been necessary to reduce capacity across services whilst at the same time ensuring that all services users were provided with a level of service. It should be pointed out that the redeployment of day service staff to support those residing in residential services throughout Covid 19 has impacted on the level of day service available. This in effect has meant that some service users are receiving a reduced day service compared to the level of service they received pre Covid 19. It should be pointed out that all individual cases are looked at on a case by case basis in terms of their need for additional supports.

The resumption of Day Services for people with a disability has been a key priority for Government and additional funding both in terms of revenue and capital was provided to the HSE in the final quarter of 2020 to support the resumption of day services. As a result of this additional funding, the HSE engaged with all Day Service Providers to ensure that all affected service users saw an increase in the level of day service being provided to them. Day Service Providers in Clare received their share of funding and have recruited additional staff to support the resumption of Services as well as utilising once off capital funding to complete adaptions/ renovations in their premises in order to increase capacity.

Whilst it is difficult to provide an exact timeframe for the full return to Day and Respite Services due the Covid 19 and the necessity to comply with public health guidelines, Service Providers in Clare have confirmed that some services have fully resumed where other services are operating at 70 % to 85 % capacity which is very positive. It should be noted that a number of individuals have chosen not to return to their Day or Respite Service while Level 5 restrictions are in place. Where this has happened, regular contact is maintained with these individuals and their families to support them.

HSE Disability Services and Service Providers in Clare are fully committed to the full resumption of day and respite services whilst endeavouring to keep everybody safe and well.

The Mid West Mental Health Service has remained open with services available for both new and existing service users throughout all phases of the Covid Pandemic. The referral pathway to Mental Health Services remains the same with access through the GP. Emergency appointments are available for existing Service Users through their Community Mental Health Team. Throughout the Mid West mental health services are delivered in the community via our network of community mental health teams. In Clare our Adult Community Mental Health Services are delivered through 4 sector community mental health teams – these are based in Ennis, Shannon, Kilrush and Lisdoonvarna. Each of these services is delivered by a multidisciplinary team including psychiatrists, clinical psychologists, occupational therapists, social workers and a team of nurses. These services operate 9-5 Monday to Friday. Access to acute services has remained the same through the Acute Psychiatric Units in Ennis and Limerick. Crisis services also continue to be available at the Emergency Department at University Hospital Limerick for both existing and new service users and can be contacted on 061 301111 (24/7). Additional Crisis Services are available in Clare (087 7999857) and Tipperary (086 830 6663) until 3am.



The average time waiting to date for patients currently on the waiting list is 27 weeks, the majority of patients will receive their surgery within 12-15 months of being list. Most of the cataracts are being delivered through the NTPF outsourcing process at present.

Five of these students are currently employed as SLTs, Nurses, Doctors by Saolta University Healthcare Group and CHO1 & CHO2.

Candidates applying for posts in Community Healthcare West do not routinely undertake an oral Irish Assessment at the interview stage unless it is for a bespoke campaign where it is essential due the requirements of the post.

Candidates are interviewed in English and placed on the relevant panel in order of merit. When approved posts are submitted to Recruitment with a post specific requirement for the Irish language, the post is expressed to the panel specifying this criteria. The candidate highest in order of merit will then undergo an oral Irish Assessment which they must pass prior to being offered the post.

Ireland's strategy is to distribute all COVID-19 vaccines that we receive, subject to ensuring availability of the second dose. At the beginning of last week, Ireland had received approximately 520,000 vaccine doses and by the end of the week approximately 500,000 doses were administered, a measure of the programme's efficiency. Vaccines continue to be administered very quickly after their arrival into the country. At the moment, vaccine administration is limited only by the supply of approved vaccines and that is dependent on manufacturers meeting their supply commitments.

In relation to General Practitioners, the position is that at the conclusion of the first phase rollout of the programme last weekend, the HSE has confirmed that the majority of patients aged 85 years and over have received their first dose of the vaccine as scheduled. GPs have also begun administration of vaccine to people aged 80-84. In total over 1,300 GP practices, representing in excess of 3000 GPs and their Practice Teams have delivered over 90,000 vaccines by last weekend and a further 37,000 vaccines being distributed this week (w/c 8 March). The programme has also involved a number of large scale GP clinics, which have taken place in the Helix DCU, MTU in Cork and Merlin Park Galway with over 1,500 over 85's receiving the vaccine at these locations.

There are a very small number of practices, less than 30, who are due to receive first delivery this week for their over 85s and it is also intended to commence the vaccination of those who are homebound as arrangements have been put in place in conjunction with GP's, local community teams and the National Ambulance Service and will commence this week and also patients in our acute hospitals. The HSE has acknowledge that there were problems with communication with GPs generally and that some issues have arisen with the distribution of vaccines to some GP Practices over the last week and we wish to apologise to GP practices, their teams and the patients who may have been impacted by these.

The vaccination programme is limited internationally by the supply of vaccine and our programme to date has ensured that all available vaccine is distributed and administered as quickly as possible. The supply required for the completion of the programme by mid-May remains on target. However, due to a re-profiling of the Moderna vaccine delivery schedule, the total vaccine doses available for distribution in the coming weeks is now slightly less. The available vaccine supply is approximately 15% less than the required amount to meet the total over-80 cohort. This means GPs may not receive the total order for these coming weeks but, in all instances, GPs will be advised on the amounts they will receive and any shortfall in vaccine for the over-80 age group will be allocated in the next order and so on through March with a significant ramp-up in vaccine delivery in April as increased supplies arrive in Ireland. Unfortunately, these supply issues are outside of our control. However, if any additional supply becomes available, this will be provided to General Practitioners at the earliest opportunity. Importantly, we expect that the totality of the over-70s programme will be completed within the original timeframe of mid-May.

With regard to the Vaccinator Role, the Statutory Instrument (SI 698 of 2020) is the relevant SI which includes pharmacists as one of those disciplines which can vaccinate for the purpose of rolling out the Covid Vaccination Programme subject to their being registered with their regulatory body (PSI) and subject to agreement by the regulatory body on required training. (The DoH introduced a new SI (81 of 2021) which added dentists and optometrists to the list of disciplines approved as vaccinators subject to registration etc.)

The COVID-19 Vaccinator Recruitment Initiative for the HSE is being supported by CPL Healthcare. Registered optometrists and registered dentists can apply to become COVID-19 Vaccinators from 2pm, Tuesday 2nd, March 2021.

Psychosocial Supports (Galway, Mayo and Roscommon)

'Psychosocial' refers to the practical, psychological and social needs that people may experience during a crisis. Each CHO has a psychology manager who leads the psychosocial response for Major Emergencies and co-ordinates the Health Service Psychosocial Management Team (HSPMT). Our HSPMT has a broad representation from CHW community services, Saolta and Tusla. Working together, a number of Psycho-social Responses have been developed for staff and the public during COVID-19.

- 1. Psychological First Aid (PFA) for staff. The aim of PFA is to support people in a crisis situation. People are generally resilient but when an extreme event occurs anyone can find themselves struggling at times. The PFA service aims to provide support to help staff get back on track. All HSE staff can contact the PFA call-back service by e-mailing Psychosocial.GMR@hse.ie. Staff will then be called back within 24 hours during office hours by a psychologist who will listen, help them to prioritise their needs, explore ways to cope and guide them to appropriate resources or services if needed. Staff may wish to have a follow-up contact and may also use the PFA service on another occasion as required.
- 2. Psychological First Aid Briefings for Staff. Our Psychology Team have provided PFA Briefings for staff in a live online format. Each briefing last approximately 1 hour. There is a presentation on PFA followed by Questions and Answers. The briefing is based on international research for supporting people in an emergency such as COVID-19, and outlines best practice for good self-care and peer support.
- 3. Psychological First Aid (PFA) Briefings for Managers. The PFA briefings for managers follow the same live online format as above: a live presentation by our Psychology Team followed by Q&A. Each briefing lasts one hour and is based on international research for supporting people in an emergency. PFA for Managers focuses on ensuring managers have key information to support their staff with their psycho-social wellbeing during COVID-19. Staff can enrol for the briefings by emailing martina.hughes@hse.ie. The briefing dates are also circulated through E-Services.
- **4. The vaccination programme is limited internationally by the supply of vaccine and our programme to date has ensured that all available vaccine is distributed and administered as quickly as possible. However, due to a re-profiling of the Moderna vaccine delivery schedule, the total vaccine doses available for distribution in the coming weeks is now slightly less. The available vaccine supply is approximately 15% less than the required amount to meet the total over-80 cohort. This means GPs may not receive the total order for these coming weeks but, in all instances, GPs will be advised on the amounts they will receive and any shortfall in vaccine for the over-80 age group will be allocated in the next order and so on through March with a significant ramp-up in vaccine delivery in April as increased supplies arrive in Ireland. Unfortunately, these supply issues are outside of our control. However, if any additional supply becomes available, this will be provided to General Practitioners at the earliest opportunity. Importantly, we expect that the totality of the over-70s programme will be completed within the original timeframe of mid-May.

There are two ways that pharmacists can vaccinate; the first is to apply through the national recruitment campaign to work in the new vaccinator role with the Department approved payscale and grade. These will be employed in that role in the Vaccination Centres along with other professions covered under the Statutory Instruments (SI698 of 2020 and SI81 of 2021) to act in that role. Alternatively, community pharmacists (and GPs and others) will support the wider vaccination programme and arrangements have been entered into with the IPU (and for GPs with the IMO) for payment rates for this work. Ireland's strategy is to distribute all COVID-19 vaccines that we receive, subject to ensuring availability of the second dose. At the beginning of last week, Ireland had received approximately 520,000 vaccine doses and by the end of the week approximately 500,000 doses were administered, a measure of the programme's efficiency. Vaccines continue to be administered very quickly after their arrival into the country. At the moment, vaccine administration is limited only by the supply of approved vaccines and that is dependent on manufacturers meeting their supply commitments.

In relation to General Practitioners, the position is that at the conclusion of the first phase rollout of the programme

last weekend, the HSE has confirmed that the majority of patients aged 85 years and over have received their first dose of the vaccine as scheduled. GPs have also begun administration of vaccine to people aged 80-84. In total over 1,300 GP practices, representing in excess of 3000 GPs and their Practice Teams have delivered over 90,000 vaccines by last weekend and a further 37,000 vaccines being distributed this week (w/c 8 March). The programme has also involved a number of large scale GP clinics, which have taken place in the Helix DCU, MTU in Cork and Merlin Park Galway with over 1,500 over 85's receiving the vaccine at these locations.

There are a very small number of practices, less than 30, who are due to receive first delivery this week for their over 85s and it is also intended to commence the vaccination of those who are homebound as arrangements have been put in place in conjunction with GP's, local community teams and the National Ambulance Service and will commence this week and also patients in our acute hospitals. and Adolescent Mental Health Service based in Letterkenny, for Inishowen, north central Donegal, north west, Donegal have we the resources to meet the huge demands in this area, and what steps are we taking to address the many challenges facing the children that need this service at the moment?

Donegal CAMHS Service have until now operated a two team model covering North Donegal and South Donegal. North Donegal also includes the Inishowen area.

Both teams are made up of Clinical Staff including a Child and Adolescent Consultant Psychiatrist, Non Consultant Hospital Doctor (NCHD), Senior Psychologist, Senior Social Workers, Nursing Staff, Occupational Therapists, Speech and Language Therapists and Social Care Workers. Teams are also supported by Administration Staff.

Unfortunately the COVID pandemic has negatively affected the numbers of people waiting to be seen by CAMHS Donegal. During the restriction levels, waiting lists have increased as professionals were unable to complete full assessments and observe the service user in their usual environment which is a key component of many mental health assessments. It has also been difficult to link with other key personnel such as teachers and other professional supports who may be working with the young person.

Whilst Donegal CAMHS acknowledge that the waiting list for children and adolescents waiting to be seen is above the acceptable levels the service is currently developing performance improvement measures to address the waiting list.

Whilst Donegal CAMHS have had two Consultant Psychiatrist posts which have not been filled with locum consultants for some time, the service has recently been successful in attracting two permanent candidates to these posts which will see the development of a three team service the third team covering the geographical area of Inishowen. This coupled with a performance improvement plan will assist in ensuring that the young people in Donegal receive the mental health supports they require.
