The recruitment process for staffing the Acute Stroke Unit has commenced. The nursing staff have been appointed and therapy support staff recruitment is currently underway.

Staffing includes 3.5 wte Nurses, 0.5 wte Healthcare Assistant, 0.8 wte Physiotherapist, 0.74wte Occupational Therapist, 0.4 wte Speech and Language therapist, 0.2 wte Dietetics and 0.5 wte Physiotherapy Assistant.

The opening of this unit has been delayed due to the COVID-19 Pandemic but with ongoing recruitment is now planned to open the unit in September - subject to no further wave of COVID 19 patients presenting to the hospital.

Following the initial contractor short listing process (stage 1) priced tenders for the enabling works package (stage 2) were sought on 4th March 2020. Due to COVID 19 the return date was extended until 22nd May 2020. Following receipt of tenders an evaluation process has been completed and the tender report prepared. It is intended to proceed with the award of contract in the coming weeks following expiry of the standstill period. It is anticipated that the enabling works contract would commence in August 2020 and be completed by early June 2021. It is intended to advertise for contractors to be shortlisted for the main ward block works later this year. Tenders could then be sought in early 2021 for the main works with a view to proceeding upon completion of the enabling works and subject to availability of funding in 2021.

In order to address the increase in the waiting lists and times in Letterkenny University Hospital the hospital has:

- -availed of additional capacity made available under the HSE initiative with private hospitals,
- -engaged with the NTPF to source funding approval to outsource eligible patients to private hospitals
- -recommenced validation of patients on waiting lists to ensure they are still require treatment and appointments,
- -commenced a number of outpatient initiative clinics in the hospital funded through the NTPF.

One of the new wards constructed to allow LUH to manage the projected COVID-19 surge opened on the 22nd June 2020

to facilitate the admission of surgical in-patient elective cases. The surgical elective ward will provide a green pathway for all elective surgeries. This ward has 14 beds plus 2 HDU beds.

The opening of the surgical elective ward does not increase the bed capacity in the hospital as 10 beds remain closed on the Surgical 2 ward as part of our ICU COVID 19 contingency plan. The remaining 29 beds are available to meet peaks in emergency admission demand — between 18 to 21 of these beds have been used on any given day over the past 3 weeks. LUH is also temporarily using the second ward created for COVID-19 (Medical 6) pending the recruitment of staff to open as an inpatient ward. This temporary use has allowed us to provide increased medical day case treatments and additional urology outpatient services to offset increase in waiting lists in these areas during the COVID-19 pandemic.

Medical 6 will also opened on the 22nd of June and will be used as a medical day case ward where bed capacity allows. It will be challenging this year to make a significant impact on the number of patients on our waiting lists due to COVID 19. Priority will be given to cancer and urgent cases.

Sligo and Leitrim HSE Disability Services, in line with the national programme Time to move on from Congregated Settings, are required to prioritise the closure of institutional residential facilities in both HSE Cregg services and HSE Cloonamahon services. To this end we have worked closely with Property Management, Estates and the local County Councils to identify and purchase properties to support individuals to move out into the community areas of their choosing. Houses are normally identified to meet the needs of individual residents with a capacity of four people moving together to their new home.

Cregg Services

Since the start of 2018 as part of the decongregation project:

- 40 people have moved out of the Cregg campus area to a number of houses in various locations across both Sligo and Leitrim.
- There are 38 people remaining to further decongregate.
- 9 people are in the process of decongregating to new houses in Leitrim at the present time
- 4 people will be moving to their new house in Leitrim before the end of Q3 2020.
- 12 people are to move to their new houses in Q4 2020

The 13 people remaining to decongregate will be moving to their new homes in Q1 2021 and this will be the completion of the Decongregation and closure of the Cregg Campus services.

Cloonamahon

- Currently 34 persons remain on campus in Cloonamahon
- 15 persons are scheduled to decongregate by year end 2020
- This leaves a total of 19 persons remaining to decongregate in 2021
- Please note that 9 of the remaining persons reside in two bungalows external to the main building

Disability Services remain committed to identifying properties for all people requiring residential supports in the Sligo and Leitrim areas.

Property in Manorhamilton Co. Leitrim

Recently a member of the Learning Disability Services community team met with New Grove Housing representative in respect of a proposal in the Manorhamilton area and unfortunately the Pandemic outbreak has prevented further discussion on the matter. Revenue funding will be the key factor in developing the proposal further i.e. staff funding as part of a Service Arrangement with New Grove Housing (Rehabcare). This funding is not currently available within the HSE revenue stream in 2020. The proposal will be reviewed further however the immediate priority is to complete the decongregation process for Cregg and Cloonamahon services.

The OPD Department reopened on the 8th June 2020 for all clinics. Visiting consultants will return on a phased basis. Fracture clinics were maintained over the last 3 months. Urgent cases that needed review were seen or had a consultation via telephone or video conference. There are now three options to reviewing patients in OPD, face to face, via telephone or using the software tool Attend Anywhere.

We recommenced our day surgery unit lists on Friday 22nd May, with a trial Gynae list of 4 patients. We have been working with all specialties to include equal share of lists, taking into account very urgent cases.

We have temporarily relocated medical day treatments from the day surgery unit in order to increase capacity for day surgery cases as part of our catch up programme.

On a phased basis we have also undertaken endoscopy lists in Kingsbridge private hospital, Sligo.

Planned elective in patient surgeries recommenced on the 22nd June.

The return to service was planned at the weekly Perioperative Department meeting. To date, 100% of our patients have attended for pre-screening and surgery.

The X-ray Unit in Clifden Community Hospital is fully operational, with one x-ray room processing GP referrals and inpatient (Clifden Community Hospital) requests. A radiographer from the UGH campus attends on site to treat approx. 15-20 patients for X-ray at a time. There is no requirement for a full time permanent radiographer as the service is provided for on demand.

There are no ultrasound facilities operational in Clifden, this service is provided for in UHG.
