Overview of Rehabilitation & Integration Officer

The RI Officer is part of the HSE Addiction Service Multi-Disciplinary Clinical Team and provides a key working/ case management role. They liaise with other statutory and community services/projects who are in-volved in Service User care.

The RI officers are available to assist SU manage their identified needs such as:

- back to education
- employment preparation
- retraining
- housing/accommodation information
- application for medical cards etc
- support and preparation for stabilisation, detox and rehabilitation.

The majority of the RI Officer's work is one-to-one sessions, but they also deliver group-based programmes often as part of a multi-disciplinary or inter-agency collaboration.

RI Officers are responsible for a particular catchment area and treatment/satellite clinics.

Who Can Access Our Service

The service is open to all individuals over 18 years of age.

Referral Process

The Rehabilitation Integration Service accepts self referrals and referrals from other disciplines/agencies & family members.

Residential Rehabilitation Process

All SU preparing for detox in Cuan Dara attend the RI Officer as part of the preparation for detox. The RI Officer will source appropriate door to door residential rehabilitation post detox in Cuan Dara. They will maintain contact with the SU while in Cuan Dara and the residential rehabilitation service and on discharge as an extra support while the SU attends an aftercare programme. This wrap around service is available to SU detoxing or seeking residential rehabilitation in other tier 4 services also.
