### Dr Niamh Lennox-Chhugani

Dr Niamh Lennox-Chhugani is Chief Executive of the International Foundation for Integrated Care. With her background as a clinician, academic and consultant, she is an Integrated care researcher and implementer in an international context. She is a regular speaker at conferences, on panels, has authored peer-reviewed papers and book chapters, led and contributed to health system reviews and integrated care evaluations globally. She has a PhD from Imperial College London in organisation change in healthcare. She is on the editorial board of the International Journal for Integrated Care and sits on the advisory board of numerous integrated care research programmes.



### **Professor Mark Mon-Williams**

Professor Mark Mon-Williams (MMW) is Chair in Cognitive Psychology at the University of Leeds, Professor of Psychology at the Bradford Institute of Health Research, Professor of Vision Science at The Norwegian Centre for Vision and a Turing Fellow at The Alan Turing Institute (the UK's National data analytics and AI Centre). He is Director of the Wolfson Centre for Applied Health Research and Impact Director for Medicine and Health at University of Leeds. He founded the Centre for Immersive Technologies, leads the Centre of Applied Education Research, and is on Born in Bradford's and Child Health Outcome Research At Leeds (CHORAL) executive boards.



### **Professor Mary McCarron**

Professor Mary McCarron is a leading expert in ageing and intellectual disability. She is Director of the Trinity Centre for Ageing and Intellectual Disability (TCAID) and Executive Director of the National Intellectual Disability Memory Service. As founder and Principal Investigator of IDS-TILDA, the first longitudinal study of ageing in people with intellectual disabilities, she has shaped policy and improved care nationally and internationally. She has led groundbreaking research on dementia in individuals with Down Syndrome and established Ireland's first dedicated memory service for people with Intellectual disabilities. She has been instrumental in developing ethical, inclusive models of research that prioritise the voices of people with intellectual disabilities. An Honorary Professor at Queen's University and Visiting Professor at Duke, she is a Fellow of the American Academy of Nursing. With over €20 million in funding, 500+ publications, and significant policy influence, she continues to advance inclusive, impactful research and healthcare innovation.



### **Professor Louise Gallagher**

Professor Louise Gallagher is Chief of the Child and Youth Mental Health Collaborative at the Hospital for SickKids, the Centre for Addiction and Mental Health (CAMH), Director of the Division of Child and Youth Mental Health and Professor at the Dept of Psychiatry, Temerty Faculty of Medicine and the Patsy Jamie Anderson Chair of Child and Youth Mental Health. She is currently leading the strategic development of the Thriving Minds Partnership, a clinical innovation between SickKids, CAMH and the Gary Hurvitz Centre for Community Mental Health to provide accessible and seamless care to children and youth with mental health disorders. In her role at SickKids she is the Co-Chair of the SickKids Mental Health Strategy and the Co-Lead of the Gary Hurvitz Centre for Brain and Mental Health. She is a Senior Scientist at the SickKids Research Institute and at the Campbell Family Centre for Mental Health Research at the Centre for Addiction and Mental Health.

### SPEAKER BIOGRAPHIES



### **Lily Collison**

Lily Collison is a globally recognised advocate for individuals with cerebral palsy (CP). Motivated by her son's diagnosis of spastic diplegia, she has been dedicated to improving outcomes for those affected by CP. She is author of Spastic Diplegia (2020), and co-author of Pure Grit (2021). In 2022, Lily was appointed Programme Director for Gillette Children's Healthcare Press at Gillette Children's Hospital, Minnesota, leading the writing of a nine-book series on childhood-acquired physical and neurological conditions. Each volume explains the condition, best-practice treatments, and families' lived experiences, with proceeds funding research. Lily has been pivotal in establishing the Irish Cerebral Palsy Programme of Excellence, creating leadership and research hubs at UCC, TCD, and RCSI to transform CP care in Ireland. Lily is a Board Member of the Health Service Executive. She was awarded an Honorary Doctorate in Medicine by UCC.



### Professor Clíona Ní Cheallaigh

Professor Clíona Ní Cheallaigh is an Associate Professor in the Department of Clinical Medicine, TCD and a Consultant in Infectious Diseases and General Medicine in St James's Hospital, Dublin. She is the Clinical Lead of the Inclusion Health Service in St James's Hospital dedicated to improving access to specialist hospital care for socially excluded individuals. The service started in 2016 and now consists of a full interdisciplinary team providing inpatient and outpatient care. The team uses an integrated, trauma-informed, harm reduction approach to meet the needs of socially excluded people.



### **Dr David Loughrey**

Dr David Loughrey is an Assistant Professor in Community Health at the School of Nursing, Psychotherapy, and Community Health, based in Dublin City University. He earned his PhD in Psychiatry at the TCD School of Medicine, where he was funded by the Irish Research Council's employment-based postgraduate research scholarship in partnership with Chime, and by the Dr. Ciaran Barry Research Scholarship awarded by the Central Remedial Clinic. He is also a senior Atlantic Fellow for Equity in Brain Health at the Global Brain Health Institute (GBHI), based at Trinity College Dublin and the University of California San Francisco, and at the Atlantic Institute based in the Rhodes Trust, University of Oxford. Dr. Loughrey's research focuses on understanding how social factors and disabilities, such as sensory impairment, may impact brain health and increase the risk of dementia.



### **Professor Sally Ann Lynch**

Prof Lynch's interests are in rare diseases. She is the author of >200 publications including a catalogue of >100 inherited rare disorders found amongst the Irish Traveller population (2018) and a catalogue of rare variants found amongst the Roma population (2025). She received the inaugural Health research impact award from HRCI foundation in 2022. She is currently the chair of the Diagnostic Scientific committee of IRDiRC (International Rare Disease Research Consortium). She is the Irish co-ordinator for the European Reference Network ERN-ITHACA. She set up the Irish training scheme for Clinical Genetics with RCPI.



#### **Professor Sean Dinneen**

Professor Sean Dinneen is an Academic Endocrinologist based in the West of Ireland. Past leadership roles include Head of the School of Medicine, University of Galway (2013 to 2016) and National Lead for Diabetes, HSE (2016 to 2022). He was an Editor with Diabetic Medicine from 2017 to 2024. In March 2021 he became National Lead for the PPI Ignite Network, aiming to increase capacity for high quality public and patient involvement in health and social care research in Ireland <a href="https://ppinetwork.ie/">https://ppinetwork.ie/</a> In January 2025 he was appointed as Ireland's first Clinical Lead for a National Diabetes Registry.



#### **Ms Fionnuala Cooney**

Ms Fionnuala Cooney is the Regional Director of Public Health in the HSE Dublin and Midlands Region. Dr Cooney has 20 years' experience working in Public Health, having previously worked in hospital medicine and primary care. Her areas of special interest include women's health, child health and human lactation (as a certified Lactation Consultant) as well as population-based planning and public health ethics. The prevention of disease and the improvement of population health and wellbeing are central to her practice.
