HSE Global Health Programme 3-year Plan, 2022-2024

Since 2010, the Global Health Programme has led a global approach in the HSE, developing and implementing initiatives aimed at improving health in developing countries while also learning from other countries to improve healthcare in Ireland. The main focus of the programme is technical cooperation with developing countries in Africa to improve health services. Building on previous achievements, including recent responses to the COVID-19 pandemic and Ukrainian crisis, the programme has developed a new strategic framework and 3-year implementation plan for 2022-2024 (see attached at Annex 1).

The HSE has a Memorandum of Understanding with Irish Aid, Department of Foreign Affairs to contribute to Ireland's international development policy, 'A Better World'. In September 2022, the Global Health Programme

entered into a funding agreement with Irish Aid, Department of Foreign Affairs for €700k over three years, based on the 3-year implementation plan.

HSE Policy on Donation of Medical Equipment and Supplies to Developing Countries and Other Countries in Crisis

The Global Health Programme leads and coordinates HSE donations of surplus medical equipment and supplies to other countries in need. Up to 2021, this was limited to decommissioned equipment which was sent to countries in Africa under the EQUALS Initiative. In 2021, in response to the COVID-19 pandemic, donations of equipment, PPE, vaccines and other supplies with a book value of more than €18m were made to India, Nepal, Brazil, Uganda, Lebanon and Zambia. This year, donations to Ukraine are expected to exceed a book value of €6m.

While all HSE donations are from <u>surplus</u> stocks or <u>decommissioned</u> equipment which would not have a future use in the HSE, there has been no previous HSE policy regarding such donations, including governance arrangements and levels of financial approval required for donating items which have a book value.

The policy attached at Annex 2 seeks to clarify these arrangements. In the policy, it is proposed that approval by the EMT is required for donations with a cumulative book value above €1m and donations with a cumulative book value above €2m in a financial year require Board approval. Decisions will be reported to the ARC/Board for information and monitoring purposes.

The policy applies to donations of medical equipment and supplies by the HSE to support development of health services in low and middle income countries, mainly in Africa. It also covers requests for humanitarian assistance from countries affected by health emergencies and other crises.

Subject to approval, it is proposed that the policy will be implemented from January 2023.
