Practice Point

- ✓ Review patients on a regular basis (within 3 months) to ensure compliance with ONS and to monitor progress in treatment goals and dietary intake.
- ✓ Discontinue when treatment goals are met and/or when the patient is established on adequate oral intake from food.

Authorisation of Reimbursement

GPs, dietitians and hospital clinicians can register with PCRS to apply for reimbursement of **ONS on List B**. The registration form is available at www.pcrs.ie:

- For dietitians and hospital clinicians at > **Online Services > Services for Hospitals > Special Drug Request User Registration Form**.
- For GPs in the **GP Application Suite** under **Claiming > Special Drug Request**.
- Email cert.info@hse.ie for more details.
- Online reimbursement approval of **ONS on List B** will be based on clinical information provided to support the application. There is a facility to upload supporting documentation from relevant healthcare professionals.

- Once reimbursement is authorised, **ONS on List B** will be reimbursed for a period of up to six months from the date of approval.
- If **ONS on List B** are required beyond a period of six months, a further online application will be required.
