INTERPRETATION:

In this Agreement, the following expressions shall have the meanings as assigned to them below:

"The Minister" means the Minister for Health and Children.

"The Association" means The Association of Optometrists Ireland.

"The Panel" means the panel(s) of Contracting Opticians maintained by the Health Board for its administrative area or for different parts of its administrative area.

"Eligible person" means a person entitled to ophthalmic services under the Health Act, 1970.

"Authorised Person" means an eligible person having a valid authorisation from the Health Board or being part of an agreed cohort and entitled to the provision of spectacles or contact lenses, being part of the ophthalmic services provided for under the Health Act, 1970.

"The Scale of Fees and Charges" means the schedule of agreed fees and charges for the time being in force.

"The (Dispensing) Services" means the provision of spectacles and contact lenses prescribed under the Community Ophthalmic Services and the Community Optometric Services.

"The Scheme" means the scheme of providing the Services as defined above.

"The C.E.O." means the Chief Executive Officer of the Health Board.

"Designated Officer" means an officer of the Health Board designated by the C.E.O. in accordance with paragraph 16 hereof.

"The Health Board" throughout this Agreement shall be interpreted as meaning the Health Board for the administrative area wherein the Contracting Optician concerned carries on his practice.

The titles "Optometrist" and "Ophthalmic Optician" are synonymous.

"Contracting Optician" shall be as defined in recital d hereof and in addition where a Body Corporate is involved references to Contracting Optician herein shall where the context admits or requires include the Supervising Optician.

"Supervising Optician" means an Optician specified in accordance with paragraph 17 hereof "Health Boards" means all the Health Boards in the State.

The masculine gender herein shall import the feminine.

RECITALS

Whereas

- (a) The Health Boards have obligations to eligible persons under the terms of the Health Act, 1970 as amended.
- (b) The Association is the representative Association of Optometrists in the State.
- (c) The Health Boards are desirous of entering into a National Agreement with the Association to deliver dispensing services for eligible persons within the State.
- (d) It is intended that individual Optometrists and Dispensing Opticians will then make agreements with individual Health Boards to deliver the services to eligible persons in accordance with the terms of this Agreement.
- (e) Model forms of the said separate Agreement between Contracting Opticians and their Health Board is included in the Schedule to this Agreement – the form in Part One thereof to be used where the Contracting Optical practice is owned/operated by an individual and Part Two to be used otherwise where the Contracting Optical practice is owned/operated by a Body Corporate.
 - (f) The objects of this Agreement include the following:
 - (i) To provide the services for eligible person as aforesaid.
 - (ii) To achieve significant benefits to eligible persons in terms of health and social gain.
 - (iii) To facilitate maximising the health and social gain potential of the Scheme.
 - (iv) To eliminate existing waiting lists for the services.
 - (v) To apply the Scheme consistently on a national basis.
- (g) It is hereby agreed between the parties hereto that any changes in the terms of this agreement agreed between the Association of Optometrists Ireland and the Health Services Employers Agency/the Health Boards/General Medical Services (Payments) Board/Department of Health and Children including, without limitation changes to payment arrangements, shall be construed as forming part of the contract upon receipt by the Contracting Opticians of a letter from the Health Services Employers Agency/Health Boards/General Medical Services (Payments) Board/Department of Health and Children, the terms of which have been agreed with the Association of Optometrists Ireland, and the terms of this contract shall be construed accordingly.

NOW IT IS HEREBY WITNESSED THAT the parties hereto have AGREED as follows:

COVENANTS BY PARTICIPATING OPTICIAN

1. The Contracting Optician agrees:

- (i) To provide the services and advice to the best of his knowledge and ability for eligible persons at the listed addresses wherein he practises using suitable instruments and equipment in the appropriate environment.
- (ii) To provide spectacles to an approved standard of frame and lenses together with an acceptable case or as appropriate contact lenses of a type and specification agreed between the Contracting Optician and the authorised person concerned.
- (iii) To take out and maintain professional indemnity insurance in a sum not less than the minimum amount as may be determined by the Health Boards from time to time and which currently stands at £500,000.00.
- (iv) To produce evidence of such professional indemnity insurance to the Health Board when demanded.
- (v) To provide the services in the same manner and under the same conditions as would be provided for private patients.
- (vi) To provide the services personally or by way of substitute who is also a registered Ophthalmic Optician or registered Dispensing Optician and the Contracting Optician undertakes to ensure that such substitute is also covered by equivalent professional indemnity insurance and the Contracting Optician also remains responsible to the Health Board for the services provided to authorised persons.
- (vii) In cases where an authorised person by reason of incapacity is confined to home, nursing home or hospital to provide the services as a domiciliary case provided that additional costs arising from such cases shall be agreed from time to time between the parties hereto and that prior authority for such cases is obtained from the C.E.O. or other designated Officer.
- (viii) To display in the practice premises a notice to be provided by the Health Board that he has entered into an agreement with that Board to provide the services.
- (ix) To abide by the Rules of the Opticians Board which requires that the names and attendance times of those providing dispensing services are displayed for the information of eligible persons.
- (x) Neither directly nor indirectly, either personally or by his servant or agent, to canvass or solicit any qualified person for the purpose of obtaining an authorisation for dispensing services.
- (xi) To notify the C.E.O. of the Health Board of any changes in the information contained in the Optician's proposal forming the basis of the Agreement between him and the Health Board (the said model forms whereof are set out in the Schedule hereto).
- (xii) Save in cases where for reasonable cause (to be submitted to the C.E.O. of the Health Board if requested) the Contracting Optician refuses to accept as a patient any particular authorised person, to accept an authorisation from an eligible person and following upon the provision of dispensing services to record on it (the authorisation) the details of that dispensing service.

- (xiii) To record in addition on the authorisation referred to in the immediately preceding paragraph hereof such other necessary and agreed sections of the authorisation so as to identify any substitute carrying out the dispensing and/or the Contracting Optician.
- (xiv) To keep for a period of at least ten years a record of all authorised persons availing of dispensing services from him under this agreement and such record shall include the name, address, medical card/authorisation number, the dates of any dispensing carried out and any advice therefrom.
- (xv) To make available all of the foregoing records to any Examining Optician appointed under this agreement.
- (xvi) In a case where an eligible person chooses for any reason to attend a different Contracting Optician to one previously attended under the Scheme to make available promptly patient records to the new practitioner.

FURTHER AGREED ASPECTS OF SCHEME

- 2. Eligible persons may choose any participating Contracting Optician from the published panel of the Health Board.
- 3. Where spectacles or contact lenses are lost or damaged, replacements or repairs as appropriate shall be provided. The timeframe within which such replacements or repairs may be provided shall be a matter for agreement between the parties. These aspects of the Scheme would be subject to review from time to time.
- 4. Eligible persons will apply to the Health Board in their area to have their applications under the Scheme authorised. It is intended that such application will be approved or rejected within one month. The Health Boards will enter into reciprocal arrangements in exceptional circumstances. Alterations in eligibility of persons to benefit from the Scheme will not be made without discussion and agreement with the Association.
- 5. The Contracting Optician will be entitled to payment for the services undertaken on foot of this agreement by reference to the agreed scale of fees and charges negotiated between the parties hereto. No charge shall be levied on the patient for such services. It is intended that the said scale of fees and charges shall be that agreed by the Minister for Social, Community and Family Affairs for his Department's Optical Benefit within the Treatment Benefit Scheme.
- 6. The parties hereto and the General Medical Services (Payments) Board shall facilitate the introduction, development and use of appropriate information technology and telematic services for the effective management of the Scheme, including the collection and dissemination of information and the transmission of claims data.
- 7. The Contracting Optician may request identification and evidence of eligibility from any person offering an authorisation for services under the Scheme.

MANAGING AND MONITORING

- 8. The dispensing services will be an integral part of the Health Board's overall annual service plan to be adopted by the Board and submitted to the Minister. The supervision and implementation of the service plan is a function of the Health Board.
- 9. An Optician Advisor who is a registered Optician under the Opticians Act, 1956, shall be appointed by the C.E.O. for agreed periods to give advice to the C.E.O. or a designated officer on all matters with regard to the provision of spectacles or contact lenses for eligible persons by Contracting Opticians subject to the following conditions:
 - (a) A Contracting Optician shall give to the Advisor, all such information and particulars regarding the services under this Scheme as the Advisor may require.
 - (b) The advisor shall bring to the notice of the C.E.O. such developments in clinical practice and other matters which affect the provision of the services under this Agreement and shall advise the C.E.O. as to their significance.

COMPLAINTS

- Complaints of a non-clinical nature from or on behalf of an authorised person will be investigated by an administrative officer of the Health Board with whatever assistance is appropriate from the Optician Advisor.
- 11. Where the C.E.O. of a Health Board receives a complaint that the services provided by a Contracting Optician have been unsatisfactory and continue to be so, the C.E.O. shall appoint an Examining Optician to investigate the matter.

The Examining Optician shall be chosen by the C.E.O. from a panel of registered Opticians which is provided by the Association. In the first place and at agreed intervals, such panels will be formed following consultation with the President of the Association or his nominee and the Optometric Director of the Optometry Course in the Dublin Institute of Technology.

The Examining Optician shall consider all aspect of the dispensing services complained of with the following results:

- (a) He may conclude that the services were satisfactory in all respects.
- (b) He may recommend an alteration or adjustment to the spectacles and no additional charge shall be made for any such alterations of the appliances provided.
- (c) The fees and expenses of the Examining Optician shall be borne by the C.E.O. of the relevant Health Board.

12. In the event that a complaint is of a very serious nature as determined by the C.E.O., (e.g. the allegation of assault, abuse, etc., by the Contracting Optician or other staff employed by the Optician) same will be investigated thoroughly by the relevant Health Board. In such cases, the contract may be suspended pending the conclusion of such investigations.

TERMINATION AND DISPUTES

- 13. The Agreement between a Contracting Optician and the relevant Health Board may be terminated by either party by:
 - (a) Giving not less than three months notice in writing of his/its intention to do so on the other and, immediately after such termination, the C.E.O. of the relevant Health Board will delete the Contracting Optician's name from the published panel.
 - (b) Where the C.E.O. has reason to believe that the Contracting Optician has not complied with the terms of the Agreement or has failed to give adequate dispensing services to authorised persons, he shall notify the Optician by registered post of the reasons for such belief and inform him that he will consider any representations in the matter which may be received from the Optician within twenty-one days of the notification. If, after consideration of any such representations with the Optician Advisor, the C.E.O. is satisfied that the Contracting Optician has not complied with the terms of the agreement and/or has failed to give adequate dispensing services, the C.E.O. shall, as he thinks appropriate:
 - (i) Issue a warning to the Contracting Optician.
 - (ii) Require the Contracting Optician to recoup to the Health Board any overpayments or incorrect payments made to him.
 - (iii) Impose a temporary suspension of the contract.
 - (iv) Terminate the Agreement.

If the Contracting Optician is aggrieved by any action of the C.E.O. as above he may appeal in writing to the C.E.O., within twenty-one days of receipt of the C.E.O.'s decision.

As soon as practicable after receiving notice of the Contracting Optician's appeal, an Opticians Appeals Tribunal shall be convened by the C.E.O., consisting of one person nominated by the Association, one person nominated by the C.E.O. and an independent chairman who is acceptable to the Association and the C.E.O. This Tribunal shall have power only in relation to appeals arising from the decision of the C.E.O. as above.

The Tribunal shall, having considered the submissions made by both parties, issue a report to the C.E.O. which may recommend, varying, endorsing or rescinding the action proposed to be taken.

REVIEW MEETINGS

14. Officers nominated by the Health Boards and/or the Health Service Employers Agency and the Association as the professional body representing Opticians within the State, shall, in order to ensure the effective operation of schemes proposed under this agreement meet from time to time and at least once a year in order to discuss matters of mutual interest in respect of the operation of such schemes, including fees and other charges applicable.

PROCEDURAL MATTERS

- 15. The C.E.O. may assign to another Officer of the Health Board his functions in relation to the entry into and subsequent performance of this Agreement in which event all references to the C.E.O. herein shall be construed as relating to such officer.
- 16. In a case where the Contracting Optician is a Body Corporate, the Managing Director shall submit to the C.E.O. a statement in writing signed by two Directors or by a Director and Secretary of and on behalf of the said Body Corporate specifying the name of the Supervising Optician under whose supervision the optical practice in respect of which the Agreement relates and the services therein are conducted. This statement shall be submitted in the format set out in Part Three of the Schedule hereto and shall also be signed by the Supervising Optician and witnessed. Where the Supervising Optician ceases to act in that capacity, the contract between the Health Board and the said Body Corporate shall terminate one month after the date he has ceased to act unless a new statement as prescribed in this paragraph has been furnished to and accepted by the C.E.O.
