# Assisted Decision-Making (Capacity) Act 2015 – Resources

## **E-learning programmes**

# **Decision Support Service**

The Decision Support Service, a new service established under the 2015 Act, officially launched on Tuesday 26<sup>th</sup> April 2023. Its primary function is to promote awareness and confidence in the new statutory framework, to regulate and supervise the new arrangements and to promote organisational change.

The Decision Support Service published 13 statutory <u>Codes of Practice</u> on the 2015 Act in advance of commencement including codes:

- for <u>Healthcare Professionals</u>,
- on Advance Healthcare Directives for Healthcare Professionals,
- for Supporting Decision-Making and Assessing Capacity.

The Decision Support Service have also developed a number of <u>guidance materials</u>, <u>easy read</u> materials and <u>videos</u> about the Act.
