CALL FOR MENTEES TO BE PART OF THIS NEW EXCITING ASSISTED DECISION-MAKING ACT INITIATIVE

Are you looking for an opportunity to develop your expertise and experience so you can support others during the transition to the Assisted Decision-Making Act 2015?

Then, please apply and join this mentorship program.

What's it all about?

You will be aware of people accessing your services who will wish to utilise different components of the ADM Act to ensure their will and preference is understood, known and included.

Becoming a **Mentee** in this program will be rewarding as you and your colleagues will be focusing on ways to ensure peoples' rights are protected - that everyone is able to participate fully in decisions that affect their lives.

The program assists you to grow and develop your knowledge in a supportive environment and provides the opportunity to transfer this learning to others in your team – all working collaboratively to make a difference.

What is expected:

You will be a staff member with 3 years' experience working in a clinical setting that will bring you and your team into contact with people who will utilise or need to access supports through this new ADM Act.

You will participate in a monthly meeting with 10-12 colleagues for a period of 12 months. The meeting will be facilitated by a trained Mentor that will guide, support and provide advice to your assigned group as you navigate the transition to the Act.

Components of the program:

Share case vignettes, experiences, issues, concerns on the transition/implementation of the Act with others.	Enhance your own understanding of the ADM Act 2015
Problem solve and take learning from the set to your team; to take actions and make necessary changes	Build professional relationships and networks with colleagues for out of session support
Develop skills in communication, listening, open questions, mentoring that are transferable to other settings and leadership roles	Make a positive impact on the lives of others and an opportunity to provide feedback via the mentoring sets that will be utilised at a national level
Access an ADM Mentorship Program workshop -x 1 day f2f in late Sept/early Oct 2023 and Nov 2024	Supported hours to virtually meet with your mentee set each month, including time for pre and post set work
Guidance and tools to develop and enhance your mentoring and reflective practice experience	Attain CPD points
