The Government has confirmed that the Assisted Decision Making (Capacity) Act **2015** will be commenced in early 2022. Work is underway across Departments to establish plans and programmes to enable full commencement of the Act. You can find more information on www.decisionsupportservice.ie. Update on the office

The HSE National Office for Human Rights and Equality Policy (formerly the HSE National ADM and Consent Office) was established to build the capacity and capability of staff to achieve compliance with human rights policy and legislation. The office is responsible for the revision of the HSE National Consent Policy and for the development and delivery of a plan to ensure compliance with the Assisted Decision Making (Capacity) Act 2015. Recent guidance produced during COVID-19 has included <u>Guidance on Advance Care Planning and Do Not Attempt Resuscitation</u> (DNAR) which was developed to support staff to address the added complexity of PPE and CPR, advance care planning and DNAR. The office worked in collaboration with HSE Disabilities Services on a rights based approach to testing for COVID-19 which can be accessed <u>here</u>.

Consent—What the Public Think

In November 2019 we commissioned Red C to conduct a nationally representative survey of 1016 adults over 18 years who had used the health service for themselves, or for their child, in the preceding 3 months.

- This survey showed that while 66% of adults were aware that their consent should be sought for any health or social care intervention, only half reported that this consent was always or frequently sought.
- For consent to be valid the person must be given sufficient information, in a format they can understand. Most people felt they were given enough information (68%), in a way they could understand (75%) and that they could ask a professional questions about their treatment (80%). However, 1 in 5 respondents reported that it can be difficult to understand the information they are given because of medical terminology and jargon.
- The survey identified some areas for improvement. Only 6 in 10 respondents reported they were told what the purpose of the treatment was and what it would involve. Only 3 in 10 said they were told about side effects, benefits, risks and the likelihood of success. A significant percentage of respondents felt they did not receive sufficient information about the cost of their treatment and how this should be paid (30%), alternative treatment options (25%), or that they had been given enough time to make a decision (18%).

Planning Ahead

In June 2020, Safeguarding Ireland published research highlighting that the vast majority of adults had not taken steps to record their future care wishes. The research also demonstrated that almost a quarter of the people surveyed had been prompted to think about doing so because of COVID-19.

The research found that just 4% of adults surveyed had completed an Advance Healthcare Directive and 4% the <u>Think Ahead form</u>. Just 5% of adults had completed either document.
