Update on National Open Disclosure Policy

The open disclosure national policy is currently being revised and updated in line with recent documents (e.g. Interval Cancer Reports and the recommendations for the development of a National Policy Framework) and developments in the national open disclosure programme. Consultation on the draft revised policy document will commence shortly.

National Open Disclosure Policy Framework

The Independent Patient Safety Council, appointed by the Minister for Health, have developed recommendations for the development of a National Policy Framework. These recommendations were accepted by the Minister and the National Policy Framework will now be developed by the National Patient Safety Office in the Department of Health. Current Status on Legislation

The Patient Safety Bill remains a priority for the Minister of Health and is actively progressing. It is anticipated the Bill will go to Committee Stage in the summer session. Part 4 of the CLA Act will be amended to align it with the Patient Safety Bill. 


